# **Macroeconomic policy questions**

## **Report of the Second Committee\***

Rapporteur: Mr. Borg Tsien Tham (Singapore)

1. At its 2nd plenary meeting, on 19 September 2014, the General Assembly, on the recommendation of the General Committee, decided to include in the agenda of its sixty-ninth session the item entitled:

"Macroeconomic policy questions:

- "(a) International trade and development;
- "(b) International financial system and development;
- "(c) External debt sustainability and development"

and to allocate it to the Second Committee.

2. The Second Committee held a substantive debate on the item at its 7th, 16th, 17th and 18th meetings, on 13, 21 and 22 October 2014.
