I. Introduction

1. The Ad Hoc Committee on the Elaboration of a Convention against Transnational Organized Crime was established by the General Assembly in its resolution 53/111 of 9 December 1998.

2. In its resolution 54/126 of 17 December 1999, the General Assembly requested the Ad Hoc Committee to continue its work, in accordance with resolutions 53/111 and 53/114 of 9 December 1998, and to intensify its work in order to complete it in 2000.

II. Organization of the session

A. Opening of the session

3. The Ad Hoc Committee on the Elaboration of a Convention against Transnational Organized Crime held its sixth session in Vienna from 6 to 17 December 1999. The Ad Hoc Committee held 20 meetings.

4. At its fifth session, held in Vienna from 4 to 15 October 1999, the Ad Hoc Committee had decided to consider at its sixth session articles 4 *ter*, 17 *bis* and 20-30 of the revised draft United Nations Convention against Transnational Organized Crime, as well as to continue its first reading of the international legal instruments addressing trafficking in persons, especially women and children, and illegal trafficking in and transporting of migrants, including by sea.

5. After the opening of the sixth session of the Ad Hoc Committee by its Chairman, the Secretary recalled that the Ad Hoc Committee had requested the Secretariat to prepare an analytical study on provisions of national laws relevant to the draft Convention concerning offences

punishable by deprivation of liberty, with an indication of the number of years of imprisonment. He informed the Ad Hoc Committee that the analytical study on serious crime (A/AC.254/22 and Corr.1 and Add.1) had been prepared and would be distributed to all delegations during the sixth session of the Ad Hoc Committee.

B. Attendance

6. The sixth session of the Ad Hoc Committee was attended by representatives of 106 States. Also attending the sixth session were observers for entities maintaining permanent observer missions to the United Nations, organizations of the United Nations system, institutes of the United Nations Crime Prevention and Criminal Justice Programme network, intergovernmental organizations and non-governmental organizations. The list of participants is contained in annex I to the present report.

C. Adoption of the agenda and organization of work

7. At its 77th meeting, on 6 December 1999, the Ad Hoc Committee adopted the following agenda for its sixth session:

1. Opening of the sixth session of the Ad Hoc Committee.
2. Adoption of the agenda and organization of work.
3. Consideration of the additional international legal instruments:
 - (a) Draft instrument against illegal trafficking in and transporting of

- migrants, with particular emphasis on articles 7-19;
- (b) Draft instrument against trafficking in persons, especially women and children, with particular emphasis on articles 8-18.
4. Consideration of the revised draft United Nations Convention against Transnational Organized Crime, with particular emphasis on articles 4 *ter*, 17 *bis* and 20-30.
 5. Adoption of the report of the Ad Hoc Committee on its sixth session.

D. Documentation

8. At its sixth session, the Ad Hoc Committee had before it, in addition to the documents prepared by the Secretariat, documents containing proposals and contributions submitted by the Governments of Argentina, Austria, Cameroon, Canada, China, Colombia, Finland, France, Germany, India (on behalf of the Group of 77), Japan, the Libyan Arab Jamahiriya, Mexico, the Russian Federation, South Africa and the United States of America. A list of documents is contained in annex II to the present report.

III. Discussion on the additional international legal instrument against illegal trafficking in and transporting of migrants, with particular emphasis on articles 7-19

9. At its 77th to 80th meetings, the Ad Hoc Committee discussed the additional legal instrument against illegal trafficking in and transporting of migrants, with particular emphasis on articles 7-19. It based its work on a document containing the revised draft Protocol against the Smuggling of Migrants by Land, Air and Sea, supplementing the United Nations Convention against Transnational Organized Crime (A/AC.254/4/Add.1/Rev.3) and on proposals and contributions submitted by Governments (A/AC.254/5/Add.15, A/AC.254/L.96, A/AC.254/L.97, A/AC.254/L.99, A/AC.254/L.101, A/AC.254/L.102 and A/AC.254/L.104).

10. At its sixth session, the Ad Hoc Committee completed its first reading of the draft Protocol, aware of

the discussion in the informal consultations on the common provisions between the draft Convention and the draft protocols thereto. The new version of those articles of the draft Protocol was included in document A/AC.254/L.128/Add.2. The progress achieved on the draft Protocol by the Ad Hoc Committee at its sixth session will be reflected in a new version of the draft Protocol.¹

IV. Discussion on the additional international legal instrument against trafficking in persons, especially women and children, with particular emphasis on articles 8-18

11. At its 81st to 86th meetings, the Ad Hoc Committee discussed the additional legal instrument against trafficking in persons, especially women and children, with particular emphasis on articles 8-18. The Ad Hoc Committee decided to base its work on the restructured version of the revised draft Protocol to Prevent, Suppress and Punish Trafficking in Persons, Especially Women and Children, supplementing the United Nations Convention against Transnational Organized Crime (A/AC.254/5/Add.13), as had been recommended by the informal consultations held during the fifth session of the Ad Hoc Committee, and on other proposals and contributions submitted by Governments (A/AC.254/5/Add.16, A/AC.254/L.103, A/AC.254/L.105, A/AC.254/L.107 and A/AC.254/L.116). The Ad Hoc Committee also had before it revisions of and amendments to the draft Protocol prepared by informal working groups, either at the request of the Chairman or on the basis of the Chairman's summaries (A/AC.254/L.110, A/AC.254/L.112 and A/AC.254/L.113).

12. At its sixth session, the Ad Hoc Committee completed its first reading of the draft Protocol, aware of the discussion in the informal consultations on the common provisions between the draft Convention and the draft protocols thereto. The progress achieved on the draft Protocol by the Ad Hoc Committee at its sixth session (A/AC.254/L.128/Add.3) will be reflected in a new version of the draft Protocol.²

V. Discussion on the revised draft United Nations Convention against Transnational Organized Crime, with particular emphasis on articles 4 *ter*, 17 *bis* and 20-30

13. At its 87th to 96th meetings, the Ad Hoc Committee discussed articles 4 *ter*, 17 *bis* and 20-30 of the draft Convention. The Ad Hoc Committee based its work on the revised draft United Nations Convention against Transnational Organized Crime (A/AC.254/4/Rev.5) and on proposals and contributions submitted by Governments (A/AC.254/5/Add.14, A/AC.254/L.98, A/AC.254/L.100, A/AC.254/L.108, A/AC.254/L.111, A/AC.254/L.114, A/AC.254/L.115, A/AC.254/L.118, A/AC.254/L.119 and A/AC.254/L.121-125). The Ad Hoc Committee also had before it revisions of and amendments to the draft Convention prepared by informal working groups, either at the request of the Chairman or on the basis of the Chairman's summaries (A/AC.254/L.122). In completing its second reading of the draft Convention and in accordance with the request by the Chairman, the Ad Hoc Committee sought to reach agreement on a single text that would reflect the points of convergence and would form the basis for further drafting. The new version of those articles was included in document A/AC.254/L.128/Add.4. The progress achieved on the draft Convention by the Ad Hoc Committee at its sixth session will be reflected in a new version of the draft Convention.³

14. The representative of Morocco, speaking on behalf of the Group of African States, informed the Ad Hoc Committee of delays experienced by representatives of least developed countries in receiving funds intended to assist them in meeting the local costs of their attendance at the sixth session of the Ad Hoc Committee. The Officer-in-Charge of the Centre for International Crime Prevention of the Office for Drug Control and Crime Prevention explained that administrative difficulties stemming from certain General Assembly decisions currently in force were the root cause of the delays. The Ad Hoc Committee expressed the hope that, in order to alleviate the situation, the Assembly would give favourable consideration to a draft resolution on the subject that would be submitted to it at its fifty-fourth session by Guyana, on behalf of the

Group of 77 and China. In that resolution the Assembly would request the Secretary-General both to continue to use the extrabudgetary resources provided for the purpose of covering the travel expenses of representatives of least developed countries to attend the session of the Ad Hoc Committee and also to provide financial support, as extrabudgetary resources permitted, to cover the local costs of those representatives.

VI. Informal consultations

15. At its fourth session, the Ad Hoc Committee had decided that, in future, informal consultations should be organized in order to facilitate the implementation of its mandate.

16. At its fifth session, the Ad Hoc Committee had decided that the informal consultations at its sixth session would be devoted to an overview of provisions that could be considered common to the draft Convention and the draft protocols thereto, and to consideration of the articles of those draft instruments that would be under discussion at its sixth session. At the sixth session of the Ad Hoc Committee, informal consultations were held from 7 to 10 December 1999 in parallel with the plenary meetings of the Ad Hoc Committee. The documents made available to the Ad Hoc Committee for its informal consultations were A/AC.254/21, A/AC.254/4/Rev.5, A/AC.254/5/Add.14, A/AC.254/L.106 and A/AC.254/L.117.

17. The recommendations of the informal consultations (A/AC.254/L.109 and A/AC.254/L.120) were submitted to the Ad Hoc Committee by the chairmen of the informal consultations.

18. At its 94th meeting, the Ad Hoc Committee approved the recommendations of the informal consultations on the common provisions of the draft Convention and the draft protocols thereto (A/AC.254/L.109). The Ad Hoc Committee carried out its work on articles 4 *ter*, 20, 22 and 22 *bis* on the basis of the recommendations of the informal consultations (A/AC.254/L.120).

VII. Adoption of the report of the Ad Hoc Committee on its sixth session

19. At its 96th meeting, on 17 December 1999, the Ad Hoc Committee adopted the report on its sixth session (A/AC.254/L.128).

20. At the same meeting, the Ad Hoc Committee approved the provisional agenda and proposed organization of work for its seventh session, to be held in Vienna from 17 to 28 January 2000 (A/AC.254/L.128/Add.1).⁴

21. In approving the provisional agenda for its seventh session, the Ad Hoc Committee decided to include an item on the implementation of General Assembly resolution 54/128, entitled "Action against corruption".
