

Open-ended Working Group on Ageing Organizational session

15 February 2011

Report of the Open-ended Working Group on Ageing on its organizational session

A. Opening and duration of the session

- 1. The Open-ended Working Group on Ageing held its organizational session at United Nations Headquarters on 15 February 2011 (1st meeting). The session was opened by the Assistant Secretary-General for Policy Coordination and Inter-Agency Affairs.
- 2. Statements were made by the Assistant Secretary-General and the representative of the Office of the United Nations High Commissioner for Human Rights.

D. Adoption of the agenda and other organizational matters

- 5. At its 1st meeting, on 15 February, the Open-ended Working Group on Ageing adopted the provisional agenda for its organizational session, as contained in document A/AC.278/2011/1. The agenda read as follows:

E. Calendar and programme of work of the working sessions of the Open-ended Working Group on Ageing

6. At its 1st meeting, on 15 February, the Open-ended Working Group adopted the dates for its working sessions as follows:

First working session: 18-21 April 2011 Second working session: 1-5 August 2011

7. At the same meeting, the Working Group approved its proposed organization of work as set out in an informal paper issued in English only.

F. Participation of non-governmental organizations in the work of the Open-ended Working Group on Ageing

8. At its 1st meeting, on 15 February, the Open-ended Working Group adopted a draft decision entitled "Modalities of participation of non-governmental organizations in the work of the Open-ended Working Group on Ageing", which read:

"the Open-ended Working Group on Ageing, recalling that the General Assembly, in its resolution 65/182 of 21 December 2010, invited the contributions of relevant non-governmental organizations to the work of the Working Group, as appropriate, decides:

- (a) To invite relevant intergovernmental organizations and other entities that have observer status with the General Assembly to participate in its work;
- (b) That accreditation of non-governmental organizations to the Openended Working Group on Ageing shall be granted to all relevant non-governmental organizations enjoying consultative status with the Economic and Social Council;

- (c) That other relevant non-governmental organizations, not falling within the above categories, may apply to the Secretariat for such accreditation, and that their applications should contain all the information on the competence of the organization and the relevance of its activities to the work of the Openended Working Group on Ageing, as specified in paragraph 44 of Economic and Social Council resolution 1996/31 of 25 July 1996, and in respect of those applications, also decides that:
 - (i) The Secretariat shall circulate to all States members of the Openended Working Group a list of new applications for accreditation received from non-governmental organizations no less than four weeks prior to each session of the Working Group, on a non-objection basis, except for the first session of the Working Group, when circulation of the list will take place no later than two weeks prior to the session;
 - (ii) The Open-ended Working Group, at the beginning of each of its sessions, shall consider and take decisions on new applications against which a State member of the Working Group has raised an objection;
- (d) To keep in mind the principle of equitable geographical participation of non-governmental organizations in the work of the Openended Working Group on Ageing;
- (e) That the arrangements outlined above shall in no way create a precedent for other open-ended working groups of the General Assembly."

G. Provisional agenda for the working sessions of the Open-ended Working Group on Ageing

- 9. At its 1st meeting, on 15 February, the Open-ended Working Group on Ageing approved the provisional agenda for its working sessions, as contained in document A/AC.278/2011/L.1.
 - 1. Election of the Bureau.
 - 2. Adoption of the agenda and other organizational matters.
 - 3. Participation of non-governmental organizations in the work of the Openended Working Group on Ageing.
 - 4. Existing international framework on the human rights of older persons and identification of existing gaps at the international level.

H. Adoption of the report on the organizational session

10. At its 1st meeting, on 15 February, the Open-ended Working Group on Ageing adopted the draft report on its organizational session, as contained in document A/AC.278/2011/L.2, and entrusted the Chair and the Bureau with its completion in collaboration with the Secretariat.
