Allocation of items to the Second Committee

1. Election of the officers of the Main Committees [item 5].

2. Permanent sovereignty of the Palestinian people in the Occupied Palestinian Territory, including East Jerusalem, and of the Arab population in the occupied Syrian Golan over their natural resources [item 38].
