Revitalization of the work of the General Assembly

**Draft programme of work of the Second Committee for the
sixty-second session of the General Assembly submitted by
the Chairman**

1. Permanent sovereignty of the Palestinian people in the Occupied Palestinian Territory, including East Jerusalem, and of the Arab population in the occupied Syrian Golan over their natural resources.
2. Information and communication technologies for development.
3. Macroeconomic policy questions:
 - (a) International trade and development;
 - (b) International financial system and development;
 - (c) External debt crisis and development.
4. Follow-up to and implementation of the outcome of the International Conference on Financing for Development:
 - (a) Follow-up to and implementation of the outcome of the International Conference on Financing for Development;
 - (b) High-level dialogue for the implementation of the outcome of the International Conference on Financing for Development.
5. Sustainable development:
 - (a) Implementation of Agenda 21, the Programme for the Further Implementation of Agenda 21 and the outcomes of the World Summit on Sustainable Development;
 - (b) Follow-up to and implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States;



- (c) International Strategy for Disaster Reduction;
 - (d) Protection of global climate for present and future generations of mankind;
 - (e) Implementation of the United Nations Convention to Combat Desertification in Those Countries Experiencing Serious Drought and/or Desertification, Particularly in Africa;
 - (f) Convention on Biological Diversity;
 - (g) Report of the Governing Council of the United Nations Environment Programme on its twenty-fourth session;
 - (h) Sustainable mountain development;
 - (i) Promotion of new and renewable sources of energy.
6. Implementation of the outcome of the United Nations Conference on Human Settlements (Habitat II) and strengthening of the United Nations Human Settlements Programme (UN-Habitat).
 7. Globalization and interdependence:
 - (a) Globalization and interdependence;
 - (b) Science and technology for development;
 - (c) Preventing and combating corrupt practices and transfer of assets of illicit origin and returning such assets, in particular to the countries of origin, consistent with the United Nations Convention against Corruption.
 8. Groups of countries in special situations:
 - (a) Third United Nations Conference on the Least Developed Countries;
 - (b) Specific actions related to the particular needs and problems of landlocked developing countries: outcome of the International Ministerial Conference of Landlocked and Transit Developing Countries and Donor Countries and International Financial and Development Institutions on Transit Transport Cooperation.
 9. Eradication of poverty and other development issues:
 - (a) Implementation of the second United Nations Decade for the Eradication of Poverty (2007-2016);
 - (b) Women in development;
 - (c) Human resources development.
 10. Operational activities for development:
 - (a) Operational activities for development of the United Nations system;
 - (b) South-South cooperation for development.
 11. Training and research: United Nations Institute for Training and Research.

12. Strengthening of the coordination of humanitarian and disaster relief assistance of the United Nations, including special economic assistance:*
 - (b) Special economic assistance to individual countries or regions.
 13. Towards global partnerships.

Sub-item (b), entitled “Special economic assistance to individual countries or regions”, has been allocated for annual consideration in the Second Committee, in accordance with para. 4 (e) of the annex to General Assembly resolution 58/316.

Sub-item (c), entitled “Participation of volunteers, ‘White Helmets’, in the activities of the United Nations in the field of humanitarian relief, rehabilitation and technical cooperation for development”, has been allocated for consideration every three years in the Second Committee, in accordance with para. 4 (g) of the annex to Assembly resolution 58/316. Since it was considered at the sixty-first session of the General Assembly, it will be considered next at the sixty-fourth session.
