**Draft resolution submitted by the Rapporteur of the Committee, Mr. Raymond Landveld (Suriname), on the basis of informal consultations on draft resolution A/C.2/66/L.26**

### **Follow-up to and implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States**

*The General Assembly,*

*Reaffirming* the Declaration of Barbados<sup>1</sup> and the Programme of Action for the Sustainable Development of Small Island Developing States,<sup>2</sup> the Mauritius Declaration<sup>3</sup> and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States,<sup>4</sup> and the Plan of Implementation of the World Summit on Sustainable Development (“Johannesburg Plan of Implementation”),<sup>5</sup> including chapter VII on the sustainable development of small island developing States,

*Recalling* the outcome document of the High-level Review Meeting on the Implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States,<sup>6</sup> held on 24 and 25 September 2010, General Assembly resolution 65/156 of 20 December 2010 and all its other previous resolutions on the subject, as well as the report of the Secretary-General on the five-year review of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States,<sup>7</sup>

*Acknowledging* the importance of the upcoming United Nations Conference on Sustainable Development,

1. *Notes* the report of the Secretary-General on concrete recommendations to enhance the implementation of the Barbados Programme of Action for the Sustainable Development of Small Island Developing States and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States,<sup>8</sup> prepared in response to the request contained in the outcome document of the High-level Review Meeting on the Implementation of the Mauritius Strategy;<sup>6</sup>

2. *Also notes* the report of the Secretary-General on the review of United Nations system support to small island developing States;<sup>9</sup>

3. *Notes* the ongoing preparatory process for the United Nations Conference on Sustainable Development to be held in Rio de Janeiro, Brazil, from 20 to 22 June 2012;

4. *Stresses* the importance of the continued substantive consideration of the follow-up to and implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States;<sup>4</sup>

5. *Decides* to include in the provisional agenda of its sixty-seventh session, under the item entitled “Sustainable development”, the sub-item entitled “Follow-up to and implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States”;

6. *Also decides* to consider, at its sixty-seventh session, the reports of the Secretary-General on concrete recommendations to enhance the implementation of the Barbados Programme of Action for the Sustainable Development of Small Island Developing States and the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States<sup>8</sup> and on the review of United Nations system support to small island developing States,<sup>9</sup> issued for the sixty-sixth session.
