

Appointments to fill vacancies in subsidiary organs and other appointments

Appointment of members of the International Civil Service Commission

Note by the Secretary-General

- 1. As indicated in document A/59/106 of 6 July 2004, the General Assembly at its current session will be required to appoint five persons to fill the vacancies that will occur in the membership of the International Civil Service Commission, beginning on 1 January 2005.
- 2. The members of the Commission whose terms of office expire on 31 December 2004 are:

Asda Jayanama (Thailand);

Ernest Rusita (Uganda);

C. M. Shafi Sami (Bangladesh);

El Hassane Zahid (Morocco).

Thus, the members to be appointed should come from the following regions:

One member from the Eastern European States.

- 4. The appointment of the members of the Commission is governed by the provisions of articles 3, 4 and 5 of its statute. Pursuant to those provisions, and in accordance with paragraphs 3 and 4 of section II of General Assembly resolution 43/226 of 21 December 1988, the Secretary-General has undertaken consultations with Member States, through the chairmen of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants' Associations and the Coordinating Committee for International Staff Unions and Associations of the United Nations System and with the Advisory Committee on Administrative and Budgetary Questions.
- 5. Regarding consultations with Member States, Mr. Vladimir Titov has been endorsed by the Group of Eastern European States and Mr. Shamsher M. Chowdhury and Mr. Xiaochu Wang have been endorsed by the Group of Asian States.

El Hassane Zahid (Morocco)

Mr. El Hassane Zahid, Minister Plenipotentiary and currently Ambassador of the Kingdom of Morocco to Thailand, is a member of the International Civil Service Commission and was Deputy Permanent Representative of Morocco to the United Nations in New York from 1995 to 2001.

During his time at the Permanent Mission of Morocco in New York, he represented Morocco on a number of United Nations committees, in some cases holding the office of chairman, vice-chairman or rapporteur: he was Chairman of the Committee on Information in 1999 and 2000, Chairman of the Committee on Conferences from January to December 1996, Vice-Chairman of the Committee on Conferences in 1993 and 1995, Vice-Chairman of the Fifth Committee (administrative and budgetary questions) during the forty-seventh session of the General Assembly, Vice-Chairman of the Committee for Programme and Coordination in 1992 and Rapporteur of the Committee on Conferences in 1994.

From 1983 to 2001, Mr. Zahid also participated as a member of the Moroccan delegation or as the representative of Morocco in the work of the following United Nations bodies:

Security Council in 1992 and 1993;

First Committee (disarmament and international security questions) from 1986 to 1988;

Shamsher M. Chowdhury (Bangladesh)

Mr. Shamsher M. Chowdhury, BB, graduated with Bachelor of Arts degree from the Pakistan Military Academy and was commissioned in the erstwhile Pakistan Army in 1969. Mr. Chowdhury actively participated in the War of Liberation of Bangladesh in 1971 and, for his valour, was decorated with the gallantry award "Bir Bikram" (BB). He was promoted to the rank of Major in September 1973.

Mr. Chowdhury's services were placed under the Ministry of Foreign Affairs in January 1975. After serving as Deputy Chief of Protocol and Director (West Europe) in the Foreign Ministry from 1975 to 1977 he was posted to Bangladesh Embassy in Rome from 1977 to 1981. He served as Counsellor in Bangladesh Embassy in Washington from 1981 to 1983 and as Counsellor and Minister in Bangladesh High Commission in Ottawa from 1983 to 1986. He served as Deputy Chief of Mission/Minister in Bangladesh Embassy in Beijing from 1986 to 1988.

Mr. Chowdhury was Director General, SAARC Division in the Ministry of Foreign Affairs from November 1988 to September 1991. During this period he also attended the Senior Staff Course in the Public Administrative Training Centre in Savar and passed with distinction.

Mr. Chowdhury served as the High Commissioner of Bangladesh of Sri Lanka from 1991 to 1995; as Ambassador of Bangladesh to the Federal Republic of Germany from 1995 to 1998; and as Ambassador to the Socialist Republic of Viet Nam from 1998 to 2001.

Mr. Shamsher M. Chowdhury, BB, represented Bangladesh in international conferences in the FAO, WFP and Non-Aligned Movement meetings. He was also member of the Bangladesh Delegation to several Commonwealth and SAARC Summits. He also represented Bangladesh in ICPE Assembly meetings in Slovenia.
