**Appointments to fill vacancies in subsidiary organs and
other appointments: confirmation of the appointment of
members of the Investments Committee**

Confirmation of the appointment of members of the Investments Committee

Note by the Secretary-General

1. As indicated in document A/59/103, it will be necessary for the General Assembly, during its current session, to confirm the appointment by the Secretary-General of three persons to fill vacancies in the Investments Committee resulting from the expiration, on 31 December 2004, of the terms of office of Emmanuel N. Omaboe (Ghana), Yves Oltramare (Switzerland) and Jürgen Reimnitz (Germany).

2. In accordance with the provisions of article 20 of the Regulations of the United Nations Joint Staff Pension Fund, the Secretary-General, after consultation with the United Nations Joint Staff Pension Board and the Advisory Committee on Administrative and Budgetary Questions, submits for confirmation by the General Assembly the reappointment of Jürgen Reimnitz (Germany) as a member of the Investments Committee for a three-year term of office beginning on 1 January 2005. Mr. Reimnitz has served on the Committee since 1975. The Secretary-General greatly appreciates his willingness to carry on this important international public service.

3. Mr. Omaboe, who has served the Investments Committee since 1980 and as Chairman since 1997, and Mr. Oltramare, who has served the Committee since 1975, have both indicated, unfortunately, that they are not available to serve another term. The Secretary-General, after consultation with the Pension Board and the Advisory Committee, further submits for confirmation by the General Assembly the appointment of Hélène Ploix (France), who has served as an ad hoc member of the Committee since 1997, and William J. McDonough (United States of America), as members of the Investments Committee for a three-year term of office beginning on 1 January 2005.

4. In July, Ahmed Abdullatif (Saudi Arabia) submitted his resignation, effective December 2004. Subsequent to the Pension Board meeting, the Secretary-General transformed the appointment of Khaya Ngqula (South Africa) from that of an ad hoc member to that of a regular member in order to fill the remainder of Mr. Abdullatif's term, which is due to expire 31 December 2006.
5. In accordance with past practice, the Secretary-General proposes to appoint Emilio J. Cárdenas (Argentina) and Ivan Pictet (Switzerland) as ad hoc members for one year, beginning 1 January 2005.
