1. In which areas is implementation of the Agreement and the recommendations adopted at the Review Conference in 2006 and 2010 proceeding generally well, and in which areas could such implementation be strengthened?
2. What means could be proposed to further strengthen the substance and methods of implementation of the Agreement?
