
## State of preparation of documentation for the fifty-seventh session of the General Assembly\*

## Note by the Secretary-General

1. In paragraph 3 of its resolution 39/68 D of 13 December 1984, the General Assembly requested the Secretary-General to circulate eight weeks before the opening of the session of each United Nations organ a report on the state of preparation at that time of documents required for the session and to identify the Secretariat unit responsible for any delay.

2. The present report gives the state of preparations at 31 July 2002 of all documents required for the session. The agenda items are those of the provisional agenda (A/57/150). The dates for submission of reports to be considered by the plenary of the General Assembly have been set by the Department of General Assembly Affairs and Conference Services. The submission dates of reports required for the Main Committees of the Assembly have been provided to the Division of General Assembly and Economic and Social Council Affairs by the department or office responsible for preparation of the documents. Explanations for any delay in submissions will be provided by the responsible offices.
