

State of preparation of documentation for the fifty-eighth session of the General Assembly

Note by the Secretary-General

- 1. In paragraph 3 of its resolution 39/68 D of 13 December 1984, the General Assembly requested the Secretary-General to circulate eight weeks before the opening of the session of each United Nations organ a report on the state of preparation at that time of documents required for the session and to identify the Secretariat unit responsible for any delay.
