## Twenty-second special session

### Credentials of representatives to the twenty-second special session of the General Assembly

#### Report of the Credentials Committee

*Chairman:* Mr. Felipe H. Mabilangan (Philippines)

1. At its 1st plenary meeting, on 27 September 1999, the General Assembly, in accordance with rule 28 of its rules of procedure, appointed a Credentials Committee for its twenty-second special session consisting of the following Member States: Austria, Bolivia, China, Philippines, Russian Federation, South Africa, Togo, Trinidad and Tobago, and United States of America.

2. The Credentials Committee held its meeting on 27 September 1999.

3. Mr. Felipe H. Mabilangan (Philippines) was unanimously elected Chairman.

4. The Committee had before it a memorandum by the Secretary-General, dated 24 September 1999, concerning the credentials of representatives of Member States to the twenty-second special session of the General Assembly. The Legal Counsel made a statement relating to the memorandum by the Secretary-General, in which, *inter alia*, he updated the memorandum by the Secretary-General, indicating those credentials and communications received subsequent to the preparation of the memorandum.

5. As noted in paragraph 1 of the memorandum and the statement relating thereto, formal credentials of representatives to the twenty-second special session, in the form required by rule 27 of the rules of procedure of the General Assembly, had been received as of the time of the

meeting of the Credentials Committee from the following 36 Member States: Australia, Bahamas, Belarus, Bhutan, China, Costa Rica, Cyprus, Czech Republic, Eritrea, Georgia, Greece, Guatemala, Jamaica, Japan, Jordan, Kazakhstan, Liechtenstein, Luxembourg, Mexico, Monaco, Myanmar, Oman, Pakistan, Philippines, Republic of Korea, Senegal, Singapore, Slovakia, Slovenia, Suriname, Sweden, Syrian Arab Republic, Thailand, Tonga, Trinidad and Tobago, and Ukraine.

6. As noted in paragraph 2 of the memorandum and the statement relating thereto, information concerning the appointment of the representatives of Member States to the session had been communicated to the Secretary-General, as of the time of the meeting of the Credentials Committee, by means of a cable or a telefax from the Head of State or Government or the Minister for Foreign Affairs, or by means of a letter or note verbale from the Permanent Mission concerned, by the following 37 Member States: Antigua and Barbuda, Bahrain, Bolivia, Brazil, Bulgaria, Cambodia, Central African Republic, Chile, Democratic People's Republic of Korea, Djibouti, Estonia, Ethiopia, Haiti, Hungary, Iran (Islamic Republic of), Italy, Kyrgyzstan, Lithuania, Marshall Islands, Micronesia (Federated States of), Nepal, Norway, Papua New Guinea, Peru, Republic of Moldova, Russian Federation, Saint Kitts and Nevis, Saint Lucia, Samoa, Seychelles, South Africa, Spain, the former

Yugoslav Republic of Macedonia, United States of America, Venezuela, Yemen and Zambia.

7. As noted in paragraph 3 of the memorandum and the statement relating thereto, the following 100 Member States participating in the twenty-second special session had not, as of the time of the meeting of the Credentials Committee, communicated to the Secretary-General information regarding their representatives to the session, but had previously empowered their permanent representatives to represent their respective States in all organs of the United Nations without limitation as to session: Afghanistan, Albania, Algeria, Andorra, Angola, Argentina, Armenia, Austria, Azerbaijan, Bangladesh, Barbados, Belgium, Belize, Bosnia and Herzegovina, Botswana, Brunei Darussalam, Burkina Faso, Burundi, Canada, Cape Verde, Chad, Colombia, Congo, Croatia, Cuba, Democratic Republic of the Congo, Denmark, Dominica, Ecuador, Egypt, Fiji, Finland, France, Gabon, Gambia, Germany, Ghana, Grenada, Guinea, Guinea-Bissau, Guyana, Honduras, Iceland, India, Indonesia, Iraq, Ireland, Israel, Kenya, Kuwait, Lao People's Democratic Republic, Latvia, Lebanon, Lesotho, Liberia, Madagascar, Malawi, Malaysia, Maldives, Malta, Mauritius, Mongolia, Morocco, Mozambique, Namibia, Netherlands, New Zealand, Nicaragua, Niger, Nigeria, Panama, Paraguay, Poland, Portugal, Qatar, Romania, Rwanda, Saint Vincent and the Grenadines, San Marino, Sao Tome and Principe, Saudi Arabia, Sierra Leone, Solomon Islands, Sri Lanka, Sudan, Swaziland, Tajikistan, Togo, Tunisia, Turkey, Turkmenistan, Uganda, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, United Republic of Tanzania, Uruguay, Uzbekistan, Vanuatu, Viet Nam and Zimbabwe.

8. Thirteen Member States had not yet communicated to the Secretary-General any information regarding their representatives to the twenty-second special session: Benin, Cameroon, Comoros, Côte d'Ivoire, Dominican Republic, El Salvador, Equatorial Guinea, Kiribati, Libyan Arab Jamahiriya, Mali, Mauritania, Nauru and Palau.

9. The Chairman recommended that the Committee accept the credentials of the representatives of all Member States mentioned in the Secretary-General's memorandum, on the understanding that formal credentials for representatives of the Member States referred to in paragraphs 6, 7 and 8 of the present report would be communicated to the Secretary-General as soon as possible.

10. Having considered the question of the credentials of Afghanistan, the Committee decided to take the same position as was taken at the fifty-third regular session of the General Assembly.

11. On the proposal of the Chairman, the Committee adopted the following draft resolution:

*"The Credentials Committee,*

*"Having examined the credentials of the representatives to the twenty-second special session of the General Assembly of the Member States referred to in the memorandum of the Secretary-General dated 24 September 1999,*

*"Accepts, subject to the decision contained in paragraph 10 of the present report, the credentials of the representatives of the Member States concerned."*

12. The draft resolution proposed by the Chairman was adopted without a vote.

13. The Chairman then proposed that the Committee recommend to the General Assembly the adoption of a draft resolution (see para. 15). The proposal was adopted without a vote.

14. In the light of the foregoing, the present report is submitted to the General Assembly.

### **Recommendation of the Credentials Committee**

15. The Credentials Committee recommends to the General Assembly the adoption of the following draft resolution:

#### **Credentials of representatives to the twenty-second special session of the General Assembly**

*The General Assembly,*

*Having considered the report of the Credentials Committee and the recommendation contained therein,*

*Approves the report of the Credentials Committee.*
