# Pakistan's Position on Draft Decision on the Implementation of Programme of Work (CD/1864) for the 2009 session of the Conference on Disarmament

The Conference on Disarmament,

Recalling the adoption, on 29 May 2009, of the draft decision for the establishment of a Programme of Work for the 2009 session<sup>1</sup>;

Without prejudice to the Conference's decisions on programmes of work to be adopted annually in accordance with the Rules of Procedure (Article VIII);

Agrees on the following as regards the implementation of the 2009 Programme of Work:

- a. the conduct of work and decision-making, including on adoption of reports, under the Conference Working Groups and Special Coordinators for the 2009 session will comply with the Rules of Procedure of the Conference, particularly paragraph 18 thereof;
- b. principle of rotation and equitable geographic representation will apply to officer bearers under (a) above;
- c. principle of equal and balanced allocation of time for four core issues; and
- d. the Conference will ensure, without any discrimination, equal treatment and priority to all agenda items of the Conference, particularly the four core issues to achieve balanced progress in terms of substantive outcomes consistent with the principle of equal and undiminished security for all states; and

Decides the following:

- 1. Ambassador Dian Triansyah Djani of Indonesia is appointed as Chairman of the Working Group under agenda item 1 entitled "Cessation of the nuclear arms race and nuclear disarmament", according to paragraph 1 of decision CD/1864;
- 2. Ambassador Jürg Streuli of Switzerland is appointed as Chairman of the Working Group under agenda item 1 entitled "Cessation of the nuclear arms race and nuclear disarmament", according to paragraph 2 of decision CD/1864;

# Complementary Presidential Statement Reflecting an Understanding of the Conference on Disarmament on the Implementation of Programme of Work (CD/1864) for the 2009 session of the Conference

I have pleasure in submitting document CD/18XX, a draft decision on the implementation of CD/1864 for the remaining part of 2009 session of the Conference on Disarmament.

The appointment of the Working Group Chairs and Special Coordinators and the draft schedule of meetings are for the 2009 Conference session. The schedule of activities reflects the importance attached by Conference members to agenda items of the Conference, particularly the four core issues. Consultations with a wide range of delegations have shown strong support for commencement of substantive work.

The Conference recognises the principle of equal and undiminished security for all states and the overriding importance of national security interests and security compulsions of all Member States. The Member States will take part in the Conference's work in conditions of full equality as independent States in accordance with the principle of sovereign equality enshrined in the Charter of the United Nations and the Rules of Procedure. Their interests will be protected *inter alia* by ensuring *that* the conduct of work and decision-making, including on adoption of reports, under the CD's Working Groups and Special Coordinators for the 2009 session will comply with the CD Rules of Procedure, particularly paragraph 18, which provides that the Conference shall conduct its work and adopt its decisions by consensus.
