Professor of Economics, University of Budapest; Senior Research Adviser to the Institute of Economics of the Academy of Sciences, Hungary; Vice-Chairman of the Committee of Operations Research, Academy of Sciences, Hungary; in 1992 elected by the Parliament of Hungary as member of the Supervisory Board of Social Security Pension Fund. Previous positions include the following: Head, Department of Mathematical Modelling in the National Planning Bureau; visiting professor at various universities in the United States of America, India and Bangladesh; Research Fellow at the International Institute of Applied Systems Analysis in Laxemburg, Austria. Received professional education in Hungary. Research interests include macroeconomic theory, quantitative models for economic decision-making, household life-cycle behaviour and macroeconomic theory. Editor of numerous journals and author of books and studies.

CARNEIRO-NETTO, Dionisio Dias. Professor of Economics, University of Rio de Janeiro. Previous positions include Vice-President/Senior Researcher, Ministry of Planning. Received professional education in Brazil and the United States. Research interests include structural adjustment, macroeconomic policies, external debt, inflation and stabilization policies. Author of several books and articles.
