> SOCIAL, HUMANITARIAN AND HUMAN RIGHTS QUESTIONS: REPORTS OF SUBSIDIARY BODIES, CONFERENCES AND RELATED QUESTIONS

Report of the Committee on Non-Governmental Organizations

1. At its substantive session of 1995, the Economic and Social Council, in resolution 1995/32, <u>inter alia</u>:

(a) Authorized the establishment of an open-ended inter-sessional working group of the Commission on Human Rights with the sole purpose of elaborating a draft declaration on the rights of indigenous peoples, and authorized the Working Group to meet for 10 working days at the earliest possible date in 1995;

(b) Invited applications from organizations of indigenous people not in consultative status with the Economic and Social Council that would be interested in participating in the Working Group;

(c) Requested the Coordinator of the International Decade of the World's Indigenous People to forward all applications and information received to the Committee on Non-Governmental Organizations;

(d) Requested the Committee on Non-Governmental Organizations to meet as necessary to examine the applications and to recommend to the Economic and Social Council those organizations of indigenous people that should be authorized to participate in the Working Group, including at its first session in 1995.

2. At its 580th meeting, on 18 October 1995, the Committee considered a number of applications from organizations of indigenous people that were interested in participating in the Working Group.

3. Statements were made by the representatives of the Russian Federation, Ireland, Greece, the United Kingdom of Great Britain and Northern Ireland, the Sudan, Chile, Indonesia, China, India and the United States of America.

4. Statements were also made by the observers for Canada, Australia, New Zealand and Peru.

5. At the same meeting, the Committee decided to recommend that the Economic and Social Council authorize 46 organizations of indigenous people not in consultative status with the Council to participate in the Working Group.

MATTERS CALLING FOR ACTION BY THE ECONOMIC AND SOCIAL COUNCIL

6. The Committee on Non-Governmental Organizations recommends to the Economic and Social Council the adoption of the following draft decision:

## DRAFT DECISION

## Applications for participation in the open-ended inter-sessional Working Group of the Commission on Human Rights to elaborate a draft declaration on the rights of indigenous peoples from organizations of indigenous people not in consultative status with the Economic and Social Council

The Economic and Social Council decides to approve the participation of the following organizations of indigenous people not in consultative status with the Council in the open-ended inter-sessional Working Group whose establishment was authorized by the Council in resolution 1995/32:
