1. Election of officers

In accordance with rule 80 of the rules of procedure of the Economic and Social Council, the Committee will elect its officers.

2. Adoption of the agenda and other organizational matters

The provisional agenda and documentation for the present session of the Committee were approved by the Economic and Social Council in its decision 1993/331.

3. Applications for consultative status and requests for reclassification received from non-governmental organizations

The Committee will consider applications for consultative status and requests for reclassification by non-governmental organizations and act thereon. The Committee will also consider applications that were deferred by the Committee at its 1993 session.

4. Review of quadrennial reports submitted by non-governmental organizations in consultative status with the Economic and Social Council, categories I and II

In accordance with arrangements approved by the Council for consultation with non-governmental organizations (resolution 1296 (XLIV), para. 40 (b)), such organizations are required to submit, every fourth year, a report on their activities as regards the support they have given to the work of the United Nations. The Committee, at its regular session in 1981, decided that such reports should be limited to two pages. After examination of those reports, the Committee may recommend to the Council any reclassification in the status of the organizations concerned that it deems appropriate.

#### 5. Review of future activities

Annual informal consultations between the Committee on Non-Governmental Organizations and non-governmental organizations in consultative status with the Economic and Social Council. In the light of the Council's ongoing review of arrangements for consultations with non-governmental organizations, as well as for practical reasons, no informal consultations were held in 1993 and 1994.

Review of arrangements for consultations with non-governmental organizations. The Economic and Social Council, in its resolution 1993/80 of 30 July 1993, decided to establish an open-ended working group and requested it to undertake a review of the arrangements for consultations with non-governmental organizations, with a view to updating, if necessary, Council resolution 1296 (XLIV), as well as introducing coherence in the rules governing the participation of non-governmental organizations in international conferences convened by the United Nations.

In its resolution 1994/28 of 26 July 1994, the Council requested the Working Group to submit the report on its second session to the Council at its substantive session of 1995, and invited the Committee on Non-Governmental Organizations at its regular session in 1995 to transmit its comments on that report to the Council at that session.

The Committee on Non-Governmental Organizations will have before it the report of the Working Group on its second session.
