The Committee will consider the application from the International Energy Foundation, which was deferred by the Committee at its 1995 session, and the application from the International Committee of Peace and Human Rights, which was referred back to the Committee by the Council in 1995.

The Committee will consider and take action on new applications for consultative status submitted by non-governmental organizations.
