Nomination of members of the Board of Trustees of the United Nations Interregional Crime and Justice Research Institute

Note by Secretary-General

1. The attention of the Commission on Crime Prevention and Criminal Justice is drawn to a matter concerning the composition of the Board of Trustees of the United Nations Interregional Crime and Justice Research Institute requiring action on the part of the Commission and the Economic and Social Council.

2. The term of Elizabeth Verville (United States of America) expires on 6 December 2009.

3. Ann-Marie Begler (Sweden) has resigned from her membership on the Board of Trustees as of 12 January 2009, since she has changed the field of her activities and that new field does not comply with the mandate of the Institute.

4. Michèle Ramis-Plum (France) has been appointed as the Ambassador of France to Guatemala, and her new duties do not allow her to continue to fulfil the duties of member of the Board of Trustees. Ms. Ramis-Plum has therefore resigned from her duties as Board member as of 15 December 2008.

5. According to article IV of the statute of the United Nations Interregional Crime and Justice Research Institute, annexed to Economic and Social Council resolution 1989/56:

"2. The Board shall be composed of the following:

"(a) Seven members selected by the Committee on Crime Prevention and Control upon nomination by the Secretary-General and endorsed by the Economic and Social Council, with due regard to the fact that the Institute and its work are funded from voluntary contributions and to the principle of equitable geographic distribution. The members shall be chosen from among eminent persons who possess the necessary qualifications and expertise. They shall serve in their individual capacity for a term of five years from the date of the first Board meeting in which they are invited to participate. They shall be eligible for reappointment by the Committee on Crime Prevention and Control with the endorsement of the Economic and Social Council for not more than one additional term."

6. According to the Office of Legal Affairs of the Secretariat, the Commission has succeeded to the functions and powers of the former Committee on Crime Prevention and Control in this and in other matters.

7. The following candidate is proposed for reappointment: Elizabeth Verville (United States).

8. The following new candidates are proposed for appointment: Stuart Page (Australia) and Alexander Vladimirovich Zmeyevskiy (Russian Federation).

9. The principle of equitable geographical distribution is taken into account in the composition of the Board. The current Board of Trustees of the United Nations Interregional Crime and Justice Research Institute is composed of:
