#### Annotations

##### Item 1. Election of officers

1. Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council (E/5975/Rev.1) provides that, at the commencement of the first meeting of a regular session, the Commission shall elect, from among the representatives of its members, a Chairman and such other officers as may be required. At the first to fourth sessions, the Commission elected, in addition to a Chairman, four Vice-Chairmen, one of whom served also as Rapporteur.
2. The membership of the Commission in 1997 is given in annex II below.

Item 2. Adoption of the agenda and other organizational matters

3. Rule 7 of the rules of procedure provides that the Commission shall, at the beginning of each session, after the election of its officers, adopt the agenda for that session on the basis of the provisional agenda.

4. In decision 1996/231, the Economic and Social Council took note of the report of the Commission on Sustainable Development on its fourth session and endorsed the provisional agenda for the fifth session of the Commission.

Item 3. Report of the Ad Hoc Intergovernmental Panel on Forests

5. At its third session, the Commission decided to establish an open-ended Ad Hoc Intergovernmental Panel on Forests, composed of representatives of Governments, to pursue consensus and formulation of coordinated proposals for action on the management, conservation and sustainable development of forests, particularly by Governments, assessing action already undertaken to combat deforestation and forest degradation and promoting management, conservation and sustainable development of all types of forests, including environmental and socio-economic impacts. The Panel held its first (organizational) session from 11 to 15 September 1995, its second session from 11 to 22 March 1996, its third session from 9 to 20 September 1996 and its fourth session from 11 to 21 February 1997. The Panel's final report will be before the Commission at its present session.

Item 4. Preparations for the special session of the General Assembly for the purpose of an overall review and appraisal of the implementation of Agenda 21

6. In resolution 51/181, the General Assembly, recalling its resolution 47/190, in which it decided to convene, not later than 1997, a special session for the purpose of an overall review and appraisal of the implementation of Agenda 21, and reaffirming its resolution 50/113 as the agreed basis that determines the modalities for the preparations for the special session, including the relevant role of the Commission on Sustainable Development as the functional commission of the Economic and Social Council mandated to follow up the United Nations Conference on Environment and Development, as well as the role of other relevant organizations and bodies of the United Nations system, decided to convene the special session envisaged in its resolution 47/190 for a duration of one week, from 23 to 27 June 1997, at the highest political level of participation.

7. The Assembly also decided that the Commission on Sustainable Development would devote its fifth session, to be held from 7 to 25 April 1997 as a negotiating meeting, to final preparations for the special session for the overall review and appraisal of the implementation of Agenda 21.
