#### Annotations

##### 1. Election of officers

Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council provides that, at the commencement of the first meeting of a regular session, the Commission shall elect, from among the representatives of its members, a Chairman and such other officers as may be required. At its first to fifth sessions, the Commission elected, in addition to a Chairman, four Vice-Chairmen, one of whom served also as Rapporteur.

In resolution 1997/63, the Council decided on the following future arrangements for the election of the Bureau of the Commission in order to implement the provisions of paragraph 136 of the Programme for the Further Implementation of Agenda 21:

“(a) The Commission, immediately following the closure of a regular session, will hold the first meeting of its subsequent regular session for the sole purpose of electing the new chairman and other members of the bureau in accordance with rule 15 of the rules of procedure of the functional commissions of the Council;

“ ...

“(c) The terms of office of the members of the Commission will begin immediately after the conclusion of work of the Commission’s regular session held after 1 January, following their election by the Council (at its resumed organizational session of the previous year) and will end at the conclusion of the regular session held after 1 January following the election of the States that are to succeed them as members of the Commission, unless they are re-elected.”

In decision 1997/316, the Council authorized the Commission to convene an organizational meeting in 1997 for the sole purpose of electing the new Chairman and other members of the Bureau in accordance with rule 15 of the rules of procedure of the functional commissions of the Council; decided that the terms of office of the new Bureau would begin immediately upon election and end at the conclusion of the sixth session of the Commission in 1998; and decided to extend the terms of office of those members of the Commission whose terms were to expire on 31 December 1997 until the conclusion of the sixth session of the Commission.

On 22 December 1997, the Commission elected, by acclamation, Mr. Cielito Habito (Philippines) Chairman, and Mr. Michael Odevall (Sweden), Mr. Rogatien Biaou (Benin) and Ms. Marta Inés Galindo (Colombia) Vice-Chairmen. It postponed the election of one Vice-Chairman.

The membership of the Commission is given in annex II below.

## **2. Adoption of the agenda and other organizational matters**

Rule 7 of the rules of procedure provides that the Commission shall, at the beginning of each session, adopt the agenda for that session on the basis of the provisional agenda.

In decision 1997/308, the Council took note of the report of the Commission on Sustainable Development on its fifth session and in resolution 1997/63 approved the provisional agenda for the sixth session.

## **3. Sectoral theme: strategic approaches to freshwater management**

In the Programme for the Further Implementation of Agenda 21, adopted by the General Assembly at its nineteenth special session, the Assembly called for a dialogue under the aegis of the Commission, beginning at its sixth session, aimed at building a consensus of the necessary actions and, in particular, on the means of implementation and on tangible results, in order to consider initiating a strategic approach for the implementation of all aspects of the sustainable use of freshwater for social and economic purposes, including safe drinking water and sanitation, water for irrigation, recycling and waste-water management, and the important role freshwater plays in natural ecosystems (resolution S-19/2, annex, para. 35).

In resolution 1997/63, the Council approved the multi-year programme of work for the Commission, recommended by the General Assembly at its nineteenth special session.

Also in the Programme for the Further Implementation of Agenda 21, the Assembly decided that the Commission, under the guidance of the Council, should continue to provide a forum for the exchange of national experience and best practices in the area of sustainable development, including through voluntary national communications or reports (resolution S-19/2, annex, para. 133 (b)).

Accordingly, on 21 January 1998, the Bureau of the sixth session of the Commission, bearing in mind the working methods of the Commission, decided that five countries, one from each regional group, would make presentations, as follows: two to the Inter-sessional Ad Hoc Working Group on Strategic Approaches to Freshwater Management (Wednesday, 25 February) and three during the first day of the sixth session of the Commission (Monday, 20 April).

#### **4. Cross-sectoral theme: transfer of technology, capacity-building, education, science and awareness-raising**

In resolution 1997/63, the Council approved the multi-year programme of work of the Commission for the period 1998-2002, including the cross-sectoral theme for the sixth session. Accordingly, the main issues for an integrated discussion by the Commission under this item are transfer of technology, capacity-building, education, science and awareness-raising.

#### **5. Economic sector/major group: industry**

In accordance with the Programme for the Further Implementation of Agenda 21 and Council resolution 1997/63, the Commission should strengthen its interaction with representatives

of major groups, including through greater and better use of focused dialogue sessions and round tables; the major groups are encouraged to adopt arrangements for coordination and interaction in providing inputs to the Commission; this could include inputs from business and industry groups on the elaboration, promotion and sharing of sustainable development practices and the promotion of corporate responsibility and accountability (Assembly resolution S-19/2, annex, para. 133 (e)).

In the light of the above, the Bureau of the fifth session of the Commission, which met on 2 and 3 October 1997, suggested that a separate segment of the sixth session be devoted to industry. This segment would provide for an interactive dialogue between the representatives of industry (both the business community and trade unions), non-governmental organizations, Governments and international organizations. Based on previous experience, the Bureau was of the view that, to ensure a participatory and interactive dialogue between the representatives of Governments and other participants, no other meetings should be held in parallel.

The Bureau of the sixth session, at its meeting on 21 January 1998, continued its consideration of the arrangements for the segment on industry. It recommended that the segment be held for a two-day period, 20 and 21 April 1998; expressed the hope that both Governments and major groups would be represented at a high level; and stressed the need for balanced representation of the corporate sector, trade unions and non-governmental organizations from both developed and developing countries.

### **6. Progress in the implementation of the Programme of Action for the Sustainable Development of Small Island Developing States**

At its fourth session, in 1996, the Commission carried out a mid-term review of selected programme areas of the Programme of Action for the Sustainable Development of Small Island Developing States. In resolution 1997/63, the Economic and Social Council approved the recommendation of the General Assembly that the Commission undertake at its sixth session, in 1998, a review of all the outstanding chapters and issues of the Programme of Action.

### **7. High-level meeting**

In resolution 47/191, the General Assembly recommended that the Commission adopt at its first session a multi-year thematic programme of work, including a high-level meeting, with ministerial participation, to have an integrated overview of the implementation of Agenda 21, to consider emerging policy issues and to provide necessary political impetus to the implementation of the decisions of the United Nations Conference on Environment and Development and the commitments contained therein.

At its first session, the Commission decided that, as a rule, its high-level meetings should last for a period of up to three days and that they should be integral parts of the session of the Commission and of its decision-making process. The organization of work of the high-level meetings should provide, *inter alia*, for an open exchange of views among the participants and for holding informal meetings, as the need arose, to resolve outstanding issues related to its work that required high-level consideration. The result of the high-level meetings could be a concise document, should the participants deem that appropriate.

In the Programme for the Further Implementation of Agenda 21, the General Assembly decided that, based on the experience gained during the period 1993-1997, the Commission, under the guidance of the Council, should make concerted efforts to attract greater involvement in its work of ministers and high-level national policy makers responsible for specific economic and social sectors, who, in particular, are encouraged to participate in the annual high-level segment of the Commission, together with the ministers and policy makers responsible for environment and development; the high-level segments of the Commission should become more interactive, and should focus on the priority issues being considered at a particular session; and the Bureau of the Commission should conduct timely and open-ended consultations with a view to improving the organization of the work of the high-level segment (resolution S-19/2, annex, para. 133 (a)).

## **8. Other matters**

In resolution 1997/53, the Council welcomed the recent initiatives of the United Nations in partnership with international consumer organizations, such as Consumers International, donors and host Governments, in convening regional conferences on consumer protection, such as those held in Africa and in the Asia and Pacific region, for initiating the process of revising the guidelines for consumer protection and extending them into the area of sustainable consumption patterns and other possible areas; requested the Secretary-General to undertake that work through the convening of an interregional expert group meeting, to be financed from extrabudgetary resources and in collaboration with interested Governments, Consumers International and other concerned entities active in this field; and recommended that the interregional expert group meeting elaborate specific recommendations for guidelines for sustainable consumption patterns for submission to the Council at its substantive session of 1998 through the Commission for Sustainable Development at its sixth session.

In the Programme for the Further Implementation of Agenda 21, the General Assembly decided that the Commission, under the guidance of the Council, should continue to provide a forum for the exchange of national experience and best practices in the area of sustainable development, including through voluntary national communications or reports (resolution S-19/2, annex, para. 133 (b)).

Also in the Programme for the Further Implementation of Agenda 21, the General Assembly decided that the Commission, under the guidance of the Council, should take into account regional developments related to the implementation of the outcomes of the United Nations Conference on Environment and Development, and that it should provide a forum for the exchange of experience on regional and subregional initiatives and regional collaboration for sustainable development (resolution S-19/2, annex, para. 133 (c)).
