Annotations

1. Election of officers

Rule 15 of the rules of procedure of the functional commissions of the Economic and Social Council provides that, at the commencement of the first meeting of a regular session, the United Nations Forum on Forests shall elect, from among the representatives of its members, a Chair and such other officers as may be required (see [E/5975/Rev.1](#)). In accordance with Council resolution 2000/35, by which the Forum was established, the Bureau of the Forum shall consist of a Chair and four Vice-Chairs, one of whom shall also act as Rapporteur, in accordance with the principle of equitable geographical distribution.

At the first meeting of its twelfth session, on 22 April 2016, the Forum elected Mr. Peter Besseau (Canada) as Chair and Ms. Clarissa Souza Della Nina (Brazil), Mr. Wu Zhimin (China) and Mr. Tomas Krejzar (Czechia) as Vice-Chairs of the Forum at its twelfth session. The Forum is expected to elect a Vice-Chair, to be nominated by the African Group, at the second meeting of the twelfth session.

2. Adoption of the agenda and other organizational matters

In accordance with rule 7 of the rules of procedure of the functional commissions of the Economic and Social Council, the Forum shall, at the beginning of the session, adopt the agenda and organization of work for that session on the basis of the provisional agenda.

3. Implementation of the United Nations Strategic Plan for Forests 2017-2030

(a) Technical discussion and exchange of experiences on the thematic and operational priorities, priority actions and resource needs for the period 2017-2018, taking into account the review cycle of the high-level political forum on sustainable development during the biennium and the theme of the International Day of Forests

In accordance with the quadrennial programme of work of the Forum, the twelfth session will focus on technical discussions and exchange of experiences on the thematic and operational priorities, priority actions and resource needs for the period 2017-2018, with the engagement of, and exchange of experiences among, States members of the Forum, member organizations of the Collaborative Partnership on Forests, regional and subregional organizations, major groups and other relevant stakeholders and the science-policy interface. These discussions will take into account the theme and review cycle of the high-level political forum on sustainable development for the period 2017-2018 and the theme of the International Day of Forests in 2018. Under this item, the Forum will provide its contribution to the follow-up, review and implementation of the Sustainable Development Goals and targets under consideration by the 2017 high-level political forum. The Forum may also wish to discuss activities in preparation for its contribution to the theme, Sustainable Development Goals and targets under consideration by the 2018 high-level political forum. Emerging issues and challenges of global significance that are related to and/or have an impact on forests and sustainable forest management will also be discussed under this agenda item.

(b) Voluntary announcement of voluntary national contributions, where appropriate

In accordance with the United Nations Strategic Plan for Forests 2017-2030 ([E/CN.18/SS/2017/2](#)), Member States may, on a voluntary basis, determine their contributions towards achieving the global forest goals and targets of the Strategic Plan (voluntary national contributions), taking into account their national circumstances, policies, priorities, capacities, levels of development and forest conditions. Member States and stakeholders may wish to make a voluntary announcement of their voluntary national contributions during the twelfth session of the Forum under this agenda item. Background information for discussions by Member States on the possible format for voluntary national contributions is provided in the report of the Secretary-General on monitoring, assessment and reporting to be submitted under item 4.

(c) United Nations system-wide contributions to the implementation of the global forest goals and targets

The United Nations Strategic Plan for Forests 2017-2030 serves as a reference for the forest-related work of the United Nations system and for fostering enhanced coherence, collaboration and synergies among United Nations bodies and partners towards its vision and mission, as well as a framework to enhance the coherence of

and guide and focus the work of the international arrangement on forests and its components. As outlined in the Strategic Plan, United Nations bodies, organizations and specialized agencies that address issues that are relevant to forests, within the scope of their mandates, were invited to use the Strategic Plan as a reference with a view to building synergies between the global forest goals and targets of the Strategic Plan and their respective policies and programmes, including their contributions to the achievement of the Sustainable Development Goals. United Nations system organizations and partners may wish to inform the Forum on their planned activities to contribute to the implementation of the global forest goals and targets of the United Nations Strategic Plan for Forests 2017-2030 under this agenda item.

4. Monitoring, assessment and reporting

In accordance with General Assembly and Economic and Social Council resolutions (to be added) on the United Nations Strategic Plan for Forests 2017-2030 and Economic and Social Council resolution 2015/33, the Forum is to establish a cycle and format for voluntary national reporting by its members, taking into account the cycle of the Global Forest Resources Assessments by the Food and Agriculture Organization of the United Nations and the Sustainable Development Goals review cycle at the global level. In addition, in accordance with the provisions of the quadrennial programme of work, States members of the Forum are also expected to discuss the format for communicating their voluntary national contributions to the Forum. In accordance with the Strategic Plan, States members of the Forum may, on a voluntary basis, communicate their progress on the voluntary national contributions as part of their voluntary reporting on the United Nations Strategic Plan for Forests 2017-2030 and the United Nations forest instrument. The report of the Secretary-General under this agenda item includes a proposal for a new reporting format and reporting cycle, an update on ongoing work on the development of a set of global forest indicators and possible measures to further streamline and harmonize reporting, reduce reporting burdens and synchronize data collection with relevant members of the Collaborative Partnership on Forests, criteria and indicators processes and other existing forest data collection mechanisms.

The Global Forest Financing Facilitation Network of the Forum, which was established in accordance with Economic and Social Council resolution 2015/33, works in close cooperation with members of the Collaborative Partnership on Forests to contribute to the implementation of sustainable forest management by mobilizing, catalysing and facilitating access to financial resources. The note by the Secretariat under this agenda item provides a summary of the activities of the Global Forest Financing Facilitation Network since the adoption of resolution 2015/33 and provides a basis to initiate discussion on the guidelines for the operation of the Network, which are to be considered at the thirteenth session of the Forum in 2018.

The report of the Secretary-General under this item includes information on the activities of the regional and subregional partners in implementing relevant provisions of Economic and Social Council resolution 2015/33 and, in particular, their contributions to the development and implementation of the United Nations Strategic Plan for Forests 2017-2030 and the quadrennial programme of work.

(iii) Major groups and other relevant stakeholders

The report of the Secretary-General under this item includes information on the activities of the major groups and other stakeholders in implementing the provisions of Economic and Social Council resolution 2015/33 and, in particular, their contributions to the development and implementation of the United Nations Strategic Plan for Forests 2017-2030 and the quadrennial programme of work.

(iv) Communication and outreach activities

The Forum considers communication and outreach aimed at raising awareness of the vital contribution of all types of forests and trees to life on earth and human well-being to be an essential component of the United Nations Strategic Plan for Forests 2017-2030. The International Day of Forests, on 21 March, will promote the implementation of the Strategic Plan by providing a global platform for individual and collective public outreach activities by all actors on forests at all levels. The report of the Secretary-General under this item includes information on the relevant activities since the adoption of Economic and Social Council resolution 2015/33.

(b) Revision of the existing guidelines for country-led initiatives and similar initiatives to enhance their contribution to the work of the Forum

Pursuant to Economic and Social Council resolution 2015/33, the Forum decided to enhance the contributions by country-led and similar initiatives to the work of the Forum by ensuring that they directly support the priorities of the Forum as defined in its quadrennial work programmes, ensuring that their outcomes are considered by the Forum and updating the Forum guidelines. The Forum, at its twelfth session, is expected to update those guidelines.

As outlined in the quadrennial programme of work of the Forum for 2017-2020, the output of odd-year sessions of the Forum includes a chair's summary report on discussions, including possible proposals, which is transmitted the Forum at its subsequent sessions in the even-year for further consideration and recommendations.
