Statement

- 1. We, the undersigned international and national non-governmental organizations in consultative status with the Economic and Social Council, members of the Vienna NGO Committee on the Status of Women, present to the fifty-fourth session of the United Nations Commission on the Status of Women the following statement on "Gender-sensitive medicine and the empowerment of women" for information and consideration.
- 2. Recalling paragraph 17 of the Beijing Declaration, in which Governments expressed their conviction that "the explicit recognition and reaffirmation of the right of all women to control all aspects of their health, in particular their own fertility, is basic to their empowerment", and in view of the fact that it has been scientifically proven that the female body reacts differently to medical procedures, treatment, rehabilitation and pharmaceutical products, a fact which has been neglected so far by all actors and medical institutions concerned, the undersigned non-governmental organizations:
 - (a) Emphasize the importance of gender-sensitive medicine;
- (b) Strongly believe that the promotion of women's and girls' health, including their reproductive health, throughout their lifecycle through accessible and gender-sensitive medical care is a precondition for their empowerment and will result in the improvement of the health of the entire society;
- (c) Are convinced that health represents for women and girls the complete physical, emotional, mental and social well-being, and that it is therefore of vital importance to acknowledge gender differences in all aspects of health care, including medical and pharmaceutical research, training of health-care providers, treatment, therapy and rehabilitation as well as women's health assessment by insurance companies;
- (d) Are appalled by the scandalous lack of progress in the implementation of the Millennium Development Goals, in particular Millennium Development Goal 5;
- (e) Are convinced that imposed sexualized body images of female appearance are detrimental to the physical and mental health of women and girls.
- 3. We therefore urge Governments to:
- (a) Provide adequate funding of scientific research in gender medicine, the provision of data disaggregated by sex to achieve optimal health programmes that take into account factors such as gender differences, age groups and ethnicity;
- (b) Allocate national budgets favouring gender equality and the empowerment of women and girls, especially with a view to gender-sensitive medicine;
- (c) Undertake all efforts to ensure that female genital mutilation be eradicated worldwide;
- (d) Combine gender-sensitive and culture-sensitive medical care for women and girls with migrant backgrounds, guaranteeing them access to medical information and treatment;
- (e) Implement measures to ensure gender-sensitive access to medical information and treatment for women and girls with disabilities.
