#### **Annotations**

#### 10. Administrative and budgetary questions

In its resolution 13 (XXXVI), the Commission on Narcotic Drugs established a budget cycle for the Fund of the United Nations International Drug Control Programme and a methodology that it would follow in its consideration of budgetary matters. According to the established budget cycle and revised methodology, the Commission approves the final budget for the current biennium and the initial budget for the next biennium for the Fund of the United Nations International Drug Control Programme at its reconvened session, held in the final months of odd-numbered years. At its session held in the first half of odd-numbered years, the Commission reviews and approves the proposed outline for the budget of the Fund for the next biennium and, if required, the revised biennial programme and support budget for the current biennium.

In its resolution 50/13, the Commission agreed with the preliminary indicative estimates for the consolidated budget for the biennium 2008-2009 for the Fund of the United Nations International Drug Control Programme and requested the Executive Director of the United Nations Office on Drugs and Crime (UNODC) to submit to it at its reconvened fiftieth session a consolidated budget for the biennium 2008-2009 based on those figures. It also requested the Executive Director to prepare the consolidated budget for the biennium 2008-2009, as well as for the biennium 2010-2011, for UNODC based on, inter alia, the strategy for the biennium 2008-2009 for UNODC, as approved by the Economic and Social Council in its resolution 2007/12.

In its resolution 2007/12, the Economic and Social Council requested the Executive Director to prepare the consolidated budget for the biennium 2008-2009 for

UNODC based, inter alia, on the strategy for the period 2008-2011 for UNODC; and also requested the Executive Director to submit to the Commission at its reconvened fiftieth session a report identifying the medium-term strategy activities projected for the biennium 2008-2009. That information will also be reflected in the report of the Executive Director on the consolidated budget for the biennium 2008-2009 for UNODC (E/CN.7/2007/17-E/CN.15/2007/18).

At its reconvened fiftieth session, the Commission is expected to review and approve the budget for the biennium 2006-2007 and the initial budget for the biennium 2008-2009 for the Fund of the United Nations International Drug Control Programme.

Opening of the fifty-first session of the Commission on Narcotic Drugs and election of officers

In accordance with rule 16 of the rules of procedure of the functional commissions of the Economic and Social Council, officers of the Commission on Narcotic Drugs will hold office until their successors are elected and will be eligible for re-election.

As regards the arrangements for the election of the bureau of the Commission, in section I of its resolution 1999/30, the Economic and Social Council decided that, with effect from the year 2000, the Commission should, at the end of the session, elect its bureau for the subsequent session and encourage the bureau to play an active role in the preparations of the regular as well as the intersessional meetings of the Commission, so as to enable the Commission to provide continuous and effective policy guidance.

In accordance with section I of Economic and Social Council resolution 1999/30 and rule 16 of the rules of procedure of the functional commissions, the Commission, at the end of its reconvened fiftieth session, on 28 November 2007, is invited to open its fifty-first session to elect a Chairman, three Vice-Chairmen and a

Rapporteur for its fifty-first session. In view of the established practice of rotating the offices based on regional distribution, the officers to be elected by the Commission will be from the following regional groups:

Caribbean States

First Vice-Chairman Group of African States
Second Vice-Chairman Group of Asian States

Third Vice-Chairman Group of Eastern European

States

Rapporteur Group of Western European and

other States

In accordance with established practice and Economic and Social Council resolution 1991/39, a group composed of the five chairmen of the regional groups, the Chairman of the Group of 77 and China and the representative of or observer for the State currently having the Presidency of the European Union will assist the Chairman in dealing with organizational matters. That group, together with the elected officers, will constitute the extended bureau.
