1. The Commission on Population and Development held its thirty-first session at United Nations Headquarters from 23 to 27 February 1998.

# Chapter II. Follow-up actions to the recommendations of the International Conference on Population and Development

#### A. Health and mortality

2. The Commission on Population and Development held a general discussion of item 3 (a) of its agenda, entitled "Follow-up actions to the recommendations of the International Conference on Population and Development: health and mortality", at its 1st to 3rd meetings, on 23 and 24 February 1998. It had before it the following documents:

- (a) Concise report of the Secretary-General on world population monitoring, 1998: health and mortality (E/CN.9/1998/2);
- (b) Report of the Secretary-General on the monitoring of population programmes: programme experience in implementing health and mortality activities (E/CN.9/1998/3);
- (c) Report of the Administrative Committee on Coordination Task Force on Basic Social Services for All: health and mortality (E/CN.9/1998/4);
- (d) Report of the Secretary-General on the activities conducted by non-governmental organizations and intergovernmental organizations in sexual and reproductive health and rights: three years after the International Conference on Population and Development (E/CN.9/1998/5);
- (e) Report of the Secretary-General on the flows of financial resources for population activities (E/CN.9/1998/6).

- 3. At the 1st meeting, on 23 February, the Director of the Population Division of the Department of Economic and Social Affairs of the United Nations Secretariat made an introductory statement.
- 4. At the same meeting, the Assistant Director and Chief of the Demographic Analysis Branch of the Population Division introduced the concise report of the Secretary-General on world population monitoring, 1998: health and mortality (E/CN.9/1998/2). The special discussant, Mr. Shiro Horiuchi of The Rockefeller University, also made a statement.
- 5. Also at the same meeting, statements were made by the representatives of Belgium, Indonesia (on behalf of the States Members of the United Nations that are members of the Group of 77 and China), the United Kingdom of Great Britain and Northern Ireland (on behalf of the States Members of the United Nations that are members of the European Union, and associated countries), the United States of America, China, the Sudan, the Russian Federation, Jamaica and Turkey.

#### Reports contained in documents E/CN.9/1998/3-6

- At the 2nd meeting, on 23 February, the Director of the Technical and Policy Division of the United Nations Population Fund made an introductory statement. Introductory statements were also made by the representative of the Technical and Policy Division of the United Nations Population Fund, who introduced the report of the Secretary-General contained in document E/CN.9/1998/3; the Deputy Director of the Technical and Policy Division and Chief of the Policy Branch of the United Nations Population Fund, who introduced the report of the Administrative Committee on Coordination Task Force contained in document E/CN.9/1998/4; the Chief of the Technical Branch of the Technical and Policy Division of the United Nations Population Fund, who introduced the report of the Secretary-General contained in document E/CN.9/1998/5; and the representative of the Technical and Policy Division of the United Nations Population Fund, who introduced the report of the Secretary-General contained in document E/CN.9/1998/6.
- 7. At the same meeting, statements were made by the representatives of Bangladesh, the Sudan, Ukraine, Egypt, the United Kingdom of Great Britain and Northern Ireland, Sweden, Jamaica, Algeria, the Republic of Korea and Japan. The representative of the World Health Organization made a statement. The representative of the International Organization for Migration also made a statement. Statements were also made by the representatives of the Committee for

- International Cooperation in National Research in Demography (a non-governmental organization in consultative status with the Economic and Social Council, Roster) and Advocacy for Women's Health (a working group of international non-governmental organizations).
- 8. At the 3rd meeting, on 24 February, statements were made by the representatives of the Food and Agriculture Organization of the United Nations and the United Nations Educational, Scientific and Cultural Organization.

### B. Process for the quinquennial review and appraisal in 1999

- 9. The Commission on Population and Development held a general discussion of item 3 (b) of its agenda, entitled "Follow-up actions to the recommendations of the International Conference on Population and Development: process for the quinquennial review and appraisal in 1999", at its 2nd and 3rd meetings, on 23 and 24 February 1998.
- 10. At the 2nd meeting, on 23 February, the Director of the Population Division introduced a draft outline of the quinquennial review and appraisal.
- 11. At the same meeting, the representative of Canada made a statement.
- 12. At the 3rd meeting, on 24 February, the Executive Director of the United Nations Population Fund made a statement.
- 13. At the same meeting, statements were made by the representatives of Japan, the United Kingdom of Great Britain and Northern Ireland (on behalf of the States Members of the United Nations that are members of the European Union, and associated countries), the Sudan, Indonesia (on behalf of the States Members of the United Nations that are members of the Group of 77 and China), the United States of America, Brazil, India and Sweden.

# Chapter III. General debate on national experience in population matters: health and mortality

- 14. The Commission on Population and Development held a general discussion of item 4 of its agenda, entitled "General debate on national experience in population matters: health and mortality", at its 3rd to 5th meetings, on 24 and 25 February 1998.
- 15. At the 3rd meeting, on 24 February, statements were made by the representatives of Bangladesh, Japan, China,

Thailand, Kenya, Algeria, Canada, Pakistan, Mexico and the Russian Federation.

- 16. At the 4th meeting, on 24 February, statements were made by the representatives of the United States of America, the Republic of Korea, Egypt, the Niger, South Africa, Brazil and Ethiopia and the observer for Poland.
- 17. At the 5th meeting, on 25 February, statements were made by the representatives of India, Jamaica, El Salvador, Malta, Ukraine, the Islamic Republic of Iran, Turkey, Malaysia, Sweden, the Sudan, Indonesia, Peru and Malawi and the observers for Switzerland and the Holy See.

- 18. The Commission on Population and Development held a general discussion of item 5 of its agenda, entitled "Programme questions", at its 5th and 6th meetings, on 25 February 1998. It had before it the following documents:

- 19. At the 5th meeting, on 25 February, the Director of the Population Division made an introductory statement.
- 20. At the same meeting, statements were made by the representatives of the United States of America, Bangladesh, the Republic of Korea and India and the observer for the Holy See. The representative of the Food and Agriculture Organization of the United Nations made a statement.

The representative of the Population Institute (a non-governmental organization in consultative status with the Economic and Social Council, Roster) also made a statement.

21. At the 6th meeting, on 25 February, statements were made by the representatives of Brazil and Kenya. The representative of the World Health Organization made a statement. Statements were also made by the representatives of the Economic Commission for Europe, the Economic Commission for Latin America and the Caribbean, the Economic and Social Commission for Asia and the Pacific,

the Economic and Social Commission for Western Asia and the Economic Commission for Africa.
