Draft programme of work of the Population Division for the biennium 2002-2003

Note by the Secretariat

- 1. The draft programme of work in the field of population for the biennium 2002-2003, which is contained in the annex, is submitted for the consideration of the Commission on Population and Development in compliance with the Regulations and Rules Governing Programme Planning, the Programme Aspects of the Budget, the Monitoring of Implementation and the Methods of Evaluation. In section I, paragraph 7, of its resolution 52/220, the General Assembly stressed the role of the relevant intergovernmental bodies in the consideration of the narrative of the proposed programme budget, as well as the need for a timely presentation of their recommendations on the budget.
- 2. The draft programme of work has been formulated within the framework of subprogramme 6 (Population) of programme 7 (Economic and social affairs) of the medium-term plan for the period 2002-2005.
- 3. The Commission is invited to comment and make recommendations, as appropriate, on the draft programme of work. These comments and recommendations will be taken into account, as appropriate, by the Secretary-General in finalizing his proposed programme budget for the biennium 2002-2003, which will be reviewed by the Committee for Programme and Coordination, the Advisory Committee on Administrative and Budgetary Questions and the General Assembly at its fifty-sixth session.

Draft programme budget for the biennium 2002-2003 for the Population Division, Department of Economic and Social Affairs

- 1. The subprogramme will be implemented by the Population Division.
- 2. The draft programme of work has been formulated within the framework of subprogramme 6 (Population) of programme 7 (Economic and social affairs) of the medium-term plan for the period 2002-2005.

- 1. Frequency of citation of research findings in statements by or on behalf of national policy makers or in policy documents.
- 2. Frequency of citations in policy documents and statements of research findings of United Nations Population Division and coverage in press.

Indicator(s) of achievement

- 1. Feedback from users that they receive information in a timely manner on United Nations Population Division publications or databases, for use in their policy processes.
- 2. Frequency of use of research findings in the field of population and development.

Indicator(s) of achievement

Demographic indicators of progress achieved in the implementation of the Programme of Action of ICPD and the key issues for the further implementation of the Programme of Action of ICPD adopted at the twenty-first special session of the General Assembly.

External factor(s)
