Summary

The thirty-fifth session of the Commission on Population and Development was held at United Nations Headquarters from 1 to 5 April 2002. Its central theme was reproductive rights and reproductive health, with special reference to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS).

The documents before the Commission included a report on world population monitoring, focusing on the theme of the session. The report provided recent information on selected aspects of reproductive rights and reproductive health, covering topics such as: entry into reproductive life; reproductive behaviour; family planning; abortion; maternal mortality and morbidity; sexually transmitted infections; HIV/AIDS; and reproductive rights. Other reports covered the intersessional meeting of the Bureau of the Commission; monitoring of population programmes focusing on reproductive rights and reproductive health, with special reference to HIV/AIDS, as contained in the Programme of Action of the International Conference on Population and Development; the flow of financial resources for assisting in the implementation of the Programme of Action; and programme implementation and progress of work in the field of population in 2001.

The Commission considered follow-up actions to the recommendations of the International Conference on Population and Development and adopted a resolution concerning reproductive rights and reproductive health, including HIV/AIDS. In that resolution, the Commission requested the Population Division of the Department of Economic and Social Affairs of the Secretariat to continue its research and requested the United Nations Population Fund to continue its programming on reproductive rights and reproductive health, in close collaboration with each other and with all other relevant funds, programmes and agencies of the United Nations system. It also requested the Population Division, in collaboration with the Joint United Nations Programme on Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (HIV/AIDS) (UNAIDS) and other relevant funds, programmes and agencies, to strengthen its work on the demographic aspects and impact of HIV/AIDS. It further requested that the Population Division incorporate the findings from that and other relevant research on reproductive rights and reproductive health, including the interrelationship with HIV/AIDS, in its contribution to the next review and appraisal of the implementation of the Programme of Action of the International Conference on Population and Development scheduled for 2004 and, to the extent appropriate, to the annual reviews of the Declaration of Commitment on HIV/AIDS as well as to any other relevant processes.

The Commission approved the draft provisional agenda for its thirty-sixth session, to be held in New York from 31 March to 4 April 2003, and adopted its report on its thirty-fifth session.

adopted at the twenty-third special session of the General Assembly,⁶ in particular those recommendations relating to reproductive rights and reproductive health,

Bearing in mind the goals and objectives of the United Nations Millennium Declaration⁷ and the outcome of other major United Nations conferences and summits and their reviews, in particular on population and development,

Bearing in mind also the Universal Declaration of Human Rights⁸ and the Declaration of Commitment on HIV/AIDS,⁹

Recalling that the theme for the thirty-fifth session of the Commission on Population and Development was "Reproductive rights and reproductive health, with special reference to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS)",

- 1. Requests the Population Division of the Department of Economic and Social Affairs of the United Nations Secretariat to continue its research and requests the United Nations Population Fund to continue its programming on reproductive rights and reproductive health, in close collaboration with each other and with all other relevant funds, programmes and agencies of the United Nations system;
- 2. Also requests that the Population Division, in collaboration with the Joint United Nations Programme on Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (HIV/AIDS) (UNAIDS) and other relevant funds, programmes and agencies, strengthen its work on the demographic aspects and impact of human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS);
- 3. Further requests that the Population Division incorporate the findings from this and other relevant research on reproductive rights and reproductive health, including the interrelationship with HIV/AIDS, in its contribution to the next review and appraisal of the implementation of the Programme of Action of the International Conference on Population and Development¹ scheduled for 2004 and, to the extent appropriate, to the annual reviews of the Declaration of Commitment on HIV/AIDS⁹ as well as to any other relevant review processes.

Chapter II

Follow-up actions to the recommendations of the International Conference on Population and Development

- 3. The Commission on Population and Development held a general discussion on item 3 of its agenda, entitled "Follow-up actions to the recommendations of the International Conference on Population and Development", at its 1st, 2nd and 3rd meetings, on 1 and 2 April 2002. It had before it the following documents:
- (a) Concise report of the Secretary-General on world population monitoring, 2002: reproductive rights and reproductive health, with special reference to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS) (E/CN.9/2002/2);
- (b) Report of the Secretary-General on the monitoring of population programmes focusing on reproductive rights and reproductive health, with special reference to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS), as contained in the Programme of Action of the International Conference on Population and Development (E/CN.9/2002/3);
- (c) Report of the Secretary-General on the flow of financial resources for assisting in the implementation of the Programme of Action of the International Conference on Population and Development (E/CN.9/2002/4);
- (d) Statement submitted by Catholics for a Free Choice, a non-governmental organization in special consultative status with the Economic and Social Council, in accordance with paragraphs 36 and 37 of Council resolution 1996/31 (E/CN.9/2002/NGO/1).
- 4. At the 1st meeting, on 1 April, introductory statements were made by the Director of the Population Division of the Department of Economic and Social Affairs of the United Nations Secretariat, the Assistant Director and Chief of the Demographic Analysis Branch of the Population Division, the Chief a.i. of the Reproductive Health Branch of the Technical Support Division of the United Nations Population Fund, and the Director of the Technical Support Division of the United Nations Population Fund.
- 5. At the same meeting, the special discussant for the item, Amy Tsui, Professor at Johns Hopkins University, Baltimore, Maryland, United States of America, made a statement.
- 6. Also at the 1st meeting, statements were made by the representatives of Egypt, the Islamic Republic of Iran, China and Yemen and the observer for Spain (on behalf of the States Members of the United Nations that are members of the European Union).
- 7. At the 2nd meeting, on 1 April, statements were made by the representatives of the United States of America, Japan, Mexico, Pakistan, Ghana, Algeria and Indonesia and the observers for the Syrian Arab Republic and Canada.
- 8. Also at the 2nd meeting, the representative of the International Planned Parenthood Federation, a non-governmental organization in general consultative status with the Economic and Social Council, made a statement.
- 9. At the 3rd meeting, on 2 April, the representative of Norway made a statement.

10. At the same meeting, statements were made by the representatives of the Joint United Nations Programme on Human Immunodeficiency Virus/Acquired Immunodeficiency Syndrome (HIV/AIDS) (UNAIDS) and the World Health Organization.

Action taken by the Commission

Reproductive rights and reproductive health, including human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS)

- 11. At the 7th meeting, on 5 April, the Vice-Chairman of the Commission, Makoto Atoh (Japan), reported to the Commission on the work undertaken in the informal working group and also introduced a draft resolution (E/CN.9/2002/L.4) entitled "Reproductive rights and reproductive health, including human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS)".
- 12. At the same meeting, the Commission adopted the draft resolution (see chap. I, sect. B, resolution 2002/1).
- 13. After the adoption of the draft resolution, the representative of the United States of America made a statement.

14. At the 7th meeting, on 5 April, on the proposal of the Chairman, the Commission took note of the documentation submitted under agenda item 3 (see chap. I, sect. B, decision 2002/1).

Chapter III

National experience in population matters: reproductive rights and reproductive health, with special reference to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS), as contained in the Programme of Action of the International Conference on Population and Development

- 15. The Commission on Population and Development considered item 4 of its agenda, entitled "General debate on national experience in population matters: reproductive rights and reproductive health, with special reference to human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/AIDS), as contained in the Programme of Action of the International Conference on Population and Development", at its 3rd to 5th meetings, on 2 and 3 April 2002.
- 16. At the 3rd meeting, on 2 April, statements in the general debate were made by the representatives of Brazil, Chile, Croatia, Belgium, Algeria, the Russian Federation, the Netherlands, Botswana, China, Norway, Germany and Indonesia and the observers for Sweden, the United Kingdom of Great Britain and Northern Ireland, Spain, the Republic of Korea and the Dominican Republic.
- 17. At the 5th meeting, on 3 April, statements in the general debate were made by the representatives of Italy, Lithuania, Bangladesh, Poland, France, Malaysia, Ghana, Jamaica, Austria and Kenya and the observers for India, the Philippines, Portugal and South Africa.

Panel discussion

18. At its 4th meeting, on 2 April, the Commission held a panel discussion, moderated by Muhamad Noor Yacob, Deputy Secretary-General, Ministry of Women and Family Development of Malaysia. The following panellists made presentations, after which a question and answer session took place: Anabella Arredondo Paz, Executive Director, National Commission on AIDS, Ministry of Health of Chile; John Jackson, Chairman, Irish Aid Advisory Committee; Olga Antonova, Deputy Director, Population Statistics Department, State Committee of the Russian Federation on Statistics; and Lindi Molefe, Director, Population and Development Strategies, Department of Social Development of South Africa.

Chapter IV

Programme implementation and future programme of work of the Secretariat in the field of population

- 19. The Commission on Population and Development held a general discussion of item 5 of its agenda, entitled "Programme implementation and future programme of work of the Secretariat in the field of population", at its 6th and 7th meetings, on 3 and 5 April 2002. It had before it the report of the Secretary-General on programme implementation and progress of work in the field of population in 2001: Population Division, Department of Economic and Social Affairs (E/CN.9/2002/5).
- 20. At the 6th meeting, on 3 April, the Director of the Population Division made an introductory statement.
- 21. At the same meeting, statements were made by the representatives of the United States of America, Norway, China and Bangladesh.
- 22. Also at the 6th meeting, the representative of the Food and Agriculture Organization of the United Nations made a statement.
- 23. At the same meeting, statements were made by the representatives of the Economic Commission for Latin America and the Caribbean, the Economic and Social Commission for Asia and the Pacific and the Office of the Regional Commissions in New York (on behalf of the Economic Commission for Africa).
- 24. Also at the 6th meeting, statements were made by the following non-governmental organizations: *general consultative status*: International Institute for Applied Systems Analysis; *special consultative status*: IPAS, International Women's Health Coalition (on behalf of the International Sexual and Reproductive Rights Coalition), Commonwealth Medical Association, and International Union for the Scientific Study of Population.
- 25. At the 7th meeting, on 5 April, the representative of the Population Institute, a non-governmental organization in consultative status with the Economic and Social Council (Roster), made a statement.

- 29. At its 7th meeting, on 5 April 2002, the Commission adopted the draft report on its thirty-fifth session (E/CN.9/2002/L.3), as introduced by the Vice-Chairman-cum-Rapporteur.
- 30. At the same meeting, the Commission also authorized the Vice-Chairman-cum-Rapporteur to finalize the report by incorporating therein the proceedings of its 7th meeting.

Chapter VII

Organization of the session

A. Opening and duration of the session

- 31. The Commission on Population and Development held its thirty-fifth session at United Nations Headquarters from 1 to 5 April 2002. The Commission held 7 meetings (1st to 7th).
- 32. The session was opened by the Chairman of the thirty-fourth session, Makoto Atoh (Japan).
- 33. Opening statements were made by the Under-Secretary-General for Economic and Social Affairs of the United Nations Secretariat, the Executive Director of the United Nations Population Fund and the Director of the Population Division of the Department of Economic and Social Affairs.
- 34. At the 2nd meeting, on 1 April, the President of the Economic and Social Council addressed the Commission.
