EXPLANATORY NOTES

Item 1

In accordance with the Commission's rules of procedure, the first item on the provisional agenda is the adoption of the agenda. The documents for the session will be published in English, French and Russian and will be posted on the UNECE web site as soon as they become available at the following address: http://www.unece.org/ie/se/coal/cmm.html.

Item 2

At the first session of the Task Force, the members drafted Terms of Reference (TOR) for discussion and consideration. The meeting agreed upon the importance of the Task Force having a brief TOR that would provide a general guide for steering its work and activities. The final TOR is presented in Annex I for adoption by the Task Force.

Item 3

The members determined that two very important activities for the Task Force are the preparation and distribution of case studies on methane degasification programmes and development of a set of guidelines to increase both safety and productivity at mine sites. To initiate these efforts, the Task Force will discuss the draft template distributed among the members for development of their case studies. Geologic conditions, mining practices, and market conditions vary by country, region, basin, and even by mine. Technologies that have worked in some instances have failed in others. To create a truly valuable resource, the case studies will examine both successful and unsuccessful degasification programmes in a range of settings in different countries. Identifying and discussing the reasons for success or failure will provide users with a better foundation to adapt and apply certain technologies or applications to their unique circumstances.

Item 4

The work of the Task Force complements the work of other national, international, and non-governmental organizations addressing mine safety and methane capture/use such as the International Labour Organization and the Methane to Markets Partnership. The Task Force will consider opportunities to collaborate with the other organizations and initiatives to further the overarching goal of improving mine safety.

Item 5

The Task Force will be given an opportunity to discuss and review the programme of work for 2006 and propose specific activities to be carried out during this period.

TERMS OF REFERENCE

The Task Force on the Economic Benefits of Improving Mine Safety through Extraction and Use of Coal Mine Methane was launched in April 2005 to specifically support the activities of the Ad Hoc Group of Experts on Coal Mine Methane in the area of improving mine safety through extraction and use of coal mine methane. The Task Force, which will comprise experts from the technical, business and regulatory communities, will report on its activities to the annual sessions of the Ad Hoc Group of Experts on Coal Mine Methane.

The Task Force will seek to:

- (i) establish a clear linkage between the economic benefits and the mining of gassy coal seams based on the safe drainage and use of the gas, and to facilitate this through the establishment of a dedicated membership from the technical, business and regulatory communities;
- (ii) develop a number of focused case studies that will then serve to provide the basis for the elaboration of a set of UN Guidelines on "Avoidance and Minimizing Impact of Mine Explosions and Other Impacts of Mine Gas"; and
- (iii) cooperate and work with the governments of target countries and the global mining industry in developing the economic justifications for implementing incentives to increase the extraction and use of coal mine methane.
