# Letter dated 1 July 2004 from the Chairman of the Security Council Committee established pursuant to resolution 1373 (2001) concerning counter-terrorism addressed to the President of the Security Council

On 13 April 2004, the Committee established pursuant to paragraph 6 of Security Council resolution 1373 (2001) (the Counter-Terrorism Committee) submitted a work programme for the eleventh 90-day period (S/2004/284). Annexed hereto is the Committee's work programme for the twelfth 90-day period, which covers the months from July to September 2004 (see annex).

The Committee will continue to work with States on monitoring the implementation of resolution 1373 (2001), operating on the principles of cooperation, transparency and equal treatment. The Committee's main objectives will remain maintaining and strengthening the consensus within the international community on the importance of combating terrorism, with particular emphasis on establishing practical measures designed to increase the capabilities of States to combat terrorism; helping to identify and address the problems faced by States in implementing resolution 1373 (2001); and encouraging international coordination and cooperation by, for instance, stimulating the process of increasing the number of States that are parties to the international conventions and protocols relating to counter-terrorism. All of these tasks contribute to the Committee's mandate, as set out in paragraph 6 of the resolution, to monitor its implementation.

The twelfth work programme covers the ongoing transitional period during which the Committee in cooperation with the United Nations Secretariat will continue the implementation of the provisions of Security Council resolution 1535 (2004) and the recommendations contained in the Committee's report (S/2004/124) to enable the Counter-Terrorism Committee Executive Directorate to become operational as soon as possible.

In order to attain those general goals, the Committee will continue its work in the areas of technical assistance and cooperation with international organizations in accordance with the decisions adopted by the Committee.

The Committee welcomes the support received from Member States, the United Nations Secretariat and international, regional and subregional organizations, and pays tribute to the contribution of its team of experts.

## Annex

# Work programme of the Counter-Terrorism Committee (1 July-30 September 2004)

1. The present document sets out the work programme of the Counter-Terrorism Committee for its twelfth 90-day period, from 1 July to 30 September 2004. This work programme updates that submitted for the eleventh 90-day period (S/2004/284). This work programme will have to be adapted according to the implementation of Security Council resolution 1535 (2004).

#### Summary

- 2. The Committee will:
  - (a) By 31 July:

(i) Consider and endorse the organizational plan for the Counter-Terrorism Committee Executive Directorate, that is to be submitted by the Executive Director through the Secretary-General, as provided in paragraph 4 of resolution 1535 (2004);

(ii) Continue to circulate the States assistance matrix on a monthly basis, to identify assistance needs and offers;

(iii) Further develop strengthening cooperation between the Counter-Terrorism Committee and the Committee established under Security Council resolution 1267 (1999) concerning Al-Qaida and the Taliban;

(iv) Complete the review of 30 further reports;

(v) Continue to work on countries' assessments of assistance needs that can be shared with interested donor States and organizations, with the prior approval of the country concerned;

(vi) Begin the preparation in accordance with Security Council resolution 1535 (2004) of the first visit of the Counter-Terrorism Committee experts with the representatives of international organizations to one of the States with its consent in order to enhance the monitoring of the implementation of resolution 1373 (2001) and the direct dialogue with the country authorities to make clear its needs in particular technical assistance programmes.

- (b) By 30 September:
- (i) Complete the review of 25 further reports;

(ii) Begin with the League of Arab States the preparation of the fourth special meeting of the Counter-Terrorism Committee with international, regional and subregional organizations in Cairo;

(iii) The Chairman will have made a briefing to interested delegations about the Committee's work.

#### I. Implementation of resolution 1373 (2001)

3. The Committee and its subcommittees will continue to review the reports submitted by States pursuant to paragraph 6 of resolution 1373 (2001).

4. By 30 June 2004 the Committee had received 515 reports from States and others. They include 160 second reports from Member States and 2 from others, 116 third reports from Member States and 40 fourth reports from Member States. As indicated earlier, all States have submitted their first reports.

5. Nevertheless, it should also be noted that 71 States have missed the deadlines for submission of their respective reports. The Committee urges all States that have not submitted their reports on time to submit them as soon as possible, in fulfilment of the provisions of resolution 1373 (2001). The Committee remains ready to work with them to find a way to progress towards the common objective of combating terrorism in the terms established by resolution 1373 (2001). The Chairman of the Committee will continue to provide the Security Council with the list of States late in the submission of their reports. The list will be released to the Security Council every six months, at the time of the Chairman's report to the Security Council; it includes the States (if any) that have contacted the Committee and those that have asked for assistance.

6. In accordance with resolution 1456 (2003), the Committee will continue to report regularly on progress made by States regarding their obligation to report to the Security Council pursuant to paragraph 6 of resolution 1373 (2001).

7. Bearing in mind the call for all States to become parties as soon as possible to the relevant international conventions and protocols relating to terrorism contained in paragraph 3 (d) of Security Council resolution 1373 (2001) and paragraph 2 (a) of the declaration annexed to Security Council resolution 1456 (2003), the Committee will remain committed to ensuring that the largest possible number of States become parties to the 12 pertinent international conventions and protocols and incorporate that important body of international law into their domestic legislation.

### II. Work of the Committee

8. On 26 March 2004 the Security Council adopted resolution 1535 (2004), by which it endorsed the report on the revitalization of the Committee (S/2004/124). In accordance with the resolution the Counter-Terrorism Committee Executive Directorate was established and the Committee, in cooperation with the appointed Executive Director and the United Nations Secretariat, will work to make the new structure operational as soon as possible. The Committee will consider the organizational plan for the Counter-Terrorism Committee Executive Directorate that the Executive Director is to submit. The Chairman of the Committee will present the plan to the Security Council for its endorsement and further promotion of its implementation. At the same time the Committee will continue to operate effectively throughout the transitional period.

9. The Committee has agreed that it should strengthen and integrate its efforts in the facilitation of technical assistance and reinforcing coordination and cooperation with international, regional and subregional organizations as stated in its reports (S/2004/70 and S/2004/124). During this work programme the Committee will proceed with a thorough re-evaluation of its work in those areas, consistent with the report of the Chair of 14 November (S/2004/70) and the revitalization report (S/2004/124). In order that technical assistance becomes a priority in all areas of the Committee's work, and in preparation for the assumption of this function by the Counter-Terrorism Committee Executive Directorate, the Technical Assistance Team was integrated with the larger group of experts.

10. While pursuing a case-by-case approach in monitoring the implementation of resolution 1373 (2001), the Committee will bear in mind all international best practices, codes and standards that are relevant to the implementation of the resolution.

#### III. Technical assistance

11. The facilitation of the provision of technical assistance to countries in need will remain one of the Committee's priorities. The report of the Chair of 14 November is clear about the need to study and develop the means necessary to ensure that technical assistance receives the appropriate attention from the Committee and the Security Council.

12. The Committee has developed the Directory of Counter-Terrorism Information and Sources of Assistance, which can be consulted on its web site, at http://www.un.org/Docs/sc/committees/1373/ctc\_da/index.html. The Directory is designed to be a source of information on counter-terrorism-related best practices, model laws and available assistance programmes. The Committee encourages all States seeking assistance or guidance in the matters covered by resolution 1373 (2001) to use this online information tool.

13. The Committee and its experts are ready, wherever possible, to facilitate the provision of assistance programmes to States in order to further the implementation of resolution 1373 (2001).

14. One of the priority areas of the activity of the Committee will remain the work on countries' assessments of assistance needs. It will be necessary to start elaborating the procedures regulating the sharing of such information between the Committee and the interested donor States and organizations.

15. As provided by Security Council resolution 1535 (2004), the Committee will start to prepare the first visit of the Counter-Terrorism Committee experts and the representatives of international organizations to one of the States in order to enhance the monitoring of the implementation of resolution 1373 (2001) and the direct dialogue with the country authorities to make clear its needs in particular technical assistance programmes.

#### IV. Transparency in the work of the Committee

16. Transparency will continue to be a hallmark of the work of the Committee.

17. The Committee will continue to provide information on its activities on a regular basis, including briefings of interested delegations by the Chairman. The next briefing will be held before the end of September.

18. The Committee has an informative web site (http://www.un.org/sc/ctc) that has become an essential source of information on all aspects of the implementation of resolution 1373 (2001).

19. The Committee, through its Chairman, the Executive Director and, where appropriate, the Committee's experts, will continue to maintain close relations with organizations and programmes of the United Nations system on aspects relevant to international counter-terrorism efforts, within the scope of the mandate contained in resolution 1373 (2001). Special attention will be paid to strengthening cooperation between the Counter-Terrorism Committee and the Committee established pursuant

to resolution 1267 (1999) concerning Al-Qaida and the Taliban, as well as the new Committee established under resolution 1540 (2004) on prevention of proliferation of nuclear, chemical and biological weapons.

21. The Committee has updated its web site as a source of detailed information on all issues related to resolution 1373 (2001). The Committee will maintain a matrix of technical assistance programmes by international, regional and subregional organizations. The Committee will continue to encourage all relevant organizations to contact it on a regular basis to ensure that the information provided in the new matrix is both accurate and useful for Member States seeking technical assistance. The Committee also encourages organizations to continue to submit information on international best practices, codes and standards relevant to the implementation of resolution 1373 (2001) and on any modes of assistance and guidance in implementing those best practices, codes and standards.

# V. Cooperation between the Committee and international, regional and subregional organizations

22. The Committee has continued to expand its contacts and cooperation with international, regional and subregional organizations as outlined in the action plan agreed following the special meeting of the Committee held on 6 March 2003. The Committee has accepted the proposal of the League of Arab States to host the fourth special meeting of the Counter-Terrorism Committee with the international, regional and subregional organizations in Cairo later this year. Following the approach agreed by the Committee it will start with the League of Arab States the preparation of the meeting.

23. The Committee, through its Chairman, the Executive Director and, where appropriate, the Committee's experts, will continue to establish contacts with organizations outside the United Nations system by attending regional meetings and conferences.

#### VI. Future work of the Committee

24. The Committee, including through the Chair, will work closely with the Executive Director of the Counter-Terrorism Committee Executive Directorate in order to contribute to his success in the implementation of the provisions of resolution 1535 (2004) and the recommendations in the Committee's report (S/2004/124).
