## Replies by the Government of the Republic of Kazakhstan to the questions addressed by the Security Council Committee established pursuant to resolution 1540 (2004)

In response to the letter dated 28 September 2005 from the Chairman of the Security Council Committee established pursuant to resolution 1540 (2004), the Government of the Republic of Kazakhstan has the honour to submit the following information, consisting of replies to the Committee's questions and the matrix (see enclosure).

The Government has no objection to the inclusion in the matrix of official data previously contained on the website of the International Atomic Energy Agency (IAEA).

#### Question

National legislation or other legal measures that the Government of the Republic of Kazakhstan has implemented or intends to implement to prohibit any non-State actors to manufacture, acquire, possess, develop, transport, transfer or use nuclear, chemical or biological weapons and their means of delivery, as well as attempts to engage in any of the foregoing activities, participate in them as an accomplice, assist or finance them.

#### Reply

One piece of domestic legislation regulating the above-mentioned activities is the Act "On nuclear energy use" of 14 April 1997.

In addition, the Criminal Code provides for penalties for the manufacture, acquisition or sale of weapons of mass destruction of any kind (arts. 158, 159 and 161).

With a view to prohibiting non-State actors from manufacturing, acquiring, possessing, developing, transporting, transferring or using nuclear, chemical or biological weapons and their means of delivery or engaging in any of the foregoing activities, participating in them as an accomplice or financing them, the Republic of Kazakhstan has acceded to a number of multilateral international agreements, the most important of which in this context are the Treaty on Cooperation among the States Members of the Commonwealth of Independent States (CIS) in Combating Terrorism, the International Convention for the Suppression of Terrorist Bombings and the Shanghai Convention on Combating Terrorism, Separatism and Extremism.

#### Question

Laws and regulations as well as law enforcement efforts that the Government of the Republic of Kazakhstan has taken or intends to take:

(a) To develop and maintain appropriate national measures to account for, secure and physically protect nuclear, chemical and biological weapons and their means of delivery, including related materials.

#### Reply

Government Decision No. 769 "On the organization of State accounting and control systems for nuclear materials and sources of ionizing radiation", of 22 July 2005:

Act No. 93-I "On nuclear energy use", of 14 April 1997, as amended by Act No. 13-III of 20 December 2004;

The Government of the Republic of Kazakhstan has also adopted the Act "On accession by the Republic of Kazakhstan to the Convention on the Physical Protection of Nuclear Material" of 22 December 2004. Ratification of the Convention is currently delayed owing to the introduction of corrections to the text of the Convention at the forty-ninth session of IAEA in 2005.

On 22 June 1993, the Government adopted Decision No. 525-23 "On the establishment of special agencies of the Ministry of the Interior of the Republic of Kazakhstan and special units of Ministry of the Interior forces of the Republic of Kazakhstan", under which such agencies and units would be required to take the necessary measures to provide operational servicing, guarding and physical protection of restricted, highly secure and protected premises or areas.

The establishment of special police agencies and special units of Ministry of the Interior forces has been instrumental in preventing dangerous incidents or theft of equipment or components from nuclear premises located in the territory of Kazakhstan.

Supplementary measures to ensure the security of restricted premises are currently being implemented.

#### Question

(b) To develop and maintain appropriate national border controls to detect, deter, prevent and combat the illicit trafficking and brokering of nuclear, chemical, biological weapons and their means of delivery, including related materials.

#### Reply

National border controls over nuclear, chemical and biological weapons and their means of delivery, including related materials, are exercised by two departments in Kazakhstan: the Border Control Committee of the Ministry of Finance (Decree of the President of the Republic of Kazakhstan No. 1449 "On measures for the further improvement of the State administration system of the Republic of Kazakhstan", of 29 September 2004) and the Border Service of the National Security Committee.

The basic legislation is Act No. 9-I "On export controls", of 18 June 1996, and the Customs Code.

Article 19, paragraph 12, of the Customs Code states: "The customs bodies shall: ... conduct radiation controls at entry points for goods and vehicles across the State (customs) border of the Republic of Kazakhstan".

#### Question

(c) To review and maintain appropriate national export and trans-shipment controls over nuclear, chemical and biological weapons and their means of delivery, including related materials.

#### Reply

Government Decision No. 1143 "Specific issues relating to the transit of products subject to export controls", of 11 August 1999;

Act No. 9-I "On export controls", of 18 June 1996;

Government Decision No. 1282 "On approval of the schedule of products subject to export controls in the Republic of Kazakhstan", of 18 August 2000.

#### Question

Steps that the Government of the Republic of Kazakhstan has taken or plans to take in establishing and enforcing appropriate criminal or civil penalties for violations of such export control laws and regulations.

#### Reply

Article 158 of the Criminal Code, "Manufacture or distribution of weapons of mass destruction" provides for a penalty in the form of imprisonment for 5 to 10 years for the manufacture, acquisition or sale of chemical, biological or other forms of weapons of mass destruction prohibited by an international agreement to which the Republic of Kazakhstan is a party.

Article 159 of the Criminal Code, "Use of prohibited means of warfare", provides for a penalty in the form of imprisonment for 10 to 20 years or the death penalty or life imprisonment for using weapons of mass destruction prohibited under international agreements to which the Republic of Kazakhstan is party.

Article 161 of the Criminal Code, "Ecocide", provides for a penalty in the form of imprisonment for 10 to 15 years for mass destruction of plant or animal life, poisoning of the atmosphere or terrestrial or water resources and other acts causing or capable of causing environmental disaster.
