**Organization of the forty-seventh session of the

1. Representatives whose Governments wish to host the forty-seventh or subsequent sessions of the Subcommission on Illicit Drug Traffic and Related Matters in the Near and Middle East are invited to inform the Subcommission. That information will be brought to the attention of the Commission on Narcotic Drugs at its fifty-fifth session, in 2012.
2. The draft provisional agenda for the forty-seventh session of the Subcommission<sup>1</sup> is annexed to the present note.
3. Item 4 of the provisional agenda for the forty-seventh session of the Subcommission will be devoted to the examination of the status of implementation of the recommendations adopted by the Subcommission at its forty-fifth session. In order to facilitate reporting, a questionnaire concerning action taken by Governments to implement those recommendations will be transmitted prior to the forty-seventh session.
4. At the fortieth session of the Commission on Narcotic Drugs, the view was expressed that the recommendations adopted by the meetings of the subsidiary bodies of the Commission would remain meaningless if Governments did not take action, including, where necessary, the enactment of domestic legislation, to implement those recommendations.

5. States members of the Subcommittee are urged to conscientiously and promptly implement those recommendations, so that an effective evaluation of their progress can be made.
6. It would be highly desirable for the Subcommittee at its forty-sixth session to identify the topics that would be most appropriate for consideration by working groups at its forty-seventh session. Alternatively, the Subcommittee may decide to request the Secretariat to informally consult member States of the region with a view to identifying topics for consideration by working groups.
