## **I. Introduction**

### **Opening and duration of the session**

1. The second session of the Preparatory Committee for the High-level International Intergovernmental Event on Financing for Development was held in New York from 12 to 23 February 2001, in accordance with paragraph 2 of General Assembly resolution 55/213. The Committee held \_\_\_ meetings (1st to \_\_\_).

2. The Preparatory Committee also held a number of informal meetings in which it engaged in interactive dialogue reviewing the inputs to the substantive preparatory process and the high-level international intergovernmental event on financing for development from the perspective of the main headings of the preliminary agenda, as annexed to decision 1/1 contained in the report of the Preparatory Committee on its organizational, resumed organizational, first and resumed first sessions.<sup>1</sup>

3. At its 1st meeting, on 12 February, the President of the General Assembly addressed the Preparatory Committee.

4. At the same meeting, the Secretary-General addressed the Preparatory Committee.

5. Also at the 1st meeting, Mats Karlsson, Vice-President for External Affairs and United Nations Affairs of the World Bank; Rheinhard Munzberg, Special Representative of the International Monetary Fund to the United Nations; and Patrick Low, Director of the Office of the Director-General of the World Trade Organization, also addressed the Preparatory Committee.

6. At its 1st meeting, on 12 February, the Committee adopted the agenda for its second session, as contained in document A/AC.257/20. The agenda was as follows:
