Annotations to the agenda

1. Adoption of the agenda and organization of work

The Committee, at its second session (Geneva, 13-24 September 1993), approved the provisional agenda for the second session, as contained in decision 2/5 of the Report of the Second Session (A/48/226/Add.1).

The provisional agenda for the third meeting is submitted for adoption.

The Plenary will hear statements from ministerial representatives of INCD Member countries, Heads of UN Agencies and the Chairman of the Committee. After these statements, the Executive Secretary of the INCD Secretariat will introduce the Secretariat document A/AC.241/15.

The provisional work programme (Annex I) provides further details on the organization of work to be undertaken by the Committee. The proposed schedule for consideration of each sub-section in the two Working Groups mirrors the order of sub-sections in document A/AC.241/15. Consideration of the Regional Instrument for Africa in Working Group II will be dealt with on the basis of a conference room paper that will be circulated early in the session.

The Committee might have to consider an additional list/s of Non-Governmental Organizations (NGOs) recommended for accreditation for the negotiating process of the Convention.

2. Elaboration of an international convention to combat desertification in countries experiencing serious drought and/or desertification, particularly in Africa

The Committee will have before it the document prepared by the Secretariat (A/AC.241/15), which integrates proposals made by Governments in document A/AC.241/12 during and after the second session into a draft convention for consideration by the Committee. The Committee may wish to give further guidance to the Secretariat on the elaboration of the draft of the convention.

3. Review of the situation as regards extrabudgetary funds

(a) Special Voluntary Fund to support the participation of developing countries affected by drought and desertification, particularly in the least developed countries

(b) Trust Fund for the negotiating process

The Committee will have before it the document (A/AC.241/16) submitted by the Secretariat indicating the present status of the two funds.

4. Adoption of the provisional agenda for the fourth session and organization of work for the final stages of negotiations

The Committee will have before it a note by the Secretariat on the draft provisional agenda for its fourth session.

5. Adoption of the report of the Committee on its third session

The Committee will adopt a report on its third session.
