REVIEW OF THE SITUATION AS REGARDS EXTRABUDGETARY FUNDS

Note by the Secretariat

I. SPECIAL VOLUNTARY FUND TO SUPPORT THE PARTICIPATION OF DEVELOPING COUNTRIES AFFECTED BY DROUGHT AND DESERTIFICATION

1. By its Resolution 47/188 of 22 December 1992, the General Assembly established a Special Voluntary Fund, administered by the head of the ad hoc secretariat under the authority of the Secretary General of the United Nations, to assist developing countries affected by desertification and drought, in particular the least developed countries, to participate fully and effectively in the negotiating process.
2. During the past sessions of the negotiating Committee several countries indicated their contributions to the Fund, and others indicated their intention to contribute as soon as their internal procedures would permit. The Chairman of the Committee urged Governments in a position to do so but which have not yet done so to contribute to the Special Voluntary Fund according to their possibilities at an early date.
3. The current status of pledges and receipts is shown in the following table:

4. From contributions, 13 percent overhead costs are retained and an operating reserve (15%) maintained to cover eventual final obligations. Consequently, of total contributions amounting to US\$ 1,816,766, an amount of US\$ 1,437,342 was available to meet travel and DSA costs of participants from countries eligible for funding.
5. These resources have been used in connection with the first, second, third and fourth substantive sessions of the Committee for which total expenditures amounted to US\$ 1,216,828. In extending assistance to the countries experiencing serious drought and/or desertification, due attention has been paid to the particular situation of the countries concerned, as well as precedents established recently by negotiating processes on Climate Change and Biodiversity.
6. In the light of the above considerations the Secretariat issued travel authorizations for the first and second sessions, to one delegate from about 70 countries including most LDCs and a significant number of developing countries affected by desertification and drought as specified in paragraph 15 of General Assembly's resolution 47/188. For the third session, funds were available to cover only 58 countries. As indicated in document A/AC.241/20, a total additional amount of US\$ 520,705 was pledged during the third session for the Special Voluntary Fund. This amount constituted the pledges made by France, Ireland and Japan. Since then Greece has specified that its contribution for US\$ 10,000 should be split as follows: US\$ 5,000 for the Special Voluntary Fund and US\$ 5,000 for the Trust Fund.
7. As indicated in document A/AC.241/20/Add.1, issued during the Fourth session, the Secretariat received on 19 March 1994 an allotment for US\$ 266,800 issued on the basis of the Japanese and Irish contributions. This amount represented the Japanese and Irish contributions of US\$ 370,000, after deduction of 13% overhead costs and 15% operating reserve.
8. For the Fourth Session, the Secretariat covered the participation of one delegate from 27 Least Developed Countries which have sought assistance. This represents a commitment of approximately US\$ 150,000. An estimated balance of US\$ 150,000 was still available to be used in connection with travel of participants for the Fifth INCD Session.
9. During the Fourth Session, Austria, Benin and Portugal made new pledges. As indicated in the table above, the delegation of Austria pledged US\$ 10,000, the delegation of Benin pledged US\$ 1,000 and the delegation of Portugal pledged US\$ 25,000.
10. For the Fifth session, the Secretariat received on 25 May an allotment for US\$ 295,000 issued on the basis of the French, Italian and Greek contributions as well as on the use of the operating reserve under the Trust Fund.
11. During the Fifth session, the Secretariat will distribute an addendum to this document which will indicate the list of countries concerned whose participation was financed through the Special Voluntary Fund.

12. Should an arrangement be adopted for the sixth session of the INCED in order to ensure funding of one delegate from some 70 countries and Bureau members, the total amount of additional contributions required for this Fund would amount to an estimated US\$ 400,000. This estimate is subject to confirmation based on the final decision on the venue of the Sixth session. In the light of this situation, the Committee may wish to call upon potential donors to make the necessary contributions to the Special Voluntary Fund.

13. The Committee may also wish to give further guidance to the Executive Secretary concerning the adequacy of the arrangements made in respect of the use of the Fund for participation in the substantive sessions held to-date and concerning its future use.

II. TRUST FUND FOR THE NEGOTIATING PROCESS

14. The General Assembly, by its resolution 47/188, paragraph 13 decided that "the negotiating process shall be funded through existing United Nations budgetary resources, without negatively affecting its programmed activities, and through voluntary contributions to a Trust Fund established specifically for that purpose for the duration of the negotiations..." It also urged "governments, regional economic integration organizations and other interested organizations, including non governmental organizations, to contribute generously to the Trust Fund."

15. The current situation concerning pledges and contributions is shown in the following table. A number of countries which had pledged have made contributions while Germany has pledged without specifying the amount of its envisaged contributions. The Secretariat has established contacts with other countries as well as Agencies of the United Nations system and intergovernmental organizations to enlist their support. UNDP has announced additional contributions in support of the negotiating process, including an amount of US\$100,000 already put at the disposal of the INCED Secretariat by UNSO. UNEP has increased its support from the level reported to the second session, including an additional pledge of US\$ 100,000 earmarked for the participation of NGOs and support to the Secretariat for the preparation of other Regional Annexes. Furthermore, the Government of Switzerland is in the process of finalizing with the Secretariat the modalities of a new contribution of US\$ 50,000 earmarked for the participation of NGOs. Finally, during the fourth session Greece has made a new pledge for US\$ 5,000.

16. At the time of the adoption of resolution 47/188, the General Assembly was informed that estimated costs in 1993 and 1994 for staff and conference servicing in connection with the work of the Committee would be absorbed in the United Nations Programme Budget for those years. Three professional level posts and four general service posts were provided from the regular budget for 1993, and two senior posts were loaned from the resources of the Department of Administration and Management. For 1994, the two senior level posts have been incorporated into the regular budget of INCD, and non-staff costs have been provided for at a similar level as that for 1993. The Fund was established for the purpose of supplementing the resources to be provided by the regular budget; these additional resources were required to enable the Secretariat to undertake activities designed to provide the necessary support to the negotiating process including preparatory substantive work at the national, regional and global levels. As summarized in the Aide Memoire attached to the Secretary General's note verbale, the Secretariat estimated the extrabudgetary resources needed at US\$3.2 million, to enable it to carry out the activities identified.

17. As noted in paragraph 4, overhead costs (13%) are retained and an operating reserve (15%) maintained out of contributions, the latter to ensure the availability of resources to meet eventual final commitments. Thus, from total contributions of US\$ 2,431,125 an amount of US\$ 1,750,411 was available to meet on-going expenses. At 31 March 1994, expenditures from the Fund amounted to US\$ 1,117,950. Commitments remaining for staff indicated in paragraph 14 below amount to a further estimated cost of US\$ 350,000.

18. As agreed with contributing countries, US, Canada, Switzerland, three staff members have been recruited for one year using the resources available in the Fund. France has made a contribution which has enabled the recruitment of an Associate Expert from a developing country for one year. The extra-budgetary contributions used for the recruitment of staff members by the Secretariat as well as the staff members concerned are listed under the following table:

19. Moreover, a staff member of the World Meteorological Organization (WMO) has been seconded to the Secretariat for the duration of the negotiations. FAO has also assigned an Environmental Lawyer to assist the Secretariat on a part-time basis. The Secretariat has also been in contact with Italy and Spain to obtain the secondment of civil servants or the financing of experts. The Government of Italy has recently confirmed its willingness to second a JPO to the Secretariat. The Secretariat has also proceeded with the recruitment of an Associate Legal Adviser from a Developing Country on the basis of a contribution from the Swedish Government. Other staff members, both professional and general service, may be made available from the United Nations secretariat, other institutions or will be recruited as temporary staff financed from the Fund.

20. In the framework of the negotiating process the Secretariat has also assisted a number of developing countries in their national, sub-regional and regional preparatory activities. The countries concerned by those preparatory activities and the resources allocated, are shown in the following table. These activities are being financed through the INCD Trust Fund and bilateral arrangements concluded between the recipient country and a donor country or Agency. This has been the case for the following countries: Germany, Sweden and the following United Nations Programmes: UNSO, UNDP, UNCDF. The Secretariat is in contact with other countries and international Agencies and organizations in order to obtain additional support for the preparatory activities. In this regard, the regional offices of UNDP are studying the possibility of extending such a support through the UNDP offices in the recipient countries. Some of these offices have already earmarked resources for this purpose.

21. The Secretariat is also financing or co-financing special studies being undertaken by the International Panel of Experts on Desertification in cooperation with intergovernmental and non-governmental organizations such as UNIDO and with the assistance of other Experts in order to draw to the maximum on expertise available in government, international

organizations and the private sector. These studies have been identified by the five sub-groups of IPED and are related to the following areas: (1) the linkages between drought/desertification and the global climate system/climate change, (2) the conservation and utilization of biodiversity in dryland areas, (3) the effect of drought and desertification on ground and surface water resources, (4) the development and utilization of alternative renewable energy resources in areas affected by drought and desertification, and (5) the economic and social consequences of drought and desertification. As shown below, some of these studies are already being carried out. Additional resources will be necessary to undertake the remaining studies and usefully supplement IPED resources. The following table shows the special studies being carried out as well as other activities undertaken by the Secretariat in the fulfilment of its mandate, including support to NGOs both in terms of participation to the INCD sessions as well as preparatory activities:
