#### I. INTRODUCTION

- 1. By its Resolution 47/188 of 22 December 1992, the General Assembly established a Special Voluntary Fund and a Trust Fund, both administered by the Head of the Ad Hoc Secretariat under the authority of the Secretary-General of the United Nations (UN). These funds were established with a view:
  - (a) to assist developing countries affected by desertification and drought, in particular the least developed countries, to participate fully and effectively in the negotiation process; and
  - (b) to supplement limited regular budget resources in financing the negotiating process.
- 2. Subsequently, Resolution 49/234 of 23 December 1994 adopted by the 49th Session of the General Assembly extended the mandate of these funds for the interim period. It also amended the terms of reference of the INCD Trust Fund to take into consideration the recommendations of the Committee regarding the participation of NGOs in its sessions.
- 3. This document reviews pledges and contributions made to both INCD funds. As the Committee requested at its Sixth Session, it also summarizes the Secretariat's utilization of UN regular budget resources during the biennium 1994-1995

#### II. REGULAR BUDGET RESOURCES

- 4. Regular budget resources are used essentially to cover expenses related to staff, travel, communications and consultancies, as well as standard operating expenses such as maintenance and supplies. Appendix A shows the Secretariat's total regular budget allotment for the biennium 1994-1995 by object of expenditure. Appendix B shows regular budget expenditures during the biennium through May 1995.
- 5. Various expenditures on staff covered the services of the 5 professional and 4 general service posts carried under the Regular Budget (1 D-2, 1 D-1, 1 P-5, 1 P-4, 1 P-3 and 4 GS).
- 6. For the biennium 1994-1995 an allotment of US\$ 236,900 was issued for official travel of staff. The bulk of this allotment was used for the participation of the Secretariat staff in the Third, Fifth and Sixth sessions of the INCD, held respectively in New York, Paris and New York.
- 7. Consultancy resources were mainly used for meetings and services of the International Panel of Experts on Desertification. Consultants were also employed in 1995 for the organization and promotion of awareness and information campaigns as well as for ad hoc activities for which the relevant expertise was not available within the Secretariat.
- 8. In this regard, the Secretariat launched, with the assistance of "Earth Action", an experienced International NGO, media and parliamentarian campaigns. The cost of these two campaigns was roughly US\$ 54,000. They took place prior to the World Day to Combat Desertification and Drought, targeting journalists and parliamentarians worldwide to draw their attention to the problem of desertification and to the innovative approach adopted by the Convention.

## III. TRUST FUND

9. The General Assembly, by its Resolution 47/188, paragraph 13, decided that the "negotiating process shall be funded through existing UN Budgetary Resources, without negatively affecting its programmed activities, and through voluntary contributions to a Trust Fund established specifically to that purpose for the duration of the negotiations." It also urged "governments, and regional economic integration organizations to contribute generously to the Trust Fund."

- 10. The situation concerning pledges and contributions to the Trust Fund as of 30 June 1995 is shown in Appendix C.
- 11. As of May 1995, recorded expenditures from the Fund for the biennium 1994-1995 amounted to US\$ 2,031,295. After provision for support costs and operating reserve, the Fund is virtually exhausted. Trust Fund expenditures incurred in support of Secretariat activities are summarized in Appendix D.
- 12. The Secretariat has established contacts and concluded agreements with several countries, as well as with agencies of the United Nations system and intergovernmental organizations, to enlist their support for ongoing extrabudgetary activities in the following four fields, which the sections below summarize.
  - (a) Organizations of national awareness seminars
  - (b) Subregional consultation processes
  - (c) Public information
  - (d) Grass-roots implementation of the Convention

## Organization of national awareness seminars

- 13. The Secretariat has facilitated the launching of national awareness seminars concerning the implementation of the Convention and the Resolution on Urgent Action for Africa. By promoting contacts between the various partners working at the national level, these seminars will facilitate the integration into the implementation process of institutions or organizations that may not yet be involved in it and encourage them to give it greater priority. As a presentation and exchange fora, these seminars can also provide the opportunity to bring together important actors in civil society, as well as field representatives of donor agencies.
- 14. Each seminar can be organized at a cost of roughly US\$ 8,000. In this respect, the Government of Switzerland has contributed US\$ 183,500 for the organization of national seminars in Africa. The Swiss contribution has allowed the launching of the seminars in a first group of twenty African countries. Based on a schedule agreed individually with each concerned country, and with the active support of relevant subregional organizations, as of 32 July, seminars would have been organized in the following countries:

April	Cape Verde, Eritrea
May	Burkina Faso, Chad, Egypt, Mauritania
June	Benin, Ethiopia, Morocco, Niger, Senegal, Zambia
July	Cote d'Ivoire, Sudan, Uganda

15. The Secretariat is discussing the modalities of financing further awareness seminars in Africa with other interested donor countries. If sufficient resources are available, the objective would be to hold such seminars in all countries that request them, in Africa as well as in other regions.

# Subregional consultation processes

16. The subregional consultation processes take the form of seminars organized by a relevant subregional organization acting as coordinating agency with the support of the Secretariat. They bring together representatives of the governments of a given subregion, donor countries and relevant intergovernmental and non-governmental organizations (NGOs) to discuss the implementation in the subregion of the Convention and of the INCD Resolution on Urgent Action in Africa.

They are organized in conjunction with a workshop that gathers media professionals of the same subregion.

- 17. These seminars and workshops will provide all parties involved with an opportunity to increase their level of knowledge about the Convention and to formulate a clear and common view of their obligations and respective roles. These fora will also allow participants to be informed of the latest developments regarding the Convention and their impact on activities in the subregion.
- 18. The terms of reference and goals of these seminars are presented in detail in a document prepared by the Secretariat. This document has already been sent to some donor countries and is available upon request.
- 19. The Government of Denmark has contributed US\$ 112,900 to the Trust Fund to help organize subregional consultations in East Africa and the Government of Norway US\$ 142,000 for those in Southern Africa. The Government of Canada has provided financing directly to Permanent Interstate Committee for Drought Control in the Sahel (CILSS) for the West African consultations.

#### Public information

- 20. The Secretariat, which faces an increasing demand for information, has launched the preliminary phase of an information programme. It is centered at this stage on the production and distribution of materials that facilitate implementation of the Convention. These materials will deliver to several different audiences unbiased and carefully balanced information on the various dimensions of the Convention in easily accessible language. The target audiences include national policy makers, development practitioners, economic and business leaders, NGOs, journalists and the public in general.
- 21. The aim is to create materials that are unique: they will have the credibility and the authority of the United Nations, they will be created and reviewed by leading experts in all relevant disciplines and they will be attractively packaged, well written and concise. These materials comprise the following, some of which will be packaged in a Convention kit.
  - (a) The Convention text in an attractive booklet format, with an accompanying explanatory leaflet, in English, French, Arabic, Spanish and Portuguese
  - (b) A simplified version of the Convention in a booklet entitled "Down to Earth", initially in English, French, Spanish and Arabic, but later in other languages including the languages most widely spoken in affected areas
  - (c) Ten fact sheets covering the main aspects of the Convention and providing policy makers and other target audiences with greater access to high quality information, initially in French, English and Spanish
  - (d) A slide presentation to assist in promotional activities for the ratification and implementation of the Convention  ${\sf Convention}$
  - (e) A "home page" on the Internet World Wide Web containing INCD documents and other materials related to the Convention
- 22. The official launching of the booklets coincided with the first celebration of the World Day to Combat Desertification and Drought. On that occasion, the Secretariat also organized, in collaboration with the International Academy of the Environment, a policy dialogue that gathered 25 experts from all regions of the world to discuss the theme "Combatting Desertification Through Alternative Energy Strategies: A Focus on Africa."
- 23. In initiating its public information programme, the Secretariat utilized significant assistance form the governments of Switzerland and Denmark, as well

as from the International Fund for Agricultural Development (IFAD) and the United Nations Environment Programme (UNEP). Denmark contributed through the Trust Fund for the production of the Convention Kit and Convention Booklet. Switzerland, IFAD and UNEP contributed directly to the Center for Our Common Future, a Genevabased international NGO, which supervised the writing, editing and production of the simplified version of the Convention. UNEP's Information Unit for Conventions also supervised and co-financed the initial production of the Convention booklet and explanatory leaflet in English, French and Arabic. It also made possible the initiation of a World Wide Web home page on desertification.

## Grass-roots implementation of the Convention

- 24. IFAD has agreed to contribute US\$ 400,000 to the INCD Trust Fund. As indicated below, part of this contribution will be used for the recruitment of one general service staff member. The balance is earmarked for facilitation and coordination of activities related to the involvement of affected communities in the implementation of the Convention, as well as for promotion of initiatives for dissemination of information on its implementation. In addition, the Secretariat is in contact with several governments and organizations to obtain financing for NGO participation in INCD sessions.
- 25. In light of the discussion above and given the current status of the Fund, the INCD may wish to call upon potential donors to contribute to the Trust Fund and give further guidance to the Executive Secretary concerning its future use.

#### IV. SPECIAL VOLUNTARY FUND

- 26. The current status of pledges and receipts to the Special Voluntary Fund is shown in Appendix E. After provision for support costs and operating reserve, a balance of approximately US\$ 255,718 remains available in that Fund. In allocating the remaining funds, priority will continue to be given to least developed countries affected by drought and desertification. The Secretariat will circulate, during the session, as an addendum to this document, a list of countries whose participation has been financed through the Fund.
- 27. Two budget scenarios are possible for the Special Voluntary Fund, depending on the level of contributions. The first would fund the travel of one representative from approximately seventy affected developing countries to two INCD meetings per year at an annual cost of US\$900,000. The second, assuming insufficient contribution levels, would cover only one representative from least developed affected countries at an annual cost of US\$550,000.
- 28. In light of the above and given the current status of the Fund, the INCD may wish to call upon potential donors to contribute to the Special Voluntary Fund and give further guidance to the Executive Secretary concerning its future use.

## V. SECRETARIAT STAFFING SITUATION

- 29. The staffing situation of the Secretariat, as of May 1995, is shown in Appendix F. It does not include consultants or temporary staff hired to assist the Secretariat during sessions of the Committee.
- 30. Contractual arrangements relating to the positions covered by the Trust Fund continue to be of a short-term nature owing to the uncertainty of funding. The extension of the contracts of the six staff members currently financed from extrabudgetary resources depends on the timely receipt of contributions.
- 31. The following information is of relevance to the staffing situation of the Secretariat:
  - (a) FAO has extended the services of an Environmental Lawyer to assist the Secretariat on a part-time basis.

- (b) IFAD has approved a contribution of US\$ 400,000 to the Trust Fund. Part of this contribution will be earmarked for the recruitment of a General service staff member.
- (c) UNEP has earmarked US\$ 50,000 of its most recent contribution to the Trust Fund for general temporary assistance in the Secretariat.
- (d) Italy has recently confirmed its willingness to second a junior professional officer to the Secretariat, who will work for one year in the field of media and communications.
- (e) One temporary staff member has been recruited using Trust Fund resources to assist professional staff members in their daily work.
- 32. Administrative support to the Secretariat is provided by a Geneva based administrative unit of the Department for Policy Coordination and Sustainable Development (DPCSD) consisting of one professional officer and two general service staff. The unit, which functions within the framework of the Executive Office of the Department located at United Nations Headquarters, New York, also serves the Interim Secretariat of the Convention on Climate Change. The recruitment of the head of this office was completed in May 1995.
- 33. The workload of this administrative unit in 1995 will tax its capacity, notably in relation to financial monitoring and support for travel arrangements before and during the sessions of the Committee. This problem is being addressed in consultation with DPCSD and with central administrative services at the United Nations Headquarters.
