Annotations to the agenda

1. Adoption of the agenda and organization of work

In accordance with the decision 10/14 of the Intergovernmental Negotiating Committee for Desertification (INCD), taken at the first part of its tenth session, the resumed tenth session will take place at the United Nations Office at Geneva on 18-22 August 1997. The agenda remains the same as that adopted on 6 January 1997 for the first part of the tenth session. A tentative schedule of work is provided in Annex II.

Annex I lists the documentation available for the resumed tenth session, including documents being prepared for the first session of the Conference of the Parties (COP 1). In addition to normal distribution, all documents can be accessed on the Secretariat's world web site at the following address on the internet: http://www.unccd.ch

A meeting of the Bureau, joined by the chairs of regional and other interest groups, will be held at 10:00~A.M. on 18~August~1997. The session will then open at 3:00~P.M. on 18~August. At that time, there will be statements by the Chairman of the Committee and the Executive Secretary, who will present an overview of issues before the session and introduce documentation. Other opening statements will follow as well as reports on the status of ratification and accession. Under this agenda item, the Committee will also review document A/AC.241/L.5/Add.3 and A/AC.241/9/Add.14 on the accreditation of intergovernmental and non-governmental organizations.

The opening plenary will continue on the morning of 19 August, followed by meetings of regional and other interest groups for the remainder of that day. Annex II gives the tentative schedule of plenary meetings for the rest of the session.

2. <u>Preparation for the Conference of the Parties</u>

Under this item, the Committee may wish to review the logistical aspects of the COP 1, hear a report from the Executive Secretary on parallel events being organized and consider the handling of outstanding substantive issues, particularly the following:

Designation of a Permanent Secretariat and arrangements for its functioning: physical location — the Chairman of the Committee will report on any discussions in the contact group established by INCD decision 9/2. On that basis, the Committee can discuss the modalities of taking a decision on this issue at the COP 1 in accordance with paragraph 2 of Article 23 of the Convention.

Identification of an organization to house the Global Mechanism — the Committee may wish to hold a preliminary discussion of the revised offers of the International Fund for Agricultural Development (IFAD) and the United Nations Development Programme (UNDP) to host the Global Mechanism, contained in document ICCD/COP(1)/5, and other relevant information, and consider how to organize the discussion of this issue at the COP 1.

Programme and Budget — the Committee may undertake a preliminary review of the proposed programme and budget for the biennium 1998-1999 contained in documents ICCD/COP(1)/3, ICCD/COP(1)/3/Add.1 and ICCD/COP(1)/4 and consider how to organize the discussion of this item at COP 1.

Rules of Procedure - the Committee can consider how to deal with outstanding issues relating to the draft rules (document ICCD/COP(1)/2), particularly as they relate to the election of the Bureau for COP 1.

Committee on Science and Technology - the Committee will have available documents ICCD/COP(1)/CST/1, ICCD/COP(1)/CST/2, ICCD/COP(1)/CST/3, ICCD/COP(1)/CST/4 and ICCD/COP(1)/CST/5 prepared for the first session of the Committee on Science and Technology and, if available, ICCD/COP(1)/CST/2/Add.1 and ICCD/COP(1)/CST/3/Add.1. It may, in particular, wish to consider how to handle the discussion during COP 1 of the reports on bids on the survey and evaluation of existing networks as well as on benchmarks and indicators. It may also wish to express views on the provisional agenda and organisation of work (ICCD/COP(1)/CST/1).

3. <u>Special action: urgent action for Africa and actions taken in the Asian, Latin American and the Caribbean, and Northern Mediterranean regions</u>

The Plenary will consider how to organise the discussion at COP 1 on measures taken to implement the resolution on urgent measures for Africa, as well as actions taken in the Asian, Latin American and the Caribbean and Northern Mediterranean regions.

4. Status of signature and ratification of the Convention

The Executive Secretary will present a status report on this item. The Committee may wish to consider whether any further action is required to promote ratification and accession.

5. Review of the situation as regards extrabudgetary funds

The Committee will have before it document ICCD/COP(1)/4 on the situation as regards extrabudgetary funds, prepared for COP 1 by the Secretariat. The Committee may wish to discuss how to organise the discussion of this item at the Conference of the Parties in the context of overall consideration of the programme and budget for the biennium 1998-1999.

6. Adoption of the report of the resumed tenth session

The report of the first part of the tenth session is contained in document A/52/82. A draft report on the work of the resumed tenth session will be presented for consideration by the Committee, in accordance with established practice.
