ELECTION OF THE MEMBERS OF THE SUB-COMMISSION ON PREVENTION OF DISCRIMINATION AND PROTECTION OF MINORITIES

# Note by the Secretary-General

- 1. At its thirty-fourth session, the Commission on Human Rights, on 9 March 1978, elected 26 members to the Sub-Commission on Prevention of Discrimination and Protection of Minorities for a three-year term of office.  $\underline{1}$ /
- 2. As the term of office for the above-mentioned membership of the Sub-Commission has expired, the Commission is called upon to elect new members.
- 3. The procedure for the election of the members of the Sub-Commission is governed by the following decisions of the Commission and of the Economic and Social Council:
  - (i) At its first session (January and February 1947) the Commission decided:
    - "(a) that the Sub-Commission be ... selected by the Commission in consultation with the Secretary-General and subject to the consent of the Governments of which the persons are nationals;
    - "(b) that not more than one person be selected from any single  $\infty$ untry;" 2/
  - (ii) On 31 May 1968, the Economic and Social Council adopted resolution 1334 (XLIV), on the composition of the Sub-Commission, which reads as follows:

# "The Economic and Social Council,

"Moting resolution 9 (YMIV) of the Commission on Human Rights,

"Lesirous of having greater representation of the different regions, legal systems, cultures as well as equitable geographical representation in the membership of the Sub-Commission on Prevention of Discrimination and Protection of Minorities,

- "1. <u>Decides</u> to increase the membership of the Sub-Commission on Prevention of Discrimination and Protection of Minorities to twenty-six as from 1969;
- "2. Requests the Human Rights Commission at its twenty-fifth session to elect twenty-six members of the Sub-Commission from nominations of experts made by Member States of the United Nations on the following basis:

from the Afro-Asian group of States, 12 members;

from Western European and other States, 6 members;

from Latin American States, 5 members;

from Eastern European States, 3 members."

4. By decision 1978/21 of 5 May 1978, the Economic and Social Council decided that the 12 seats allocated to the Afro-Asian group in the Sub-Commission on Prevention of Discrimination and Protection of Minorities referred to in paragraph 2 of its resolution 1334 (XLIV) of 31 May 1968 should be sub-divided as follows:

African group of States: 7 seats

Asian group of States: 5 seats.

- 5. On 3 November 1980, the Secretary-General circulated a note verbale to Governments requesting them to submit to the Commission on Human Rights at its thirty-seventh session their nominations of experts for election to the Sub-Commission.
- 6. As at 8 January 1981, the Secretary-General had received nominations of candidates for election to membership of the Sub-Commission from the Governments of: Argentina, Bangladesh, Belgium, Colombia, Costa Rica, Egypt, France, Greece, India, Iraq, Italy, Mexico, Nicaragua, Norway, Pakistan, Panama, Romania, Syrian Arab Republic, Tunisia, Turkey, United Kingdom of Great Britain and Northern Ireland, United States of America, Yugoslavia and Zaire.
- 7. The Governments of Austria and Qatar indicated that they had no candidate to propose. Further communications and nominations of candidates received from Governments will be circulated as addenda to the present document.

# Annex I

#### BIOGRAPHICAL DATA

#### MR. JULIO CESAR AVILES ABURTO

(Nominated by the Government of Nicaragua)

Date of birth: 4 May 1931.

Place of birth: Jinotepe, Nicaragua.

Marital status: Married to Onelia Castillo de Avilés: they have six children.

# Studies:

Primary education: Jinotepe Public School and Municipal Institute.

Secondary education: Juan José Rodríguez National Institute and Ramírez Goyena National Institute at Managua. School-leaving certificate 1950.

University education: Graduated as lawyer and notary public from the University of León, Nicaragua, in 1957.

#### Career:

Engaged in professional activities in Managua, Nicaragua; he organized the defence committee for persons accused of political offences in view of the political persecution under the dictatorship.

- 1959. Arrested for political reasons and held in communicado for six months in Managua prisons because he had protested against the murder of university students by the Somoza dictatorship.
- 1960. Continued to defend persons accused of political offences.
- 1961. Appointed legal counsel by the Nicaraguan port workers! trade unions, which were endeavouring to achieve trade-union rights.
- 1964. Delegate to the Congress of Young Members of Latin American Democratic Parties, held in San José, Costa Rica.
- 1968. Appointed defence counsel at trials of various members of the Sandinista National Liberation Front.
- 1972. "Unofficial delegate" for Nicaragua to the Congress on Agrarian Reform and Colonization, spensored by FAO, ECLA and the Latin American Institute for Economic and Social Planning (ILPES).
- 1973. During the Managua earthquake, organized the emergency committee in Carazo to protect and assist victims.
- Co-founder of the Carazo Red Cross.

- 1974. Appointed President of the Carazo Red Cross, a post to which he was re-elected up to 1978.
- 1977. Founded and organized in Managua, in conjunction with humanitarian groups, the permanent commission for the defence of human rights.

Acted as National Legal Secretary.

1978. Organized in Carazo and other departments of the Republic of Nicaragua the regional commissions of the permanent commission for the defence of human rights.

September 1978. Persecuted by the Somoza dictatorship, he was successful in retaining his liberty thanks to arrival in Nicaragua of the Inter-American Commission on Human Rights (ICHR), with which he collaborated in investigations of human-rights violations in Nicaragua.

- 1979. Participant in the human rights seminar (implementation of the Pact of San José) sponsored by the Organization of American States, ICHR and the Inter-American Association of Jurists.
- April 1979. Because of his constant denunciations of disappearances of political dissidents and his defence of persons accused of political offences, he was arrested, imprisoned, held incommunicado for 30 days and, after being severely tortured and transferred from one prison to another around the country, released in Rivas, 110 kilometres from Managua, after a mock trial.
- May 1979. Hunted by the Somoza National Guard, he was forced to remain underground while assisting in the defence of human rights. When he could not be found, his wife was imprisoned, Nicaragua then being in a state of open war, and his entire family was persecuted.
- 1979. Fall of Somoza.
- 1980. Appointed national legal adviser to the Nicaraguan National Commission for the Promotion and Protection of Human Rights a body founded in conformity with United Nations resolutions and recommendations; and member of the commission's national executive committee.

September 1980. Assisted in the organization of ICHR's mission and investigation in Nicaragua.

October 1980. Appointed second vice-president of the Nicaraguan National Commission for the Promotion and Protection of Human Rights, a post he currently holds, and chairman of the Sub-Commission for the Defence of Public Liberties.

#### Mr. ANTONIO MARTINEZ BAEZ

(Nominated by the Government of Mexico)

Born on 18 July 1901 at Morelia, capital of the State of Michoacán, the son of Dr. Manuel Martínez Solórzano and Mrs. Francisca Báez de Martínez.

His father was Curator of the Michoacán Museum for 20 years (1900-1920) and Rector of the Colegio Primitivo Nacional de San Nicolás de Hidalgo for 15 years, as well as being a teacher of natural sciences in that school. Deputy to the Constituent Congress of Querétaro held in 1916-1917.

Antonio Martínez Báez completed his preparatory studies at the Colegio Primitivo Nacional de San Nicolás de Hidalgo (1913-1919) and began his professional studies in the Faculty of Law of the Michoacán University in 1920. In 1921, he continued his studies at the National School of Jurisprudence of the Universidad Nacional de Mexico (1921-1925), obtaining a lawyer's degree at that University on 21 July 1926. In the last year of his professional studies, he won first prize in a competition on the topic "Essay on constitutional government" organized by the newspapers El Universal of Mexico City and the Los Angeles Times of Los Angeles, California.

In 1929, he assumed the Chair of Constitutional Law at the National School of Jurisprudence, which he held without interruption until 1948; he returned to this Chair in 1953. Both in that Faculty and at the Open School of Law, he gave various special six-month courses on "Bankruptcies and insolvency proceedings" and "Agrarian law".

In 1944, he gave a six-month course on "Democracies, doctrines and institutions" at the Colegio de México.

Member of the Committee for the Review of the Commercial Code, 1931-1946.

In 1935-1941, Head of the Compensation Department of the Ministry of Agriculture and Development and of the Public Debt Office at the Ministry of Finance and Public Credit and Head of the Legal Department of the National Urban Mortgage and Public Works Bank.

Delegate of the Government of Mexico to the American Municipal Congress at Santiago, Chile, in 1941.

Chairman of the National Banking Commission, 1941-1943.

Manager of the Sugar Industry Finance Company, 1943-1946.

When the Universidad Nacional Autónoma de México was re-organized in 1945, he was appointed a member of its Board of Governors and acted as permanent secretary of the Board until 1966.

He acted as legal consultant to the National Agrarian Commission, the Ministry of Agriculture, the Ministry of Development and the former Ministry of Industry, Commerce and Labour.

1946-1948, member of the Committee for Legal Studies and Legislative Work responsible to the Office of the Counsel-General of the Republic.

Permanent member of the Mexican Academy of Legislation and Jurisprudence, the correspondent of its Spanish counterpart.

Member of the Board of Directors of the Mexican Bar Association, Vice-President of that institution in 1946-1948, 1954-1955, 1956-1957 and 1958, and President in 1959-1960.

Government representative of Mexico to the International Labour Conference held at Geneva in 1947.

Government Secretary for Economic Affairs, October 1948-November 1952.

1950, obtained a Doctor-of-Law degree and the post of Professor for doctorate courses in the Faculty of Jurisprudence and Social Sciences of the Universidad Nacional Autónoma de México. At present, holds the Chair of Constitutional Law.

Representative of Mexico at the special session of the Inter-American Economic and Social Council, held at Washington in March 1950.

Member of the International Academy of Political Sciences and Constitutional History of the Sorbonne, Paris.

Chairman of the fifth session of the Economic Commission for Latin America held at Mexico City in April 1951; remained Chairman until the sixth session at Rio de Janeiro in April 1953, which he attended as Head of the Mexican delegation.

Member of the National Insurance Commission, 1953-1959.

Member of the Board of Governors of the Colegio de México, 1961.

Member of the Ilustre y Nacional Colegio de Abogados de México.

Member of the Mexican Institute of Procedural Law.

Delegate to the First American Conference of Lawyers on World Peace through the Rule of Law (San José, Costa Rica, June 1961).

Member of the Governing Council of the International Association of Legal Science, 1961-1963.

Delegate to the First World Conference on Lawyers on World Peace through the Rule of Law (Athens, Greece, June 1963).

Member of the Board of Governors of the Universidad Michoacana de San Nicolás de Hidalgo, 1963-1964.

Member of the Sub-Commission on Prevention of Discrimination and Protection of Minorities of the United Nations Commission on Human Rights, 1966-1968.

Member of the Permanent Court of Arbitration at The Hague (1965).

Doctor honoris causa of the Universidad Michoacana de San Nicolás de Hidalgo.

Emeritus Professor of the Faculty of Law of the Universidad Nacional Autónoma de México, 1966.

Arbitrator for the settlement of disputes within the Latin-American Free-Trade Association (LAFTA), 1968.

Representative of Mexico at the International Conference on Human Rights, Teheran, April-May 1968.

Representative of Mexico at the Inter-American Specialized Conference on Human Rights, San José, Costa Rica, 7-22 November 1969.

Participating member for Mexico at the United Nations international seminar on the dangers of a recrudescence of intolerance in all its forms and the search for ways of preventing and combating it, held at Nice in August-September 1971.

# IR. JUSTICE ABU SAYEED CHOWDHURY

(Mominated by the Government of Bangladesh)

Born on 31 January 1921, Mr. Justice Abu Sayeed Chowdhury, former President of the People's Republic of Bangladesh, comes from a well-known family of Tangail and is the only son of the late Mr. Abdul Hamid Chowdhury, Speaker of the former East Pakistan Assembly. After graduation from the Presidency College in Calcutta in 1940, Mr. Chowdhury obtained his Master of Arts and Bachelor of Laws degrees from Calcutta University. He was called to the English Bar in 1947 from Lincoln's Inn. During his student days he was General Secretary of the Presidency College Union and also the President of the British Branch of the All-India Muslim Students Federation in 1946. He was Foreign Minister of Bangladesh from August to November 1975. He held a part-time teaching post in the Department of Law, University of Dacca, for about 10 years, taught Constitutional Law, Equity and Trusts, Contract and Tort, and was Vice-Chancellor of the University of Dacca 1969-1972.
