### 2006/1. Cese de la labor de la Comisión de Derechos Humanos

*La Comisión de Derechos Humanos,*

*Recordando* la resolución 60/251 de la Asamblea General, de 15 de marzo de 2006, por la que se creó el Consejo de Derechos Humanos, y la resolución 2006/2 del Consejo Económico y Social, de 22 de marzo de 2006,

1. *Toma nota* de la resolución 60/251 de la Asamblea General, de 15 de marzo de 2006;
2. *Remite* en consecuencia todos los informes al Consejo de Derechos Humanos para que prosiga el examen de éstos en su primer período de sesiones, en junio de 2006 (véase el anexo);
3. *Expresa su reconocimiento* a todos los que contribuyeron a la promoción y la protección de los derechos humanos durante sus 60 años de existencia;
4. *Decide* dar por concluida su labor de conformidad con la resolución 60/251 de la Asamblea General, de 15 de marzo de 2006, y la resolución 2006/2 del Consejo Económico y Social, de 22 de marzo de 2006.

## II. Aprobación del programa y organización de los trabajos

### A. Apertura y duración del período de sesiones

1. La Comisión de Derechos Humanos celebró su 62º período de sesiones en la Oficina de las Naciones Unidas en Ginebra el 16 de enero y del 13 al 27 de marzo de 2006 (véanse también los párrafos 10 y 11). En ese período celebró cuatro sesiones (véase E/CN.4/2006/SR.1 a 4)<sup>1</sup>.
2. Declaró abierto el período de sesiones el Sr. Makarim Wibisono, Presidente de la Comisión en su 61º período de sesiones.
3. En la primera sesión, el 16 de enero de 2006, y en la cuarta sesión, el 27 de marzo, hizo declaraciones la Sra. Louise Arbour, Alta Comisionada de las Naciones Unidas para los Derechos Humanos.

### B. Asistencia

4. Asistieron al período de sesiones representantes de los Estados miembros de la Comisión, observadores de otros Estados Miembros de las Naciones Unidas, observadores de Estados no miembros y observadores de los organismos especializados, organizaciones intergubernamentales regionales, otras entidades y organizaciones no gubernamentales. En el anexo III se presenta la lista de los participantes.

### C. Elección de la Mesa

5. En su primera sesión, la Comisión eligió por aclamación a los siguientes miembros de la Mesa:

6. En la misma sesión, hicieron declaraciones en relación con la elección de los miembros de la Mesa los representantes de México (en nombre del Grupo de Estados de América Latina y el Caribe) y los Países Bajos (en nombre del Grupo de Estados de Europa Occidental y otros Estados).

7. También hicieron declaraciones los representantes de Marruecos (en nombre del Grupo de Estados de África), la Arabia Saudita (en nombre del Grupo de Estados de Asia), Azerbaiyán (en nombre del Grupo de Estados de Europa Oriental) y el Pakistán (en nombre de la Organización de la Conferencia Islámica), así como un representante de la Conferencia de Organizaciones No Gubernamentales (CONGO).

#### **D. Programa**

8. En la cuarta sesión, el 27 de marzo de 2006, la Comisión examinó y aprobó sin votación el programa de su 62º período de sesiones (E/CN.4/2006/L.1), que habían preparado los miembros de la Mesa en la inteligencia de que la finalidad del párrafo 6 de la parte dispositiva de la resolución 60/251 de la Asamblea General, de 15 de marzo de 2006, era que la Asamblea General transfiriese al Consejo de Derechos Humanos todos los mandatos, mecanismos, funciones y responsabilidades de la Comisión que estaban vigentes en el momento de aprobarse la resolución y de que no se precisaba por tanto ninguna medida de la Comisión para asegurar su continuidad o transferencia. En el anexo I figura el texto del programa aprobado.

#### **E. Organización de los trabajos**

9. La Comisión examinó la organización de sus trabajos en su cuarta sesión, el 27 de marzo de 2006.

10. En la segunda sesión, el 13 de marzo, la Comisión, por recomendación de la Mesa, decidió sin proceder a votación suspender por una semana el período de sesiones hasta el 20 de marzo de 2006.

11. En la tercera sesión, el 20 de marzo, la Comisión, por recomendación de la Mesa, decidió sin proceder a votación suspender por una semana el período de sesiones hasta el 27 de marzo de 2006.

12. En la cuarta sesión, el 27 de marzo, hicieron declaraciones las siguientes personas:
  - a) El Sr. Manuel Rodríguez-Cuadros, Presidente de la Comisión en su 62º período de sesiones;
  - b) La Sra. Louise Arbour, Alta Comisionada de las Naciones Unidas para los Derechos Humanos;
  - c) El Sr. Makarim Wibisono, Presidente de la Comisión en su 61º período de sesiones.

#### **F. Sesiones, resoluciones y documentación**

13. Como se indica en el párrafo 1, la Comisión celebró cuatro sesiones con todos los servicios de conferencia.
