La Commission des droits de l'homme,

Rappelant la résolution 60/251 de l'Assemblée générale, en date du 15 mars 2006, qui a créé le Conseil des droits de l'homme, et la résolution 2006/2 du Conseil économique et social en date du 22 mars 2006,
