План действий для лесного сектора в условиях развития экологичной экономики

Записка секретариата

Резюме

В настоящем документе содержится информация о процессе разработки Плана действий для лесного сектора в условиях развития экологичной экономики, который послужит основой для пяти заседаний "за круглым столом" в рамках совместного совещания Комитета по лесоматериалам и Европейской лесной комиссии в Анталье, "Орман 2011: Леса в условиях развития экологичной экономики", и предлагаются меры по доработке плана. В настоящем документе также содержится информация о плане, а в приложении – разработанный на сегодняшний день текст плана, который будет обновлен с учетом информации, собранной в Анталье.

Введение

- 1. В 2010 году бюро Комитета ЕЭК по лесоматериалам и Европейской лесной комиссии ФАО обсудили возможность разработки плана действий для лесного сектора в условиях развития экологичной экономики в регионе ЕЭК в целях решения существующих проблем и определения возможных мер для увеличения вклада лесного сектора. Было принято решение, что на начальном этапе следует собрать информацию и предложения путем проведения консультаций с соответствующими заинтересованными сторонами. Первые отклики поступили в ответах на вопросник, который секретариат распространил через различные списки рассылки информации по лесной тематике. Секретариат получил ответы от 31 заинтересованной стороны и обобщил их в первом проекте плана действий. Впоследствии в мае 2011 года секретариат организовал совещание с заинтересованными сторонами, в котором приняли активное участие несколько государств-членов, другие международные и неправительственные организации. Результаты этих консультаций содержатся в приложении к настоящему документу.
- 2. План ни в коей мере не представляет собой окончательно согласованный документ и требует существенной доработки. На данный момент в нем представлена всеобъемлющая справочная информация о мероприятиях, которые осуществляются или могли бы быть осуществлены на национальном и международном уровнях в целях повышения вклада лесного сектора в развитие экологичной экономики и обеспечение ее устойчивости.
- 3. План действий будет представлен и обсужден на ряде тематических заседаний "за круглым столом" в рамках совместного совещания Комитета по лесоматериалам и Европейской лесной комиссии "Орман 2011: Леса в условиях развития экологичной экономики". В ходе этих обсуждений будет собрана дополнительная полезная информация для доработки Плана действий. На совещании с заинтересованными сторонами было также предложено провести еще одно аналогичное совещание, возможно в привязке к другому совещанию ЕЭК/ФАО, в целях продолжения работы по разработке и улучшению Плана действий. По предложению совещания с заинтересованными сторонами бюро Комитета и Комиссии также решили представить и обсудить План действий на Конференции Организации Объединенных Наций по устойчивому развитию, которая состоится в Рио-де-Жанейро в 2012 году, и использовать эту возможность для продолжения обсуждений и обмена мнениями с соответствующими заинтересованными сторонами.
- Основная идея состоит в том, чтобы обсуждение, разработка и работа по улучшению Плана действий велись параллельно с обзором совместной программы работы ЕЭК/ФАО и чтобы его окончательный проект был представлен на утверждение государствам-членам на совместной сессии КЛ и ЕЛК в 2013 году. На совещании с заинтересованными сторонами и на последующем совместном совещании бюро было также предложено использовать План действий в качестве основы для определения соответствующих тем, которые должны охвачены совместной программой работы ЕЭК/ФАО лесоматериалам лесному хозяйству период процесса обзора (см. документ ECE/TIM/2011/9-FO:EFC/2011/9).
- 5. Кроме того, на совещании с заинтересованными сторонами было предложено начать сбор уже имеющихся тематических исследований и информации об опыте, накопленном в лесном секторе региона ЕЭК в области осуществления

мер в поддержку развития экологичной экономики, и создать на вебсайте Секции лесного хозяйства и лесоматериалов ЕЭК/ФАО доступную для осуществления поиска базу данных. Бюро одобрили эту идею.

I. Цели Плана действий

- 13. План действий призван стимулировать принятие мер для наращивания вклада лесного сектора региона ЕЭК ООН в развитие формирующейся экологичной экономики. В частности, его цели состоят в:
- а) определении, каким образом лесной сектор региона ЕЭК может или мог бы способствовать развитию экологичной экономики, и оценке прогресса в этой области;
- b) распространении и пропаганде на основе сотрудничества между всеми заинтересованными сторонами наилучшей практики в этой области на национальном и международном уровнях;
- с) оказании содействия разработке и осуществлению политики лесного сектора, которая является действенной для достижения целей общества, эффективной в плане использования ресурсов и справедливой с точки зрения учета интересов различных участников как в секторе, так и за его пределами;
- d) доведении информации о достижениях лесного сектора в регионе ЕЭК до сведения общественности, директивных органов и других секторов.
- 14. В Плане действий затрагиваются вопросы, касающиеся не только экологичных аспектов экономики лесного сектора, но и конкретного вклада, который лесной сектор может внести в развитие экологичной экономики в целом.

II. Сфера охвата и характер Плана действий

- 19. В Плане действий предлагается комплекс целей для лесного сектора региона ЕЭК и возможные меры для достижения этих целей, подлежащие принятию международными организациями, правительствами государств-членов, частным сектором, гражданским обществом и другими заинтересованными сторонами.
- 20. План не является программой работы для этих органов, но включает меры, которые должны быть осуществлены всеми участниками, включая правительства, научно-исследовательские круги, частный сектор и гражданское общество, а также международные правительственные и неправительственные организации. В нем не указываются конкретные организации или участники, которые будут отвечать за реализацию предлагаемых "возможных мер", многие из которых, вероятно, будут осуществляться по линии специальных механизмов партнерства. Он призван стимулировать принятие мер и служить основой для разработки планов и мероприятий многих организаций с целью сосредоточения внимания на вопросе о роли лесов в экологичной экономике.
- 21. План ориентирован исключительно на лесной сектор региона ЕЭК ООН, при этом в нем не рассматривается вопрос о том, каким образом страны региона могут содействовать решению глобальных проблем, в частности проблемы обезлесения в тропических регионах. Под "лесным сектором" понимается лесное хозяйство, а также производство и потребление лесных товаров.

22. В регионе ЕЭК ООН осуществляется большое число важных международных инициатив и программ, посвященных лесному сектору, включая процесс "Леса Европы", План действий ЕС в отношении лесов, Монреальский процесс и Международную сеть модельных лесов, каждая из которых преследует свои конкретные цели и располагает своими ресурсами. Особенностью настоящего Плана действий является то, что он охватывает весь регион ЕЭК ООН и что основное внимание в нем уделяется вкладу лесного сектора в развитие экологичной экономики, а не более общему вопросу обеспечения устойчивого лесопользования. Он также призван служить вкладом в обеспечение перехода к экологичной экономике на глобальном уровне путем четкого определения и развития потенциала лесного сектора.

III. Структура Плана действий

- 23. План действий охватывает пять тем и предусматривает осуществление деятельности в ряде областей, которые указаны в приложении:
 - 1. Устойчивое производство и потребление лесных товаров
 - 2. Низкоуглеродный лесной сектор
 - 3. Достойные "зеленые" рабочие места в лесном секторе
 - 4. Стоимостная оценка лесных экосистемных услуг и их оплата
 - 5. Мониторинг и управление в лесном секторе

IV. Рекомендации

Комитет по лесоматериалам и Европейская лесная комиссия, возможно, пожелают одобрить изложенные выше предложения, и в частности:

- 1. *приветствовать* План действий в качестве основы для обсуждений на сессии и руководства к действию на национальном и международном уровнях;
- 2. *организовать* в рамках к сессии Рабочей группы по экономике и статистике лесного сектора в марте 2012 года однодневное совещание с заинтересованными сторонами в целях доработки плана и, в частности, определения мероприятий и соответствующих участников;
- 3. представить План действий на Конференции в Рио-де-Жанейро в 2012 году и дополнительно запросить мнения заинтересованных сторон, участвующих в этом международном совещании;
- 4. продолжить работу по улучшению Плана действий в рамках соответствующих совещаний ЕЭК/ФАО в 2012 и 2013 годах с целью представления окончательного Плана действий на утверждение совместной сессии КЛ/ЕЛК в 2013 году;
- 5. *использовать* План действий в качестве основы для определения соответствующих тем, которые могли бы быть охвачены совместной программой работы ЕЭК/ФАО по лесоматериалам и лесному хозяйству в период процесса обзора;

6. создать в Интернете базу данных, содержащую соответствующие тематические исследования и информацию о накопленном в регионе ЕЭК опыте по вопросам, касающимся вклада лесного сектора в развитие экологичной экономики, которые должны быть собраны среди государствчленов и соответствующих организаций.
