## Nota del Secretario General

## Adición

1. El objetivo de la presente nota es informar al Consejo de que el Secretario General ha recibido otras tres propuestas de candidatos para la elección de miembros de la Comisión Jurídica y Técnica, que se celebrará durante el 17º período de sesiones de la Autoridad Internacional de los Fondos Marinos.

2. De conformidad con lo estipulado en el párrafo 1 b) de la decisión del Consejo ISBA/13/C/6, la fecha límite para la presentación de candidaturas se fijó para el 11 de abril de 2011, y las propuestas de candidaturas recibidas con posterioridad a dicha fecha no serán aceptadas. Con respecto a la elección de los miembros de la Comisión que se celebrará en 2011, el Consejo acordó, durante su 16° período de sesiones celebrado en 2010, (ISBA/16/C/14, párr. 13), que deberían aplicarse estrictamente los procedimientos establecidos en el documento ISBA/13/C/6.

3. El 26 de abril de 2011, el Secretario General recibió una nota verbal de fecha 4 de marzo de 2011 de la Misión Permanente de Uganda ante las Naciones Unidas en Nueva York, en que se proponía la candidatura del Sr. Joshua Tuhumwire para la elección de miembros de la Comisión Jurídica y Técnica.

4. El 5 de mayo de 2011, el Secretario General recibió una carta de fecha 4 de mayo de 2011 del Representante Permanente Adjunto de la Arabia Saudita ante las Naciones Unidas en Nueva York, en que se proponía la candidatura del Sr. Farhan para la elección de miembros de la Comisión Jurídica y Técnica.

5. El 18 de mayo de 2011, el Secretario General recibió una nota verbal de fecha 9 de mayo de 2011 de la Misión Permanente de Egipto ante las Naciones Unidas, en que se proponía la candidatura del Embajador Hussein Mubarak para la elección de miembros de la Comisión Jurídica y Técnica.

Corresponding investment in sector increased from less than US\$ 1 million in exploration to over \$3 million a year, including the \$110 million in Kasese cobalt plant.
