**NOTE VERBALE DATED 7 FEBRUARY 1994 FROM THE SECRETARY-GENERAL
ADDRESSED TO THE PRESIDENT OF THE SECURITY COUNCIL**

The Secretary-General presents his compliments to the President of the Security Council and, in accordance with paragraph 8 of Security Council resolution 816 (1993), has the honour to bring to his attention further information received by the United Nations Protection Force (UNPROFOR) regarding apparent violations of the ban on flights in the airspace of Bosnia and Herzegovina.

Between 4 and 6 February 1994, there appear to have been 23 flights of fixed- or rotary-wing aircraft in the airspace of Bosnia and Herzegovina other than those exempted in accordance with paragraph 2 of that resolution. Details as to the itinerary of flights in this reporting period are annexed to the present note verbale.

Please note that the total number of flights assessed is now 1,377.

1381	4 Feb.	1121	1122	NATO fighter aircraft made radar and visual contact with a white MI-8 helicopter with a red cross, 15 kilometres south of Zvornik. 1382	4 Feb.	1141	1230	AWACS made radar contact 6 kilometres south-west of Vitez, heading north-east. Three of the bundles had four parachutes and one bundle had two parachutes. The parachutes were red-and-white-striped. North Atlantic Treaty Organization (NATO) fighters investigated and made visual contact with an MI-8 helicopter hovering 2 kilometres north of Vradina. NATO fighter aircraft shadowed the helicopter until contact was lost in the vicinity of Posusje. The unauthorized flight occurred in an area controlled by Bosnian Croats. Additionally, there was another violation as the flight plan did not follow the approved schedule. The unauthorized flight occurred in an area controlled by Bosnian Serbs.
