#### Rif Dimashq governorate

- 1. At 2200 hours on 16 June 2012, an armed terrorist group opened fire on a Mitsubishi microbus, licence plate No. 918152, driven by Sergeant Ali Uthman, on the Qadsiya Hamah road just before the Hamah overpass. The driver was killed and the vehicle damaged.
- 2. At 2300 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Barakah quarter of Qatana, wounding Lieutenant Khaldun Yaqzan.
- 3. At 0000 hours, an armed terrorist group deployed in Qadsiya, Kufayr al-Zayt and Zabadani, threatening to kill people if they did not vacate their homes.
- 4. At 0000 hours, an armed terrorist group opened fire on law enforcement checkpoints in Kafr Batna, near the Zamalka underpass and in Qabun.
- 5. At 0030 hours, an armed terrorist group opened fire on four border posts in Fadiliyah.
- 6. At 0650 hours, an armed terrorist group detonated an explosive device in a bus carrying law enforcement personnel as it was proceeding through the Tall district, west of the army recruitment sub-office. The bus was damaged.
- 7. At 0700 hours, an armed terrorist group detonated an explosive device at the Tall bridge.
- 8. At 0700 hours, an armed terrorist group shot and killed Lieutenant Colonel Mundhir Aql al-Shararah in front of his home in Hajar al-Aswad as he was setting out for work.
- 9. At 1000 hours, an armed terrorist group invaded the home of Captain Usamah al-Miqdad in Mu'addamiyah, stole his weapon, and shot and killed a neighbour, a civilian named Khalid Harkal.
- 10. At 1015 hours, an armed terrorist group abducted conscript Abdussalam al-Hasan in Jisrayn and demanded 500,000 Syrian pounds from his family as ransom.
- 11. At 1200 hours, an armed terrorist group opened fire on a law enforcement patrol vehicle in Duma, killing Chief Warrant Officer Muhammad al-'Ayhari, conscripts Ahmad al-Khalif, Mustafa al-Ahmad and Muhammad al-Husayn, Sergeant Manar Khalaf and Corporal Safwan al-Kuk.

- 12. At 1700 hours, an armed terrorist group opened fire on a military barracks in Marah, wounding two guards.
- 13. At 1700 hours, an armed terrorist group opened fire on and attacked the Dayr al-Hajar agricultural operation, abducting three officers with their weapons.
- 14. In Bab Bila town, an armed terrorist group shot a civilian, Ala'addin Ahmad Hammud, born in 1977, in Ali al-Wahsh Street, inflicting three bullet wounds in the head and neck and killing him instantly.
- 15. In Darayya city, the body of a civilian, Sawmar Muhammad Salman, 30, was found. He had been shot.
- 16. The body of an unidentified man in his forties was found on the Dahadil road near the Iman mosque. The victim had been shot, and the body bore indications of torture.
- 17. In Nabk city, an armed terrorist group in three vehicles set up a roadblock in the vicinity of the engineering storage depots. They deployed in the area, targeting a ZIL military vehicle that was on a food delivery mission. A clash ensued, in the course of which conscript Imad Khalid al-Husayn was shot in the chest and conscript Abdu Kayawan was shot in the left hand. One of the assailants' vehicles, a jeep, licence plate number unknown, was destroyed, one of the assailants was killed and a number of others wounded, and one of them, an individual named Ahmad Karam al-Darwish, was captured. Two Kalashnikov automatic rifles and ammunition were found at the scene afterwards. The remaining assailants fled in an unknown direction.
- 18. More than 100 armed terrorists armed with rocket-propelled grenades, bombs, machine guns and Kalashnikov automatic rifles attacked the Mulayhah district building. There was an exchange of fire that lasted until 0400 hours. The assailants succeeded in breaking in through the main entrance after killing a police officer, Haydar Muhammad, who had been on guard duty there. They set fire to the building, completely destroying the ground floor, and also burned four police vehicles and a number of equipment items belonging to the Mulayhah municipality that were in the municipal garage: these included a Mazda pickup, a forklift truck, an ambulance belonging to the national hospital in Mulayhah, and a Government bus belonging to the Damascus international airport. The district director sustained a bullet wound in the shoulder, 10 officers were injured by bullets or grenade fragments, and 12 Kalashnikov automatic rifles, with ammunition, were lost. The military engineers defused a number of explosive devices that had been planted around and inside the district building.
- 19. An armed terrorist group commandeered a police vehicle, an Opel, licence plate No. 39609, belonging to the traffic branch in Rif Dimashq. The incident occurred near the Mazda company. A Kalashnikov automatic rifle was also stolen.

- 20. An armed terrorist group stole a police vehicle, a Toyota Camry, licence plate No. 715733 (Rif Dimashq), belonging to the emergency assistance branch in Rif Dimashq.
- 21. In Hirista, an armed terrorist group commandeered a Peugeot vehicle, licence plate No. 721974 (Damascus), from its driver, Tamibi Yakhabki ibn Majid.
- 22. In Hirista, an armed terrorist group commandeered a Government vehicle, an Isuzu, licence plate No. 899340 (Rif Dimashq), belonging to the Rif Dimashq Health Services Directorate, from its driver, Khalid Ali Afuf.
- 23. An armed terrorist group stole a Citroën pickup, licence plate No. 515384 (Ladhiqiyah), belonging to the Joud Company.
- 24. An armed terrorist group stole a closed Shanghai pickup, licence plate No. 514019 (Ladhiqiyah), belonging to the Joud Company.
- 25. Military engineers defused an explosive device that had been placed under a Hyundai bus, licence plate No. 495841 (Tartus), at the railway station in Subaynah.
- 26. An armed terrorist group launched a rocket-propelled grenade at the Bahr al-Nujum park at the Bayt Sahm turnoff on the airport road. There was some damage, but no casualties.
- 27. Armed terrorist groups ordered merchants in Bayt Sahm to close their shops, threatening to set fire to the shops if they did not comply.
- 28. In Ghizlaniyah town, an armed terrorist group shot and wounded a civilian near the fifth bridge.
- 29. An armed terrorist group opened fire on a bus on the Damascus Homs road, wounding a woman, Salma Muslimani, in the shoulder.
- 30. An armed terrorist group abducted a civilian, Imadaddin Faris, between the towns of Mudirah and Hirista.
- 31. An armed terrorist group stole a Mazda double cabin pickup, licence plate No. 537949 (Damascus), belonging to a civil aviation company.
- 32. An explosive device went off near the Damascus central prison, slightly damaging the outer wall.
- 33. Three bodies were found in Duma. Two of them proved to be those of police officers, Qadri Rahmun, of the Duma town station, and Khalid Sa'id, of the Duma courthouse detachment, while the third body was unidentified.
- 34. Five military police personnel and a civilian who had been accompanying them were killed as they were heading toward the Public Prosecutor's office in Duma in a patrol vehicle.
- 35. A clash between law enforcement forces and armed terrorist groups occurred at the Shuhada' roundabout in Duma.
- 36. Two unidentified bodies were discovered; the victims had been shot.

- 37. In Duma, an armed terrorist group stole a Government vehicle, a Datsun double cabin model belonging to the State Corporation for Roads and Bridges, licence plate No. 890302 (Damascus).
- 38. In Duma, an armed terrorist group stole a closed Citroën truck, licence plate No. 882822 (Aleppo), belonging to the Kaadan Company.
- 39. The army engineers defused an explosive device attached to a military vehicle, licence plate No. 81849, that had been placed at the disposal of Staff Sergeant Wasim Nayif al-Safadi, serving with the Popular Army in Adra. The terrorist was caught with a wireless detonator in his possession. He proved to be one Urfan Arsal, 22, of Palestinian nationality.
- 40. Armed terrorist groups attempted to deploy in Qadsiya and Wadi Barda, blocking roads, closing shops and detonating noise bombs. At 1915 hours, there was a call from the Umri mosque urging people to vacate their homes and take up *jihad*. Armed men also deployed in Hamah and at the Birah factory. A clash occurred between them and the law enforcement personnel who were present in the district.
- 41. An explosive device went off at the Ahdath stop in Qadsiya. It had been intended for a shop kept by a civilian.
- 42. An explosive device intended for a military bus went off without causing any casualties or damage.
- 43. The body of First Warrant Officer Majid Jamil Dakur was found in Darayya. He had been shot, and the body bore indications of torture.
- 44. An armed terrorist group stole a 24-seat Mitsubishi microbus, licence plate No. 930261 (Damascus), belonging to the National Institute of Public Administration.
- 45. In Nashabiyah town, an armed terrorist group commandeered a Government dump truck, licence plate No. 899114, belonging to the Damascus Water Supply and Sanitation Authority from its driver, Husayn Ibrahim. The terrorists drove a Hyundai jeep, licence plate number unknown.
- 46. Three civilians, Umar Bakri Qasim, born in 1944, Walid Bakri Qasim, born in 1955, and Ammar al-Hamawi, 50, were taken to the Basil hospital after having been shot by an armed terrorist group while they were harvesting cherries in the vicinity of Ra's al-Ma'arrah.
- 47. The body of an individual in his thirties was found in Hazzah town. The victim had been shot in the head and abdomen, and the body bore indications of torture.
- 48. Army engineers defused a 50-kg explosive device in Kiswah town, near the spice packing plant in the Mansurah district. It proved to be filled with high explosive.

#### **Damascus governorate**

- 49. At 0600 hours, an armed terrorist group attacked and ransacked the railway station in Qadam.
- 50. An explosive device was discovered in the residential area of Qadam Jawrah, behind the Sadkub warehouses. It was defused by army engineers. The device had been placed inside a large sheet of metal. It weighed 20 kg and consisted of explosive materials and a quantity of small stones

- and sand. It was fitted with a detonator containing powerful incendiary materials connected to a battery, operated by remote control.
- 51. An armed terrorist group opened fire on a traffic patrol vehicle in the Nahr Ayshah neighbourhood, wounding one officer. He was taken to hospital, where he died. In addition, an armed terrorist group positioned beside the Ali ibn Abi Talib mosque opened fire on officers of the Qadam police detachment and hurled explosive devices at them, wounding an officer in both hands. He was taken to hospital.
- 52. In the Yarmuk district, an armed terrorist group opened fire in 30th Street on law enforcement personnel, wounding two officers. They were taken to hospital.
- 53. A wireless explosive device weighing approximately 3 kg was found enclosed in a nylon bag in the Manakhiliyah district, in the Nahhasin market. It consisted of an iron cylinder connected by a wire to a small external battery. The device was defused by army engineers.
- 54. A police officer, Mahmud Bakur, born in Homs in 1974, was found lying in the Rukn al-Din Tal'at al-Tahhan district of Damascus, bleeding profusely from a bullet wound. He was taken to hospital, where he died.

#### Dar'a governorate

- 55. At 2200 hours on 16 June 2012, an armed terrorist group opened fire on a military barracks in Harak, wounding a guard.
- 56. At 0100 hour, an armed terrorist group opened fire on the border guards at the Tall Shihab and Kharab al-Shahm posts.
- 57. At 0600 hours, an armed terrorist group abducted Colonel Jihad al-Rahil from in front of his home in Ghasm town.
- 58. At 0700 hours, an armed terrorist group set up a roadblock on the Shamri press canning factory road in Muzayrib, looking for law enforcement and police personnel.
- 59. At 0730 hours, an armed terrorist group detonated an explosive device and opened fire on a law enforcement patrol vehicle as it was proceeding along the road near Judayyah, wounding a civilian.
- 60. At 1030 hours, an armed terrorist group abducted three law enforcement officers in Umm Walad.
- 61. At 1530 hours, an armed terrorist group opened fire on a law enforcement checkpoint at the intersection near the dam, at the entrance to the camp in Dar'a, wounding one officer.
- 62. An armed terrorist group fired a mortar round from the Dar'a camp at the railway station police detachment. The round fell in the street, and there were no casualties.

#### Homs governorate

- 63. At 2030 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Jawbar quarter, wounding Lieutenant Khalid al-Husayn.
- 64. At 2100 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in Jawrat al-Shiyah, wounding Colonel Zuhayr Hammad and another officer.

- 65. At 2130 hours on 16 June 2012, an armed terrorist group opened sporadic fire on law enforcement personnel in Rastan, wounding one officer.
- 66. At 2130 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in Karm Shamsham, wounding one officer.
- 67. At 2130 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in Wadi al-Sayih, wounding one officer.
- 68. At 2155 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel beside the Cardamom Market roundabout.
- 69. At 2200 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Qarabis quarter, wounding one officer.
- 70. At 2200 hours on 16 June 2012, an armed terrorist group opened fire on a military barracks in Ghantu, killing the driver, Talal al-Ahmad, and wounding Major General Husayn Ishaq and two other officers.
- 71. At 2230 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in Sultaniyah, wounding one officer.
- 72. At 2300 hours on 16 June 2012, an armed terrorist group opened fire on a law enforcement checkpoint near the Water Authority, wounding one officer.
- 73. At 2300 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement officers near Bab Tadmur.
- 74. At 2330 hours on 16 June 2012, an armed terrorist group opened fire and launched rocket-propelled grenades at law enforcement personnel in the Kahlidiyah quarter, wounding three officers.
- 75. At 0100 hour, an armed terrorist group opened fire on law enforcement personnel in Bishulah, wounding one officer.
- 76. At 0100 hour, an armed terrorist group opened fire on law enforcement personnel in the Qusur quarter, wounding one officer.
- 77. At 0200 hours, an armed terrorist group opened fire on border guards in the Jawsiyah district.
- 78. At 0230 hours, an armed terrorist group opened fire on the Tadmur airport.
- 79. At 0315 hours, an armed terrorist group opened fire on law enforcement personnel near the Education Directorate, wounding one police officer.
- 80. At 0400 hours, an armed terrorist group opened fire on law enforcement personnel near Nizariyah village in Qusayr.
- 81. At 1820 hours, an armed terrorist group opened fire and launched a rocket-propelled grenade at law enforcement personnel in Kafr Aya, setting fire to a small area of farmland and burning the crops there.
- 82. At 1900 hours, an armed terrorist group fired a mortar round at law enforcement personnel near the Agricultural Development Establishment.
- 83. At 1930 hours, an armed terrorist group opened fire on law enforcement personnel near the Matahin roundabout.
- 84. An armed terrorist group opened fire with sniper rifles on law enforcement personnel in the Qusur quarter, wounding one officer.
- 85. An armed terrorist group opened fire on law enforcement personnel near the Bab Tadmur roundabout, killing one officer.

- 86. An armed terrorist group opened fire with machine guns and sniper rifles and launched rocket-propelled grenades at law enforcement personnel from the direction of the Warshah quarter.
- 87. An armed terrorist group fired a mortar round at law enforcement personnel near the cultural centre.

#### Hama governorate

- 88. At 2000 hours on 16 Jun 2012, an armed terrorist group abducted seven law enforcement officers in the Suran sub-district, including Lieutenant Basim Qattash.
- 89. At 2030 hours on 16 June 2012, an armed terrorist group abducted a civilian, Khidr al-'Ulaywi, from his home in Kawkab village.
- 90. At 2100 hours on 16 June 2012, an armed terrorist group abducted conscript Ra'id al-Yusuf from Aqrab village, took him to Hulah town and killed him.
- 91. At 2100 hours on 16 June 2012, an armed terrorist group shot five civilians and dumped their bodies near Ruz Surayhin village, in the vicinity of the Bik agricultural operation.
- 92. At 2130 hours on 16 June 2012, an armed terrorist group stole a Landwind vehicle belonging to Brigadier Sulayman Izzaddin in Salamiyah.
- 93. At 2215 hours on 16 June 2012, an armed terrorist group detonated an explosive device near the Nasih Alwani school.
- 94, At 2300 hours on 16 June 2012, an armed terrorist group intercepted and commandeered three trucks on the Raqqah Salamiyah road, two of them carrying olive oil and the third 18 tonnes of fabric.
- 95. At 0030 hours, an armed terrorist group abducted two guards at the pound belonging to the Communications Directorate on the Hama Salamiyah road.
- 96. At 0730 hours, an armed terrorist group intercepted Lieutenant Colonel (retired) Anis Mu'alla near the Sahir restaurant, just outside Shari'ah village, abducted him and commandeered his car.
- 97. At 0800 hours, an armed terrorist group intercepted a Government tanker, licence plate No. 937794, driven by a civilian, Marwan Ali, as it was proceeding along the Shathah Suqaylibiyah road near the Sahir restaurant. The terrorists abducted the driver and commandeered the tanker.
- 98. At 0800 hours, an armed terrorist group opened fire on a law enforcement checkpoint in Bab al-Taqah village Ghab, wounding two officers.
- 99. At 0800 hours, an armed terrorist group attacked a law enforcement checkpoint in Shari'ah village, killing two officers.
- 100. At 0800 hours, an armed terrorist group abducted a police officer, Mahmud al-'Ankir, in Kafr Nabudah town.
- 101. At 1100 hours, an armed terrorist group opened fire on law enforcement personnel in the Qusur quarter, killing Corporal Muhammad Shu'aybi and another officer.
- 102. At 1230 hours, an armed terrorist group killed a civilian and dumped the body at the Jazdan stop in the Hawarinah quarter.

- 103. At 1400 hours, an armed terrorist group intercepted and commandeered two trucks carrying wheat on the Raqqah Salamiyah Athariyah road.
- 104. At 1530 hours, an armed terrorist group ambushed a law enforcement patrol vehicle on the road between Qal'at al-Madiq and Karakat village, killing Staff Sergeant Husayn Haydar and wounding another officer.

#### Aleppo governorate

- 105. At 2100 hours on 16 June 2012, an armed terrorist group broke into the Agricultural Bank in the Mari' sub-district and stole a quantity of fertilizer with a view to using it to manufacture explosives.
- 106. At 2115 hours on 16 June 2012, an armed terrorist group detonated an explosive device in Tal'at al-Mula'ib Street.
- 107. At 2200 hours on 16 June 2012, an armed terrorist group attacked and beat law enforcement personnel in the Sayf al-Dawlah neighbourhood, injuring six officers.
- 108. At 2230 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Atarib district, wounding one officer.
- 109. At 2300 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Kalasah neighbourhood, wounding one officer.
- 110. At 0100 hour, an armed terrorist group invaded the Communications Directorate in Naqqarin and blew up a booby-trapped car inside the building.
- 111. At 0200 hours, an armed terrorist group opened fire on law enforcement personnel in Dar Taʻizzah.
- 112. At 0200 hours, an armed terrorist group attacked the Kuwayris traffic centre in Maskanah.
- 113. At 0400 hours, an armed terrorist group opened fire on law enforcement personnel in Dar Ta'izzah for a second time.
- 114. At 0400 hours, an armed terrorist group opened fire on a law enforcement checkpoint at the Jandul roundabout.
- 115. At 0500 hours, an armed terrorist group opened fire on law enforcement personnel in the Handarat district.
- 116. At 0800 hours, an armed terrorist group planted an explosive device in a citizen's car on the Aleppo Muslimiyah road.
- 117. At 0800 hours, an armed terrorist group planted an explosive device in front of the Haram office in Manbij.
- 118. At 0900 hours, an armed terrorist group opened fire on a car proceeding along the Raqqah road in the direction of the Rashidin quarter, killing a civilian and wounding two others.
- 119. At 0930 hours, an armed terrorist group opened fire on law enforcement personnel in Anadan, killing one officer and wounding 11 others, including Captain Muhannad Barri.
- 120. At 1000 hours, an armed terrorist group opened fire on law enforcement personnel in Atarib.

- 121. At 1000 hours, an armed terrorist group planted an explosive device near the Jandul roundabout on the Aleppo Muslimiyah road.
- 122. At 1030 hours, an armed terrorist group opened fire on law enforcement personnel in Anadan town, killing Sergeant Imran Jawriyah and wounding six other officers.
- 123. At 1100 hours, an armed terrorist group abducted Lieutenant Colonel Ahmad Luk in the Halak area.
- 124. At 1200 hours, an armed terrorist group planted an explosive device in the yard of the Pullman garage in Manbij.
- 125. At 1230 hours, an armed terrorist group detonated a noise bomb behind the law enforcement forces building in Manbij.
- 126. At 1300 hours, an armed terrorist group commandeered a tanker, licence plate No. 938512, in the Bab district, and abducted two law enforcement officers who were performing their duty of escorting it. The terrorists also stole the officers' weapons.
- 127. At 1300 hours, an armed terrorist group attacked the district directorate and security centres in Bab city.
- 128. At 1315 hours, an armed terrorist group detonated an explosive device opposite the Dar al-Shifa' hospital in the Shi'ar quarter, killing a police officer, Lu'ayy al-Salim, and injuring 10 civilians.
- 129. At 1330 hours, an armed terrorist group killed a civilian, Abdullah Sarur, and dumped the body on the Atarib Batabu road.
- 130. At 1330 hours, an armed terrorist group detonated two explosive devices in the Salah al-Din quarter, injuring five law enforcement officers.
- 131. At 1400 hours, an armed terrorist group opened fire on law enforcement personnel in Atarib, wounding one officer.
- 132. At 1400 hours, an armed terrorist group detonated two explosive devices behind the Sa'd mosque in the Salah al-Din quarter, and opened fire on law enforcement patrol vehicles, killing six civilians and wounding four law enforcement officers.
- 133. At 1715 hours, an armed terrorist group invaded the Arab Izzah border post in the Ghadurah Jarabulus district, abducting two guards and stealing four rifles and ammunition.
- 134. At 1815 hours, an armed terrorist group infiltrated a military barracks in Aleppo and stole weapons from the armoury.
- 135. At 1830 hours, an armed terrorist group opened fire on a law enforcement checkpoint at the Biyanun turnoff on the Aleppo I'zaz road.
- 136. At 1900 hours, an armed terrorist group opened fire on law enforcement personnel in the vicinity of Hawr town on the Aleppo Dar Ta'izzah road.
- 137. At 1930 hours, an armed terrorist group ambushed a law enforcement patrol vehicle near Jablat Aruda in the Manbij district, wounding two officers.

#### **Idlib** governorate

138. At 1830 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in the Angawi - Ghab district.

- 139. At 0100 hour, an armed terrorist group shot conscript Ali al-Jarad in Khan Shaykhun.
- 140. At 0100 hour, an armed terrorist group opened fire on law enforcement personnel near the Sayjar turnoff, killing Sergeant Muhammad al-Hadid.
- 141. At 0230 hours, an armed terrorist group opened fire on law enforcement personnel in Ariha, killing conscript Muhammad Mahmud Khayyat.
- 142. At 0600 hours, an armed terrorist group planted two explosive devices between the Ma'arr Tamasrin and Baladiyah roundabouts in Idlib city.
- $143.\,\mathrm{At}\ 0600\ \mathrm{hours},\ \mathrm{an}\ \mathrm{armed}\ \mathrm{terrorist}\ \mathrm{group}\ \mathrm{planted}\ \mathrm{two}\ \mathrm{explosive}\ \mathrm{devices}$  on the  $\mathrm{Idlib}$  Sarmin road.
- 144. At 0700 hours, an armed terrorist group opened fire on a border guard patrol vehicle in the Jisr al-Shughur Salqin Allani district.
- 145. At 1100 hours, an armed terrorist group opened fire on a law enforcement checkpoint near the Water Resources office at the Sayjar turnoff on the Idlib road, wounding four officers, including Lieutenant Yusuf Muhammad.
- 146. At 1100 hours, an armed terrorist group shot and killed a police officer, Muhammad al-'Ali, on the Idlib Kafr Takharim road.
- 147. At 1330 hours, an armed terrorist group planted an explosive device on the Baksariya Khirbat al-Jawz road.

#### Dayr al-Zawr governorate

- 148. At 2000 hours on 16 June 2012, an armed terrorist group shot Lieutenant Husam al-Khayr in the vicinity of the Pullman garage while he was on his way to work.
- 149. At 2200 hours on 16 June 2012, an armed terrorist group opened fire on law enforcement personnel in Dayr al-Zawr, wounding five officers, including Lieutenant Ali Muhammad.
- 150. At 0000 hours, an armed terrorist group opened fire on the district headquarters building in Abu Kamal.
- 151. At 0000 hours, an armed terrorist group opened fire on a law enforcement checkpoint near the Fisheries Resources office in Abu Kamal.
- 152. At 0200 hours, an armed terrorist group opened fire on the border guards at the Tayyan post.
- 153. At 0330 hours, an armed terrorist group opened fire on the Globe law enforcement checkpoint in Jawrah, killing Corporal Ahmad Isma'il and conscripts Muhammad al-Sallum and Salih al-Rumi and wounding four other officers.
- 154. At 0430 hours, an armed terrorist group opened fire on the local defence headquarters in Dayr al-Zawr.
- 155. At 1100 hours, an armed terrorist group opened fire on a law enforcement patrol vehicle on the Dayr al-Zawr Mayadin road, wounding one officer.
- 156. At 2000 hours, an armed terrorist group opened fire on the border guards brigade headquarters in Abu Kamal, killing two guards, wounding five more, destroying a vehicle and damaging another.

157. An armed terrorist group deployed on the Dayr al-Zawr - Kasrah road in the vicinity of the villages of Safirah Tahtani and Muhaymidah, set up roadblocks, and stopped and inspected passing vehicles as a means of terrorizing people.

158. An armed terrorist group deployed on the Dayr al-Zawr - Mayadin road in the vicinity of the Muhasan overpass and Bulayl village, set up roadblocks, and stopped and inspected passing vehicles in order to terrorize drivers and passengers.

159. An armed terrorist group deployed on the Dayr al-Zawr - Busayrah road in the vicinity of the villages of Sabhah and Dahlah, set up roadblocks, and stopped and inspected passing vehicles in order to terrorize drivers and passengers.

160. An armed terrorist group blew up the oil pipeline linking the Tanak and Ward fields at a point between the villages of Bahrah and Gharanij, in the Hajin sub-district. The pipeline caught fire at the point of the explosion, and the pumps shut down until repairs were made by maintenance crews.

161. In Dayr al-Zawr city, an armed terrorist group entered the Agricultural Research Centre at Al-Furat University and stole a Government microbus, 15 cows, 80 ewes and 30 lambs. The terrorists subsequently fled in an unknown direction.

#### Ladhiqiyah governorate

162. An armed terrorist group in a vehicle of unknown make, licence number unknown, attacked the law enforcement checkpoint placed to guard the Amruniyah bridge in the Bahluliyah sub-district. The assailants fired at the law enforcement officers there, who returned fire. In the course of the clash, Staff Sergeant Farid Jalal Muhammad was wounded, one of the terrorists was killed, and their vehicle was captured, together with a quantity of weapons.

163. An armed terrorist group detonated a dynamite charge at the entrance to Bint al-Shawish Street in the Zara'ah quarter. No casualties or damage resulted from the blast.

#### Hasakah governorate

164. At 0230 hours, an armed terrorist group opened fire on two border posts manned by guards of the Third Brigade in Jiz'ah.

#### Svrian-Lebanese border

165. At 2230 hours on 16 June 2012, an armed terrorist group attempted to infiltrate from Lebanese territory into Syrian territory and opened fire on the border guards manning the Ziyarah post.

166. At 2300 hours on 16 June 2012, an armed terrorist group attempted to infiltrate from Lebanese territory into Syrian territory and opened fire on the border guards manning the Shahirah post.

167. At 0100 hour, an armed terrorist group attempted to infiltrate from Lebanese territory into Syrian territory and opened fire on the border guards in Tall Kalakh.

#### Syrian-Iraqi border

168. At 0330 hours, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and opened fire on the border guards in the Jiz'ah district.

169. At 0330 hours, an armed terrorist group opened fire from within Iraqi and Syrian territory on the border guards in Abu Kamal.

170. At 0530 hours, an armed terrorist group attempted to infiltrate from Iraqi territory into Syrian territory and opened fire on the border guards in the Abu Kamal district.
