# LETTER DATED 22 APRIL 1991 FROM THE PERMANENT REPRESENTATIVE OF KUWAIT TO THE UNITED NATIONS ADDRESSED TO THE PRESIDENT OF THE **SECURITY** COUNCIL

# Damage sustained by the Ministry of Social Affairs and Labour and its subordinate institutions

#### 1. Furniture and equipment

All office furniture, office equipment, telephone, fax and telex apparatus, equipment for scanning statistics and statistical and representational graphs and television, radio and photographic apparatus.

- 2. <u>Documentation</u> library
- 3. <u>Computer apparatus</u>
- 4. <u>Microfilm apparatus</u>
- 5. <u>Manuscripts and archives</u>

All files were stolen, as were the official seals of the Ministry.

6. <u>Transport</u>

All 170 vehicles belonging to the Ministry were stolen, as were all spare parts and testing and repair equipment. The stolen vehicles included brand-new vehicles for the transport of the handicapped, whose value is estimated at \$30,000 each.

7. Stores

The stores were seized in their entirety and looted of all their contents, including furniture, stationery, foodstuffs, clothing, cleaning materials and utensils, as well as beds, tents and generators used for hikers and youth camps and items needed for children and the handicapped.

## 8. <u>Social Welfare Homes complex</u>

A **major** medical clinic, another subsidiary clinic, a **dental** clinic, a central pharmacy and a medical treatment centre were all seized. Utensils and equipment were also stolen **from** the complex's central canteen and central laundry.

# 9. <u>Vocational Training Centre</u>

All contents and equipment. including raw materials and products made by the handicapped and the blind and marketed on their behalf, were looted.

# 10. Youth centres and recreation centres for mothers and children

The 14 centres were taken over in their entirety, after being stripped of their contents, including children's toys, sports equipment, training workshops for young people's creative activities and the children's library.

# 11. Svorts Captains: TraiminCentre and Natural Medicine Centre

The centres were looted of all the medical and **natural** healing equipment which they contained.

## 12. <u>Scientific Club and branches</u>

All technical apparatus was confiscated and removed. Training wot-kshops were emptied and the scientific inventions of young people were stolen, as well as the contents of the Ajiri Meteorological Station and models used for research.

# 13. Olympic Committee. sports associations and clubs and all-Asia authorities

There **are** in all 32 sports clubs and associations, as well as the Olympic Committee and the **all-Asia** authorities. These establishments and authorities were taken over in their entirety and robbed of all their contents, including furniture, air-conditioning equipment, electric appliances, sports apparatus, audiovisual materials and commemorative and official cups and shields. Horses trained for racing and showjumping were also stolen, as well as yachts, boats and equipment and apparatus used for watersports.
