Introduction

- 1. The Governing Council of the United Nations Compensation Commission (the "Commission") constituted the present Panel of Commissioners (the "Panel") by appointing Mr. Roberto MacLean (Chairman) and Mr. Rafael Vizcarrondo at its thirtieth session in December 1998 and Mr. Nigel Alington at its thirty-third session on 30 September 1999. The Panel was appointed to review claims filed with the Commission on behalf of insurers and export credit agencies (the "E/F claims"), in accordance with the relevant Security Council resolutions and Governing Council decisions, including the Provisional Rules for Claims Procedure (S/AC.26/1992/10) (the "Rules").
- 2. The E/F claims category originated from the fact that some insurers (the "claimants", more specifically defined in paragraph 17 below) filed their claims in category "E" (claims of corporations and other legal entities) and some claimants filed their claims in category "F" (claims of Governments and international organizations). Each claimant seeks compensation for amounts paid to policyholders for loss, damage or injury allegedly arising from Iraq's invasion and occupation of Kuwait on 2 August 1990.
- 3. This report contains the Panel's recommendations to the Governing Council, pursuant to article 38(e) of the Rules, concerning 35 "E/F" claims for compensation in a total amount of 4,667,446,453 United States dollars (USD) (the "third instalment claims"). Initially the third instalment consisted of 40 claims for compensation in a total amount of USD 4,668,239,181. As described in paragraph 12 below, however, five claims originally included in the third instalment were transferred by the Executive Secretary to other categories during the period of the Panel's review. These claims are listed in annex IV below and are not included in the recommendations set out in this report. Nine of the third instalment claims relate to losses incurred by export credit agencies. The majority of the third instalment claims relate to losses in connection with supply and construction contracts between German exporters and Iraqi parties, including 20 claims by the institution that financed the payment obligations of the Iraqi parties, a claim on behalf of the export credit agency which guaranteed the contracts and four claims by the exporters themselves (see paragraphs 14, 45, 46 and 47 below). By loss type, the third instalment claims include all of the claims relating to the supply and construction contracts described above and relate to:
- (a) Contract-related losses, including losses under financing arrangements, export credit insurance policies and other government indemnities to exporters; and
 - (b) Other losses, specifically payments for unlawful detention.

I. PROCEDURAL HISTORY

A. The nature and purpose of the proceedings

4. The role of the Commission is set out in the "Report of the Secretary-General pursuant to paragraph 19 of Security Council resolution 687 (1991)" (S/22559). In paragraph 20 of his report, the Secretary-General described the function of the Commission:

- "... The Commission is not a court or an arbitral tribunal before which the parties appear; it is a political organ that performs an essentially fact-finding function of examining claims, verifying their validity, evaluating losses, assessing payments and resolving disputed claims. It is only in this last respect that a quasi-judicial function may be involved. Given the nature of the Commission, it is all the more important that some element of due process be built into the procedure. It will be the function of the Commissioners to provide this element."
- 5. In processing the third instalment claims, the Panel was required to:
- (a) Determine whether the various types of losses alleged by claimants are within the Commission's jurisdiction (i.e. are eligible for compensation within the framework established by the Security Council);
- (b) Verify whether the alleged losses that are, in principle, eligible for compensation have in fact been incurred by a given claimant; and
- (c) Evaluate the appropriate measure of compensation for each type of compensable loss and the quantum of the compensable losses.

For this purpose, the Panel had regard to the "Report and recommendations made by the Panel of Commissioners concerning the first instalment of 'E/F' claims" (S/AC.26/2001/6) and the "Report and recommendations made by the Panel of Commissioners concerning the second instalment of 'E/F' claims" (S/AC.26/2002/18) (respectively, the "First E/F Report", the "first instalment claims", the "Second E/F Report" and the "second instalment claims").

B. The procedural history of the third instalment claims

- 6. Before the third instalment claims were submitted to the Panel on 1 May 2001, the secretariat undertook a preliminary assessment of these claims in accordance with article 14 of the Rules, in order to determine if they met the formal requirements established by the Governing Council.
- 7. Nine claims presented formal deficiencies. The secretariat issued notifications to the claimants concerned, pursuant to article 15 of the Rules, requesting that the defects be remedied. All of the claimants responded, eight of which corrected those formal deficiencies. The claim with outstanding formal deficiencies was presented to the Panel as submitted.
- 8. Following adoption of Governing Council decision 114 (S/AC.26/Dec.114 (2000)) the Panel issued Procedural Order No. 1, dated 19 December 2000, sending to the Government of Iraq the claim files relating to nine of the third instalment claims, eight of which comprised the claims relating to losses in connection with supply and construction contracts between German exporters and Iraqi parties (see paragraph 3 above). These claim files were sent to the Government of Iraq as each claim sought compensation for asserted losses that exceeded USD 100 million. On 23 October 2001 the Government of Iraq provided the secretariat with its comments on the claimants' assertions as to the losses which are the subject of these claims. The Panel considered the information provided by the

Government of Iraq and took those comments into account in making the recommendations set out in this report.

- 9. In view of the nature and complexity of the issues raised in the third instalment claims, the Panel classified the third instalment claims as "unusually large or complex" claims within the meaning of article 38(d) of the Rules. By Procedural Order No. 2, dated 1 May 2001, the Panel gave notice of its intention to complete its review of the third instalment claims and to submit its report and recommendations to the Governing Council within 12 months, in accordance with article 38(d) of the Rules. This procedural order was transmitted to the claimants, through the diplomatic missions of their respective Governments, and to the Government of Iraq.
- 10. In processing the third instalment claims, the Panel employed the full range of investigative procedures available to it under the Rules. Pursuant to article 34 of the Rules, notifications were sent to all of the claimants ("article 34 notifications"). In the case of some of the claimants, the Panel sent supplementary article 34 notifications seeking further explanatory information and evidence.
- 11. The Panel performed a thorough factual and legal analysis of all of the third instalment claims, in accordance with article 38 of the Rules. The Panel also engaged expert accounting consultants to assist in the verification and valuation of the third instalment claims.
- During the course of its review, the Panel considered that five claims are not, in fact, claims of insurance companies or export credit agencies for losses arising out of payment or relief to others. Three of these claims were submitted by individuals and two claims were submitted by corporate entities, all seeking compensation for business losses. The Panel recommended to the Executive Secretary that these five claims be transferred to other categories of claims for review. Following this recommendation, the Executive Secretary transferred the three claims submitted by individuals to the "D" category of claims and the two claims submitted by corporate entities to the "E2" category of claims, pursuant to article 32(3) of the Rules.

II. LEGAL FRAMEWORK

- 13. The legal framework for the evaluation of the third instalment claims is the same as that used for the first instalment claims and the second instalment claims, as described in paragraphs 12 to 30 of the First E/F Report and paragraph 15 of the Second E/F Report, respectively. The present report only addresses new issues, which arise out of the factual circumstances of the third instalment claims.
- 14. The majority of the third instalment claims relate to losses in connection with certain contracts between German exporters and Iraqi parties for supply and construction contracts relating to projects in Iraq (see paragraph 3 above). One of these claims was submitted by a government-owned financial institution that advanced loans to the Iraqi parties to finance their payment obligations to the exporters under the contracts. These payment obligations were guaranteed by an export credit agency that provided export credit guarantees to exporters and, in some cases, to the financial institution referred to above. Such guarantees covered a certain percentage, usually 90 per cent, of the amounts owed by the Iraqi parties under the financing arrangements (as defined in paragraph 45 below). The uninsured portion of the risk was usually transferred to the exporter, which signed a guarantee in favour of the

financial institution. The financial institution seeks compensation for losses arising from the failure of the Iraqi parties to repay the loans. The claim of the export credit agency is based on its losses arising out of payments to either or both of the exporters and the financial institution in respect of those parties' participation in these transactions. The export credit agency is also claiming for its losses arising out of other payments to German exporters in respect of contracts entered into between the exporters and Iraqi parties.

- 15. As set out in paragraphs 45 and 46 below, the loans described above were the subject of rescheduling and deferral agreements. In considering these arrangements, the Panel adopted the reasoning of the "E2" Panel that such arrangements do not create "new" debts for the purposes of the "arising prior to" clause within the meaning of Security Council resolution 687 (1991) and that claims based on such arrangements are not within the Commission's jurisdiction if the original debt or obligation arose prior to 2 August 1990.²
- 16. Two of the third instalment claims were made by governmental entities, which made non-contractual payments to exporters that had suffered losses as a result of Iraq's invasion and occupation of Kuwait. These non-contractual payments were made pursuant to governmental decrees or decisions rather than insurance policies or guarantees. In paragraphs 31 to 36 of the First E/F Report, the Panel considered that, to be eligible for compensation, the underlying loss must have been compensable under the relevant policy in force at the time of Iraq's invasion and occupation of Kuwait. In respect of the third instalment claims, therefore, the Panel had to consider whether payments made pursuant to governmental decrees or decisions are compensable in the absence of any insurance policy or guarantee. The Panel considers that such claims are eligible for compensation to the extent that the underlying loss would have been eligible had the recipient itself claimed before the Commission.³

III. COMPENSABILITY OF INSURANCE AND EXPORT CREDIT CLAIMS

A. The underlying loss and the insurers' right of subrogation

- 17. The third instalment claims have been submitted by export credit agencies or their agents and insurers as well as other entities (the "claimants") in respect of indemnity payments to policyholders, non-payment in respect of loans to Iraqi parties and non-contractual payments for losses that were said to be a direct result of Iraq's invasion and occupation of Kuwait.
- 18. The Panel considered the eligibility of insurance claims for compensation in paragraphs 31 to 36 of the First E/F Report. The Panel recommended that payments by insurance entities for which compensation is sought must satisfy two criteria to be eligible for compensation:
- (a) Such payments must have been made in respect of underlying losses (i.e. losses suffered by policyholders) that were a direct result of Iraq's invasion and occupation of Kuwait; and
- (b) The underlying loss must have been compensable under the particular insurance policy (i.e. the claimant must have been obligated to pay its policyholder under the terms of the relevant policy).

19. The Panel has applied the same criteria to the third instalment claims, except in the circumstances described in paragraph 16 above.

B. Quantum of compensation

1. Valuation

- 20. The Panel has applied to the third instalment claims the valuation methodology used in the first and second instalment claims (see paragraphs 37 to 43 of the First E/F Report and paragraphs 22 to 24 of the Second E/F Report).
- 21. Accordingly, the Panel recommends awards of compensation to claimants for the actual value of the underlying loss suffered by a claimant's policyholder, rather than the agreed or contractually defined value of the asset lost (see paragraph 39 of the First E/F Report). This is subject to the condition that, where the value of the underlying loss is greater than its agreed or contractually defined value, a claimant may receive compensation for no more than the insured value it actually paid (see paragraph 41 of the First E/F Report).
- 22. For the purposes of assessing the value of the underlying loss, the Panel has followed the recommendations it made in this respect in the First E/F Report. For claims in relation to loss of goods, the Panel recommends awards of compensation based on the actual value of the lost consignment, which is normally the invoice value of the goods, not the contractually uplifted value (see paragraph 43 of the First E/F Report). Where the invoice value includes the cost of the insurance premium, the Panel finds that the premium paid in relation to a consignment of goods is part of the underlying loss and is, therefore, compensable (see paragraph 43 of the First E/F Report).

2. Date of underlying loss

23. The date of the underlying loss is the date on which the actual loss was suffered by the policyholder. The Panel chooses this date, rather than any date of loss defined in the policy, so that Iraq will not benefit, or suffer, from fluctuations in market values resulting from the application of a term of a policy to which it was not a party (see paragraph 44 of the First E/F Report). The date of underlying loss should be contrasted with the date of compensable loss (see paragraphs 38 to 40 below).

3. Uninsured amounts

24. In order to account for uninsured amounts, the Panel has followed the approach set out in paragraphs 45 and 46 of the First E/F Report in reviewing the third instalment claims. Accordingly, where an uninsured percentage applied, the recommended compensation to an insurer in this report is based upon the insured percentage of the compensable loss. Alternatively, where the policy applied an excess or deductible (i.e. uninsured amount), the full amount of any excess is deducted from the compensable loss.

4. Premiums

25. The Panel does not recommend the deduction of premiums from compensation awards, as it is not possible to formulate a general principle for the deduction of premiums that could be accurately applied in all cases (see paragraphs 47 to 52 of the First E/F Report). If, however, the claimed amount does not include the premium, the claimant can recover no more than the amount that it has claimed.

5. Incidental losses

- 26. In the First E/F Report (see paragraphs 53 and 54), the Panel considered that there might be circumstances in which incidental losses (i.e. costs incurred by claimants in their capacity as insurers, specifically as a result of handling claims for losses which were a direct result of Iraq's invasion and occupation of Kuwait) are eligible for compensation. To be so eligible, the Panel recommended that those losses must have:
 - (a) Been direct losses, resulting from Iraq's invasion and occupation of Kuwait;
- (b) Had a sufficient connection with the underlying loss, being incurred in mitigation of the underlying loss; and
 - (c) Been necessarily and reasonably incurred.

IV. EVIDENTIARY REQUIREMENTS

- 27. A claim must be supported by sufficient evidence to demonstrate that it is eligible for compensation pursuant to paragraph 16 of Security Council resolution 687 (1991). Specifically, article 35(3) of the Rules provides that claims of Governments or international organizations, corporations and other entities must be supported by documentary and other appropriate evidence sufficient to demonstrate the circumstances and amount of the claimed loss.⁴
- 28. Thirty claimants in the third instalment, including the five claimants whose claims were transferred (see paragraph 3 above), submitted their claims on category "E" claim forms. Ten claimants in the third instalment submitted their claims on category "F" claim forms, being claims of governmental agencies.
- 29. The instructions for the submission of claims and supporting evidence, as set out in the category "E" claim form, are described in paragraph 59 of the First E/F Report.
- 30. The category "F" claim form also required all Governments or international organizations that filed claims to submit with their claim forms a "separate statement explaining their claim ('statement of claim'), supported by documentary and other appropriate evidence sufficient to demonstrate the circumstances and the amount of the claimed loss". Claimants were instructed to include in the statement of claim the following particulars:
 - (a) The date, type and basis of the Commission's jurisdiction for each element of loss;

- (b) The facts surrounding the claim;
- (c) The legal basis for each element of the claim; and
- (d) The amount of compensation sought with an explanation of how this amount was calculated.
- 31. The Panel has required the same nature and specific types of evidence for the third instalment claims, and applied the same methodology in relation to evidentiary shortcomings, as it did in the first instalment (see paragraphs 60 to 78 of the First E/F Report). As set out in the First E/F Report, the Panel's approach to the verification of claims balances the claimant's inability always to provide the best evidence against the "risk of overstatement" introduced by shortcomings in evidence (see paragraphs 72 and 73 of the First E/F Report).

V. MITIGATION

- 32. Insurers (like all claimants before the Commission) are under a duty to take all reasonable steps to mitigate their losses. An award of compensation will be reduced to the extent that the claimed losses could reasonably have been avoided. In certain circumstances expenses reasonably incurred in mitigation of a loss are compensable (see paragraph 81 of the First E/F Report). The Panel considered this subject in the First E/F Report (see paragraphs 79 to 82) and followed the same approach in relation to the second instalment claims. Likewise, the Panel has followed the same approach in relation to the third instalment claims.
- 33. In one of the third instalment claims the claimant, a governmental entity, provided a guarantee to an exporter in respect of the export of goods to a buyer in Iraq. The claimant agreed to provide coverage and issued a policy after the exporter had suffered the losses that were insured (i.e. after the risk of non-payment due to Iraq's invasion and occupation had eventuated). The Panel recommends that no compensation be awarded to the insurer in this claim because, in issuing a policy with retroactive effect after Iraq's invasion and occupation of Kuwait, it had increased rather than mitigated its losses.

VI. AVOIDANCE OF MULTIPLE RECOVERY

- 34. The Panel avoids awarding compensation for the same loss more than once (i.e. multiple recovery), in the ways described in paragraphs 84 to 89 of the First E/F Report. In summary, the Panel recommends that:
- (a) Where a claimant has already received compensation in another forum or from another source for the same loss as that claimed in the third instalment, the amount already received by the claimant should be deducted from the amount of the compensation recommended by the Panel; and

- (b) Where the Commission has already awarded compensation for the same losses as those claimed in the third instalment claims, the amount already awarded should be deducted from the amount of the compensation recommended by the Panel.
- 35. As mentioned in paragraph 3 above, nine of the third instalment claims were made by export credit agencies in respect of losses suffered by insured exporters. Some of these exporters also claimed before the Commission for the same losses, in other categories of claims. Four of the exporters submitted third instalment claims for their portion of these losses (see paragraph 14 above). Two of these exporters filed contingent claims, to proceed before the Commission only if no compensation was recommended for the related export credit agencies' claims. These claims are discussed in paragraph 47 below.
- 36. The Panel instructed the secretariat to carry out cross-category checks in other claims categories to identify any claims by insured exporters or exporters which had received non-contractual payments (see paragraphs 14 and 16 above). The Panel also requested the secretariat to investigate whether the importer had filed a claim in respect of the goods and services that the exporter had contracted to provide. The Panel reviewed the evidence provided by the exporters and importers in their claims and took such evidence into account, where relevant, in its review of the related third instalment claims.
- 37. For example, one of the third instalment claims seeks compensation for the non-payment for goods shipped to a purchaser in Kuwait. The Panel reviewed the evidence in the related files of the French exporter and the Kuwaiti importer and noted that, although the exporter had been indemnified for its loss by the claimant insurer, the importer had sought compensation for the same goods, which it asserted were destroyed as a direct result of Iraq's invasion and occupation of Kuwait. The "E4" Panel of Commissioners recommended an award of compensation for the Kuwaiti importer in respect of these goods. In order to avoid multiple recovery, the Panel does not recommend any award of compensation to the third instalment claimant for non-payment for these goods.

VII. INCIDENTAL ISSUES

A. <u>Date of compensable loss</u>

- 38. The date of compensable loss is the date of loss for the purposes of calculating interest and establishing the appropriate exchange rates to be used (see paragraph 90 of the First E/F Report).
- 39. As set out in paragraphs 90 to 94 of the First E/F Report, the Panel recommends that interest be calculated from the date of payment, where proved, by the claimant to its policyholder. This is the date of loss for the claimant, i.e. the date that it was deprived of the use of money that it paid to the policyholder. The only exception to this is where the insurer has paid the policyholder prior to the expiry of a "waiting period" set out in the applicable policy, in which case the date of compensable loss should be the date of the expiry of the waiting period. In respect of the non-contractual payments which are the subject of some of the third instalment claims (see paragraph 16 above), the Panel recommends that interest be calculated from the date of payment by the governmental entity.

40. In the absence of evidence that establishes conclusively the date of compensable loss, the Panel has followed the recommendations set out in paragraphs 92 to 94 of the First E/F Report. Where there is evidence of payment to the policyholder (or to the recipient of a non-contractual payment), but not of the date of receipt of payment, the date of compensable loss should be the date 120 days after the date on which the claimant insurer drew its cheque or, if that date is not known, 120 days after the date on which the claimant dispatched the cheque to the policyholder. Where payment was made by electronic transfer, the date of compensable loss should be the date on which the claimant's account was debited. If there is no evidence that the claimant's account was debited, the date of compensable loss should be the third day after the date on which transfer instructions were given. In the absence of evidence of payment, but where there is verifiable evidence of the date of receipt of payment, the date of compensable loss should be the latter date.

B. Currency exchange rate

41. The Commission issues its awards in United States dollars. As set out in paragraphs 95 and 96 of the First E/F Report, the Panel recommends that the appropriate exchange rate to be applied to the third instalment claims in currencies other than United States dollars should be the rate prevailing in the United Nations Monthly Bulletin of Statistics on the date of compensable loss.

C. Interest

42. Governing Council decision 16 (S/AC.26/1992/16) states that the Governing Council will consider the methods of calculation and of payment of interest at the appropriate time. For this reason the Panel makes no recommendation in relation to the payment of interest. In accordance with paragraph 98 of the First E/F Report, however, the Panel recommends that the date from which interest is to run for the third instalment claims is the date of compensable loss.

D. Claim preparation costs

43. As the Governing Council intends to resolve the issue of claim preparation costs at a future date (see paragraph 99 of the First E/F Report), the Panel makes no recommendation as to claim preparation costs for the third instalment claims.

VIII. THE CLAIMS

A. Factual background

- 44. The Panel described the events surrounding Iraq's invasion and occupation of Kuwait and the effects thereof in paragraphs 100 and 101 of the First E/F Report. Against this background, the claimants in the third instalment claims asserted losses that relate to two distinct categories of underlying losses (see paragraph 3 above):
- (a) Contract-related losses, including losses under financing arrangements, export credit insurance policies and other government indemnities to exporters; and
 - (b) Other losses, being payments for unlawful detention.

B. Contract-related losses

1. Financing arrangements

(a) Summary of the relevant facts

- 45. One claimant (the financial institution described in paragraphs 3, 14 and 15 above) submitted 20 claims arising out of loan agreements between the claimant as lender and various entities of the Government of Iraq ("Iraqi entities"). The loans were to finance payment by the Iraqi entities to German exporters under various supply and construction contracts relating to projects in Iraq. The claimant made additional loans to the Iraqi entities between 1983 and 1989 pursuant to supplemental loan agreements. In many cases the financial institution and the Iraqi entities executed further "prolongation agreements" between 1987 and 1988, agreeing to defer the payment obligations under the original loan agreements. Following the failure of the Iraqi entities to pay instalments due under these agreements, the claimant, the Iraqi entities, the exporters and their respective Governments agreed to reschedule some or all of the amounts due. The claimant asserted that the Iraqi entities failed to pay instalments due under the various loan agreements or rescheduling agreements (together, the "financing arrangements") as a direct result of Iraq's invasion and occupation of Kuwait.
- 46. As stated in paragraphs 14 and 15 above, the export credit agency that insured the exporters (and, in respect of some transactions, the financial institution) has also claimed before the Commission in two of the third instalment claims (see paragraph 51 below).
- 47. As mentioned in paragraph 3 above, four of the third instalment claims were made by the exporters involved in these supply and construction contracts. These exporters guaranteed a portion of the loans advanced to the Iraqi entities (see paragraph 14 above). Each claimant seeks compensation for the amount of its liability under the guarantees.

(b) Evidentiary requirements specific to financing arrangements

- 48. In all of these claims, the Panel required evidence of the financing arrangements. The Panel also required evidence of the due dates for payment under the financing arrangements as well as evidence of whether the failure to pay amounts due under the financing arrangements was a direct result of Iraq's invasion and occupation of Kuwait.
- 49. In the light of the Panel's recommendations set out in paragraph 50 below, the Panel also required evidence of the contracts that were the subject of the financing arrangements and the dates of performance of the exporters' obligations under those contracts. The dates of performance are relevant to whether the loans relate to debts of Iraq "arising prior to 2 August 1990", within the meaning of Security Council resolution 687 (1991).

(c) Analysis and recommendations

50. The Panel considers that two of the claims did not satisfy the evidentiary requirements set out in paragraphs 48 and 49 above. The remaining claims are based on loans that were due for payment

and then renegotiated and rescheduled prior to 2 August 1990. These loans specified the particular purpose for which the funds were provided. In considering similar claims, the "E2" Panel found that such specific purpose loans "are payment mechanisms for the underlying transactions (construction, sale or other provision of goods or services)" and recommended that claims based on these loans must be subject to the same jurisdictional criteria as those that apply to the underlying transaction. The "E2" Panel has recommended that where performance of the underlying transaction was completed prior to 2 May 1990 and is, therefore, outside the Commission's jurisdiction, the associated specific purpose loan is also outside the Commission's jurisdiction, irrespective of the due dates of payment under the loan. The Panel agrees with the approach of the "E2" Panel and finds that the underlying contracts that were the subject of the loans in these claims were all performed before 2 May 1990. The Government of Iraq has asserted that such claims are outside the Commission's jurisdiction, as they relate to debts of Iraq that arose prior to 2 August 1990. The Panel agrees with this assertion and recommends that no compensation be awarded for these claims.

2. Export credit losses

(a) Summary of the relevant facts

- Nine claimants seek compensation for payments under export credit policies provided to exporters and contractors. At paragraph 122 of the First E/F Report, the Panel noted that export credit policies do not generally cover the loss of goods themselves, but rather losses relating to the costs incurred in, or amounts due from, the performance of export sale contracts. The claimants claimed for payments made under export credit guarantees to exporters in relation to contracts with Iraqi and Kuwaiti parties. The losses relate to non-payment by the importers for goods or services supplied by the exporters or losses incurred by exporters due to their inability to fulfil contractual obligations as a direct result of Iraq's invasion and occupation of Kuwait. These losses include costs incurred in redirecting shipments of goods in transit at the time of Iraq's invasion and occupation of Kuwait.
- 52. One of these nine claimants guaranteed a government entity that had provided an export credit policy to an exporter. The claimant states that the exporter suffered losses because it was prevented from exporting goods as a direct result of Iraq's invasion and occupation of Kuwait.
- 53. Another of these claimants, a bank, seeks compensation for losses arising out of contracts for the delivery of goods by an exporter to an Iraqi party. The goods were to be paid for by means of documentary credits issued by an Iraqi bank. The goods were shipped and the Iraqi party paid the value of the contract to the Iraqi bank, which failed to transmit this amount to the policyholder. The claimant sought compensation on behalf of the export credit agency which guaranteed the policyholder's export contract.
- 54. Another of the claimants seeks compensation for losses that include the interest it incurred on payments to policyholders for shipments for which the buyers paid late (see paragraph 64 below).

(b) Evidentiary requirements specific to export credit losses

- 55. In respect of contracts with Kuwaiti parties, the Panel required the same evidence as that described in relation to the claims for export credit losses in the first instalment claims (see paragraphs 126 to 133 of the First E/F Report). That is, in addition to the evidence described in paragraph 68 of the First E/F Report, the Panel required evidence of the underlying contract between the buyer and the seller or the contractor and the principal and, if applicable, evidence of presentation of the documents required under a letter of credit in accordance with its terms.
- 56. The Panel required the same evidence in relation to contracts with Iraqi parties. In addition, the Panel required evidence of the dates of performance of the underlying export contracts in order to determine whether the Iraqi importer's obligation is a debt of Iraq arising prior to 2 August 1990 (see paragraphs 22 to 25 of the First E/F Report). In relation to such contracts financed by letters of credit, the Panel required evidence of presentation of the documents required under a letter of credit in accordance with its terms (for the reasons set out in paragraph 61 below).

(c) Analysis and recommendations

- 57. Many of these claimants request compensation for payments made under policies covering numerous transactions. The Panel examined each of these transactions according to the evidentiary requirements described in paragraphs 55 and 56 above and reports its recommendations in annex III below, with each transaction identified separately by either policyholder or the relevant contract.
- 58. In relation to contracts with Kuwaiti parties, the Panel follows its recommendations set out in paragraphs 134 to 137 of the First E/F Report and paragraphs 138 to 140 of the First E/F Report concerning goods diverted or retained. In one claim, the claimant sought compensation for the time taken by the policyholders' employees in repacking goods destined for Kuwait but retained due to Iraq's invasion and occupation of Kuwait. The Panel does not recommend that compensation be awarded for these elements of the claim, as the policyholder would have incurred the salary costs in any event. The Panel considers that such costs are not, therefore, losses incurred as a direct result of Iraq's invasion and occupation of Kuwait.
- 59. In relation to contracts with Iraqi parties, the Panel adopts the recommendations of the "E2" Panel⁸ that, apart from the trade embargo and its related measures, the actions of Iraq's officials during Iraq's occupation of Kuwait, the military operations to liberate Kuwait and the ensuing breakdown in civil order in Iraq directly caused Iraq's failure to pay its debts after 2 August 1990. The "E2" Panel found that the contractual obligations of Iraqi purchasers and Iraqi banks in respect of goods delivered before the invasion were generally not paid after 2 August 1990 as a direct result of Iraq's invasion and occupation of Kuwait. Accordingly, resulting losses are direct within the meaning of paragraph 21 of Governing Council decision 7 (S/AC.26/1991/7/Rev.1) and are eligible for compensation in principle. Where however the evidence is that freezing orders adopted by individual States were the sole cause of the non-payment by the Iraqi parties, claims are not eligible for compensation. ⁹
- 60. The Panel also adopts the recommendations of the "E2" Panel that "the compensable period for losses arising from Iraq's failure to pay its debts shall be defined as 2 August 1990 to 2 August

- 1991".¹⁰ The "E2" Panel found that beyond 2 August 1991 the economic and other consequences of Iraq's invasion and occupation of Kuwait would have abated and Iraq's invasion and occupation of Kuwait could no longer be deemed to be the direct cause of Iraq's non-payment of its obligations.¹¹ Accordingly, where the payment obligations of an Iraqi party became due after 2 August 1991 a claim for losses based on this debt is not eligible for compensation.
- 61. The "E2" Panel has recommended that either the sales contract or, if the contract was financed by a letter of credit issued by an Iraqi bank, the letter of credit may be considered as the basis for the Commission's jurisdiction. ¹² If the letter of credit is considered as the basis for jurisdiction, claims for unpaid amounts due by an Iraqi buyer may be compensable if the documents required under the letter of credit were presented to the bank on or after 2 May 1990 and the period between shipment and presentation of the documents did not exceed 21 days. ¹³ The Panel followed this recommendation when considering the first of the claims described in paragraph 65 below.
- 62. In relation to the interruption of contracts with Iraqi parties (i.e. goods destined for Iraq but diverted or retained), the Panel adopts the recommendations of the "E2" Panel¹⁴ that the performance of contracts for the supply of goods to Iraq between 2 August 1990 and 2 March 1991 was rendered impossible as a direct result of Iraq's invasion and occupation of Kuwait and continued to be impossible until 2 August 1991. Accordingly, losses arising from the interruption of contracts with Iraqi parties during this period are eligible for compensation.
- 63. In the claim described in paragraph 53 above, there is insufficient evidence that the claimant is authorized to claim on behalf of the export credit agency or the policyholder. Accordingly, the Panel does not recommend that compensation be awarded for this claim.
- 64. In the claim described in paragraph 54 above, there is no evidence that the delay in payment by the buyers and consequent incurring of interest was a direct result of Iraq's invasion and occupation. Accordingly, the Panel recommends that no compensation be awarded for the interest on the payments that the claimant subsequently recovered.
- 65. In one of the claims, payment under a supply contract was to be effected under a letter of credit. The exporter did not comply with the terms of the letter of credit. Payment under the letter of credit was conditional upon compliance with its terms. Accordingly, the Panel recommends that the claim is not eligible for compensation, as the loss was caused by the failure to comply with the terms of the letter of credit rather than as a direct result of Iraq's invasion and occupation of Kuwait. In another claim, where the policyholder failed to show that it had presented documents promptly for payment under a letter of credit, the Panel recommends that the award of compensation be adjusted to reflect the policyholder's failure to mitigate its losses.

(d) Basis of valuation

66. The Panel follows the basis of valuation as set out in paragraphs 141 to 143 of the First E/F Report. Accordingly, compensation for claims relating to export credit contracts should be based on the invoice value of the goods that were the subject of the export sale contract together with any freight and handling charges and the insurance premium payable in respect of the contract. Where

goods were resold, the measure of loss is the difference between the original contract price and the resale price, plus any reasonable incidental costs to the extent that these costs were incurred in mitigation of the loss. Similarly, in respect of claims relating to export contracts for services performed, compensation should be based on the invoice value of those services together with any reasonable incidental costs incurred in mitigation of the loss.¹⁵ The Panel applied the same basis of valuation to claims for losses arising out of contracts with Kuwaiti and Iraqi parties.

3. Other government indemnities to exporters

(a) Summary of the relevant facts

67. Two claimants, both governmental entities, seek compensation for payments they made to exporters for losses, including resale losses, arising under contracts for the supply of goods and services to Iraqi buyers (see paragraph 16 above). These payments resulted from governmental decrees and decisions taken after Iraq's invasion of Kuwait on 2 August 1990 rather than from contractual obligations arising from policies issued by the governments' export credit agencies.

(b) Evidentiary requirements specific to government indemnities to exporters

- 68. The Panel required the same types of evidence as that described in relation to claims for contractual losses (see paragraphs 57 to 59 and 126 of the First E/F Report and paragraph 58 of the Second E/F Report). That is, the Panel required evidence of the underlying contracts between the parties. The Panel also required evidence that payment was received by the exporter from the governmental entity (consistent with the requirement in relation to insurers, as described in paragraph 68(g) of the First E/F Report).
- 69. The Panel finds that in order to recover compensation for the loss of payment under a contract, where goods or services were actually received by the buyer, the claimant must show that the buyer's failure to pay under the contract was a direct result of Iraq's invasion and occupation of Kuwait. The Panel therefore required evidence of the due date for payment under the contract. The Panel also required evidence of the dates of performance under the contracts. In respect of contracts with Iraqi parties, this evidence is relevant to whether the failure to pay was a direct result of Iraq's invasion and occupation of Kuwait or whether the debt arose prior to Iraq's invasion and occupation of Kuwait.
- 70. In claims where goods were resold, the Panel required the claimant to provide satisfactory evidence of the amount of the resale proceeds, to establish the existence of a loss. In respect of additional costs incurred to divert, store or re-sell goods destined for Kuwait or Iraq (storage, demurrage, warehousing, additional insurance or resale expenses), the Panel required specific evidence of those costs in the form of, for example, invoices detailing the amount of these expenses and the dates on which they were incurred, as well as evidence that such costs were reasonable and necessarily incurred.¹⁶

(c) Analysis and recommendations

- 71. In respect of these claims, the Panel finds that the claims are in principle eligible for compensation for the reasons set out in paragraph 16 above. The Panel finds however that those claims relating to non-payment of debts by Iraqi parties arising prior to Iraq's invasion and occupation of Kuwait (i.e. where performance giving rise to the original debt was rendered by the policyholder prior to 2 May 1990) are not eligible for compensation as they are outside the jurisdiction of the Commission. ¹⁷ In respect of losses arising out of non-payment for goods delivered to an Iraqi party, the Panel has followed the recommendations set out in paragraphs 22 to 25 of the First E/F Report.
- 72. In one claim where consignments were due to be sent to Iraq after the trade embargo came into force, the Panel finds that some of the losses were due solely to the trade embargo imposed against Iraq pursuant to Security Council resolution 661 (1990) and are, therefore, not eligible for compensation.¹⁸

C. Other losses

1. Summary of the relevant facts

73. One of the third instalment claims included a claim for compensation in relation to a government indemnity to a company in respect of the forced detention of four employees detained in Iraq following the invasion and occupation of Kuwait.

2. Evidentiary requirements specific to other losses

74. The Panel applied the same specific evidentiary requirements as those set out in paragraphs 215 to 217 of the First E/F Report. The Panel required evidence that the detained employees were on the employer's payroll, evidence of the occurrence of the detention and evidence that payments were made to the employer for the amounts paid to its employees.

3. Analysis and recommendations

75. The Panel adopts its recommendations set out in paragraph 218 of the First E/F Report that payments made by an employer to employees and their dependants, including humanitarian expenses, are eligible for compensation. In relation to government indemnities, the Panel has followed the approach set out in paragraph 16 above. As however the claimant did not submit evidence to substantiate the losses described in paragraph 73 above, the Panel makes no recommendation of compensation in respect of this claim.

IX. RECOMMENDATIONS OF THE PANEL

76. Based on the matters set out in this report, the Panel recommends that total compensation of USD 3,343,788, as set out in annex I below, be paid for direct losses suffered by the claimants as a result of Iraq's invasion and occupation of Kuwait.
