## **Competent national authorities under articles 7 and 17 of the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances of 1988**

The present directory lists all competent national authorities empowered to transmit or execute requests for mutual legal assistance or to receive and respond to requests for information about, and appropriate action in relation to, vessels suspected of being involved in illicit traffic by sea, in accordance with the provisions of articles 7 and 17 of the United Nations Convention against Illicit Traffic in Narcotic Drugs and Psychotropic Substances of 1988.

This listing of national authorities is issued pursuant to the 1988 Convention, in order to facilitate the exchange of information foreseen in articles 7 and 17 of that Convention. Its contents are based on data provided by Governments to the Secretary-General as required under the 1988 Convention, or in response to notes verbales transmitted by the Secretary-General to all States requesting full contact particulars of competent national authorities.

Article 7, paragraph 8, of the 1988 Convention requires parties to designate an authority or authorities with the responsibility and power to execute requests for mutual legal assistance or to transmit them to the competent authorities for execution. The transmission of requests and communications relating to them are to be effected between the designated authorities, although a party may require that such requests and communications be addressed to it through diplomatic channels and, in urgent circumstances, where the parties agree, through the channels of the International Criminal Police Organization (Interpol), if possible. Countries permitting urgent requests or communications through Interpol channels are indicated by the words "Request by Interpol: yes".

Article 17, paragraph 7, of the 1988 Convention requires parties to designate an authority or authorities to receive and respond to requests from another party for confirmation that a vessel that is flying its flag is entitled to do so, and to requests for authorization from the flag State to take appropriate measures in regard to that vessel.

## **Autorités nationales compétentes au titre des articles 7 et 17 de la Convention des Nations Unies contre le trafic illicite de stupéfiants et de substances psychotropes de 1988**

Le présent répertoire contient une liste de toutes les autorités nationales habilitées à transmettre des demandes d'entraide judiciaire ou à y répondre ou à recevoir des demandes d'informations ou des demandes de mesures appropriées concernant des navires soupçonnés de participer à un trafic illicite par mer et à répondre à ces demandes, conformément aux dispositions des articles 7 et 17 de la Convention des Nations Unies contre le trafic illicite de stupéfiants et de substances psychotropes de 1988.

Cette liste est publiée en application de la Convention de 1988 et vise à faciliter l'échange d'informations prévu aux articles 7 et 17 de cette convention. Elle est fondée sur les données fournies au Secrétaire général par les gouvernements en application de la Convention de 1988 ou en réponse à des notes verbales envoyées par le Secrétaire général à tous les États pour leur demander des détails complets sur les autorités nationales compétentes.

Le paragraphe 8 de l'article 7 de la Convention de 1988 stipule que les parties désignent une autorité ou, si besoin est, des autorités qui ont la responsabilité et le pouvoir de répondre aux demandes d'entraide judiciaire ou de les transmettre aux autorités compétentes pour exécution. La transmission de ces demandes et de toute communication y relative se fait entre les autorités désignées par les parties sans préjudice du droit de toute partie d'exiger que ces demandes et communications lui soient adressées par la voie diplomatique et, dans des cas urgents, si les parties en conviennent, par l'intermédiaire de l'Organisation internationale de police criminelle (Interpol), si cela est possible. Les pays qui autorisent des demandes ou des communications urgentes par l'intermédiaire d'Interpol sont indiqués par les mots "Demande émanant d'Interpol: oui".

Le paragraphe 7 de l'article 17 de la Convention de 1988 stipule que chaque partie désigne l'autorité ou, le cas échéant, les autorités habilitées à recevoir toute demande que lui adresse une autre partie en vue de déterminer si un navire qui bat son pavillon y est autorisé et à répondre à cette demande, ainsi qu'à toute demande visant à obtenir de l'État du pavillon l'autorisation de prendre les mesures appropriées à l'égard de son navire.

**Organismos nacionales competentes a los efectos de

En la presente guía figuran todos los organismos nacionales competentes que están facultados para transmitir o atender solicitudes de asistencia judicial recíproca o para recibir y atender solicitudes de información acerca de naves que se sospeche que están siendo utilizadas en el tráfico ilícito por mar y adoptar las medidas apropiadas al respecto, de conformidad con lo dispuesto en los artículos 7 y 17 de la Convención de las Naciones Unidas contra el Tráfico Ilícito de Estupefacientes y Sustancias Sicotrópicas de 1988.

Esta lista de organismos nacionales se publica de conformidad con la Convención de 1988 para facilitar el intercambio de información previsto en los artículos 7 y 17 de la Convención. Su contenido se basa en los datos proporcionados por los gobiernos al Secretario General con arreglo a la Convención de 1988 o en respuesta a las notas verbales enviadas por el Secretario General a todos los Estados, en las que solicitaba la información necesaria para ponerse en contacto con los organismos nacionales competentes.

El párrafo 8 del artículo 7 de la Convención de 1988 exige a las Partes que designen una o varias autoridades con facultades para dar cumplimiento a las solicitudes de asistencia judicial recíproca o transmitirlas a las autoridades competentes para su ejecución. Las autoridades designadas serán las encargadas de transmitir las solicitudes y las comunicaciones pertinentes, aunque cualquiera de las Partes podrá exigir que estas solicitudes y comunicaciones se le envíen por vía diplomática y, en circunstancias urgentes, cuando las Partes convengan en ello, por conducto de la Organización Internacional de Policía Criminal (OIPC/Interpol), de ser ello posible. Los países que aceptan que las solicitudes y comunicaciones urgentes se les envíen por conducto de la Interpol, se indican mediante las palabras "Solicitud por Interpol: sí".

El párrafo 7 del artículo 17 de la Convención de 1988 exige a las Partes que designen una o varias autoridades para que se encarguen de recibir las solicitudes de confirmación de que una nave que esté enarbolando su pabellón está autorizada a hacerlo, así como las solicitudes de autorización del Estado del pabellón para adoptar las medidas adecuadas con respecto a esa nave, y de responder a ellas.
