I. Introducción

1. El presente documento contiene un informe consolidado y un análisis del cuestionario relativo a la clasificación nacional y los procedimientos de control de los desechos enumerados en el anexo IX del Convenio de Basilea.
2. Este informe incluye:
 - a) una recopilación de las respuestas de las Partes al cuestionario relativo a la clasificación nacional y los procedimientos de control contenidos en los documentos de antecedentes siguientes:
 - i) UNEP/CHW/OEWG/1/INF/5;
 - ii) UNEP/CHW/OEWG/1/INF/5/Add.1;
 - iii) UNEP/CHW/OEWG/1/INF/5/Add.2;
 - iv) UNEP/CHW/OEWG/1/INF/5/Add.3;
 - v) UNEP/CHW/OEWG/2/INF/5;
 - vi) UNEP/CHW/OEWG/3/INF/14;
 - vii) Respuesta del Canadá recibida el 30 de junio de 2004;
 - b) Una recopilación de las respuestas de las Partes al cuestionario de la Comisión Europea (CE), y;
 - c) Un análisis comparativo de las respuestas a los dos conjuntos de cuestionarios.
3. Si bien no ha sido posible obtener el cuestionario original de la Comisión Europea ni las respuestas originales a él, se ha tratado de reunir la información necesaria de las fuentes descritas en el presente informe. El análisis indica que existe muy poca coherencia entre los dos conjuntos de respuestas. Ello puede atribuirse a que ni las preguntas ni las listas de desechos son idénticas en ambos regímenes. Tal vez la naturaleza reglamentaria de la comunicación de la Comisión Europea haya contribuido también a las discrepancias.

II. Antecedentes

4. En su sexta reunión, la Conferencia de las Partes, adoptó la decisión VI/19, que contenía los párrafos dispositivos siguientes:
 - “1. *Decide* aprobar el cuestionario relativo a los procedimientos nacionales de clasificación y control para la importación de desechos incluidos en el anexo IX (lista B de desechos) adjunto a la presente decisión (anexo II);
 2. *Pide* a la secretaría que distribuya dicho cuestionario entre todas las Partes y Signatarios.”
5. En el segundo período de sesiones del Grupo de Trabajo de composición abierta, que tuvo lugar en octubre de 2003, y en respuesta a una observación formulada por un representante en el sentido de que, como quedaba demostrado en la recopilación de las respuestas de las Partes al cuestionario relativo a la clasificación nacional y los procedimientos de control contenidos en el documento de antecedentes UNEP/CHW/OEWG/2/INF/5, existían numerosas discrepancias entre las respuestas al cuestionario de la Comunidad Europea y las del cuestionario del Convenio de Basilea, el Grupo de Trabajo convino en que era conveniente aclarar esa cuestión en el futuro. Así pues, se pidió a la secretaría que preparara una recopilación y un análisis de las respuestas recibidas a los citados cuestionarios para su presentación a la Conferencia de las Partes en su séptima reunión.
6. La lista de las Partes que respondieron a los cuestionarios del Convenio de Basilea y de la Comunidad Europea figura en el cuadro 1.

7. Este informe se ha preparado en respuesta a una solicitud formulada por el Grupo de Trabajo de composición abierta a la secretaría.

III. Tareas

8. De conformidad con el mandato para esta tarea, se pidió al consultor que, bajo la orientación del Oficial Superior de Programas (Técnico) de la secretaría del Convenio de Basilea, realizara las siguientes tareas:

a) Preparar un Informe Consolidado y un Análisis de las respuestas de las Partes al cuestionario relativo a la clasificación nacional y los procedimientos de control para la importación de los desechos enumerados en el anexo IX del Convenio de Basilea;

b) Durante la preparación del análisis mencionado, preparar un informe comparativo de la coherencia de esas respuestas con los procedimientos de control aplicados con arreglo al Reglamento (CEE) N° 259/93, de 1° de febrero de 1993, del Consejo de la Unión Europea, relativo a la vigilancia y

el control de los traslados de residuos desde el interior de la Comunidad Europea; a la entrada y a la salida;

c) Consultar de forma habitual con la secretaría, las Partes y la Comisión Europea durante la realización de las tareas descritas *supra*.

IV. Procedimientos

9. La fuente principal de información ha sido la secretaría del Convenio de Basilea, en particular, los documentos presentados al Grupo de Trabajo de composición abierta y los informes de los períodos de sesiones del citado Grupo.

10. Consultas en Internet relacionadas con el Convenio de Basilea, la Unión Europea, la Comisión Europea y la Organización de Cooperación y Desarrollo Económico.

11. También, se solicitó información sobre la Reglamento (CEE) N° 259/93 y el cuestionario conexo, así como su relación e interacción con las actividades del Convenio de Basilea a Bureau of International Recycling, de Bélgica y a la Dirección General de Comercio de la Comisión Europea. Por otro lado, se trató, sin éxito, de establecer contacto con expertos de Alemania y Suiza.

12. Sobre la base de la investigación y las respuestas recibidas a las solicitudes de información citadas anteriormente, este informe presenta la información como sigue:

V. Análisis de las repuestas a los cuestionarios relativos a los desechos enumerados en la lista B del anexo IX del Convenio de Basilea

13. Se examinaron y recopilaron todas las respuestas de las Partes al cuestionario incluido en la circular sobre la clasificación nacional y los procedimientos de control para la importación de los desechos incluidos en el anexo IX (lista B de desechos). Esas respuestas se obtuvieron del documento UNEP/CHW/OEWG/2/INF/5. También se ha incluido la respuesta recibida recientemente del Canadá al cuestionario del Convenio de Basilea.

14. La información se presenta en los cuadros A.1 a A.4. En los cuadros figuran los países que han respondido a cada una de las preguntas incluidas en los cuadros 2a, 2b, 2c y 2d del cuestionario respecto de cada tipo de desechos B1, B2, B3 y B4. Los países figuran en orden alfabético. Por ejemplo, la primera entrada indica que Argelia, Filipinas y Ucrania han optado por la respuesta 2a en relación con el desecho B1010.

15. Las preguntas relacionadas con la información sobre la clasificación nacional y los procedimientos de control para la importación de los desechos enumerados en el anexo IX (lista B) aplicadas por cada Parte son:

- Recuadro 2.a “¿Está el desecho específico de este renglón clasificado o considerado como peligroso por la legislación nacional de su país? En caso afirmativo, el desecho en cuestión se basa en el inciso b) del párrafo 1 del artículo 1 del Convenio de Basilea, clasificado como peligroso (clasificado como "desecho peligroso con arreglo al inciso b) del párrafo 1 del artículo 1"). Por consiguiente, se deben aplicar las regulaciones del Convenio de Basilea relativas a los movimientos transfronterizos.”

Recuadro 2.b “Sírvese indicar si en su país existe o no un procedimiento de control para la importación a su país de ese desecho. Si no existe un procedimiento de control, el desecho no está controlado durante un movimiento transfronterizo y se rige por el sistema aplicable a transacciones comerciales ordinarias.”

Recuadro 2.c “Sírvese indicar si la importación a su país del desecho específico de este renglón está sujeta al procedimiento de consentimiento fundamentado previo (CFP). Ello significa que las importaciones deben notificarse y únicamente se pueden efectuar con el consentimiento del (de los) país(es) de exportación, tránsito e importación. (Habitualmente, su país habrá clasificado o considerado esos desechos como peligrosos, es decir “desecho peligroso con arreglo al inciso b) del párrafo 1 del artículo 1”). ... No obstante cabe la posibilidad de que:

- a) el desecho específico de este renglón no esté considerado por su país como “desecho peligroso con arreglo al inciso b) del párrafo 1 del artículo 1”, sin embargo, su importación está controlada con arreglo a la normativa nacional aplicable, (en ese caso, rellene el recuadro 2.c);
- b) el desecho específico de este renglón no esté considerado por su país como "desecho peligroso con arreglo al inciso b) del párrafo 1 del artículo 1", sin embargo, su importación está prohibida con arreglo a la normativa nacional aplicable. (En ese caso, rellene el cuadro 2.d, y no, el recuadro 2.c).

Recuadro 2.d “¿Está prohibida en su país la importación del desecho específico de este renglón?”

16. Los datos correspondientes a cada país contenidos en los cuadros A.1 a A.4 se presenta en orden alfabético. Esta información figura en los cuadros B.1 a B.4 (apéndice B).

17. Las respuestas relativas a los desechos B1 (desechos de metales y que contengan metales) figuran en el cuadro B.1, las respuestas relativas a los desechos B2 (desechos que contengan principalmente constituyentes orgánicos, que a su vez puedan contener metales y materiales orgánicos) figuran en el cuadro B.2, las respuestas relativas a los desechos B3 (desechos que contengan principalmente constituyentes orgánicos, que puedan contener metales y materiales inorgánicos) figuran en el cuadro B.3, y las respuestas relativas a los desechos B4 (desechos que puedan contener constituyentes inorgánicos u orgánicos) figuran en el cuadro B.4.

18. Esos cuadros indican, por ejemplo, que Argelia optó por 2a y 2d para las respuestas de ese país relativas a los desechos B1010, B1020, B4020 y B4030.

19. En el cuadro 2 *infra* se presenta un resumen de los cuadros B.1 a B.4. Por ejemplo, el cuadro 2 indica que Bahrein marcó "no existe procedimiento de control" respecto de todos los desechos incluidos en el anexo IX (la lista B) del Convenio de Basilea, mientras que Polonia marcó "existen procedimientos de CFP" respecto de los desechos B2, B3 y B4.

20. No fue posible clasificar dentro de una categoría específica a los países restantes, a saber: Argelia, Egipto, Filipinas, Finlandia, Nueva Zelandia, Países Bajos, República de Macedonia, Suiza y Turquía.

21. Cabe señalar que Argelia, Filipinas, Nueva Zelandia y la República de Macedonia formularon respuestas únicamente en relación con un número limitado (es decir, menos de cinco) de categorías de desechos.

VI. Comparación entre las respuestas a los cuestionarios del Convenio de Basilea y del Reglamento (CEE) N° 259/93

22. Los envíos de residuos incluidos en la "lista verde" están, en general, excluidos del ámbito del Reglamento (CEE) N° 259/93, el cual se basa en la Decisión C(92)39 final de la OCDE. La OCDE considera que habitualmente esos envíos no deberían presentar, un riesgo para el medio ambiente si se recuperan correctamente en el país de destino.
23. No obstante, la Comisión Europea no deseó imponer este punto de vista a los países no miembros de la OCDE. Por tanto, el artículo 17 del Reglamento (CEE) N° 259/93 requiere que la Comisión notifique a todos los países que no son miembros de la OCDE de los desechos incluidos en la lista verde y se les pregunte si aceptarían envíos de esa clase de desechos para su recuperación sin recurrir a un procedimiento de control o, en caso contrario, que indiquen los procedimientos de control que requieren o desean que se apliquen.
24. Teniendo en cuenta la Reglamento (CEE) N° 259/93, la Comisión Europea envió una nota verbal a todos los países no miembros de la OCDE, con una triple finalidad: i) informar a esos países del nuevo Reglamento de la Comunidad Europea; ii) solicitar confirmación de sus posiciones respectivas descritas en los anexos de los reglamentos de la CE y de la OCDE; y iii) obtener una respuesta de los países que no habían respondido anteriormente.
25. Reviste importancia señalar que en su cuestionario, la Comunidad Europea utiliza la lista de residuos de la OCDE, mientras que, en el suyo, el Convenio de Basilea utiliza la lista B del anexo IX del Convenio.
26. Aunque, si bien no ha sido posible acceder al cuestionario original de la Comisión Europea ni a cada una de las respuestas originales de los países a él, se ha podido obtener una cierta idea de las preguntas a partir de los Reglamentos 1420/1999 y 1547/1999 y sus enmiendas, sobre la base de la información facilitada por la Dirección General de Comercio, Bureau of International Recycling (BIR) y el Boletín Oficial de las Comunidades Europeas.
27. Además, cabe inferir que las preguntas de ambos cuestionarios eran diferentes, en primer lugar, porque las lista de materiales utilizadas en el cuestionario de la Comisión Europea (anexo II del Reglamento (CEE) 259/93, la lista verde de desechos (de la OCDE y la UE)), difieren en todos los aspectos de la lista B del anexo IX del Convenio de Basilea y, en segundo lugar, las opciones respecto de los procedimientos de control en el ámbito de la Unión Europea son diferentes de los previsto en el Convenio de Basilea.
28. Con la información facilitada por BIR, en los cuadros C.1 a C.20 (apéndice C) se presentan el conjunto completo de respuestas al cuestionario del Convenio de Basilea junto con los tipos de desechos equivalentes de los códigos de la Unión Europea y la OCDE, y las respuestas de los países no miembros de la OCDE.
29. En esos cuadros, cada uno de ellos correspondiente a un país, se indican los elementos comunes y las discrepancias en las respuestas de 20 países no miembros de la OCDE. Cabe señalar que en esos cuadros y en el análisis se han incluido únicamente las respuestas disponibles de los países que respondieron a los cuestionarios del Convenio de Basilea y de la CEE.
30. Por ejemplo, en el cuadro C.1 (Argelia) se indica:

31. Los controles presentados en el Reglamento (CEE) 259/93 se interpretan del siguiente modo:

- Procedimiento ámbar – Procedimiento de notificación con consentimiento tácito;
- Procedimiento rojo – Notificación con consentimiento fundamentado previo;
- Procedimiento conforme al artículo 15 – Procedimiento de notificación complejo.

32. Si bien es necesario examinar detenidamente cada cuadro comparativo para percibir los elementos de coherencia y las discrepancias, a continuación se presentan observaciones generales en relación con los procedimientos de control:

Argelia:	Convenio de Basilea, prohibición de la importación de los desechos previstos en el Art.1 1) b; Reglamento (CEE) 259/93, no facilitó respuesta;
Argentina:	Convenio de Basilea, procedimiento de CFP; Reglamento (CEE) 259/93, procedimiento rojo;
Bahrein:	Convenio de Basilea, no procedimiento de control; Reglamento (CEE) 259/93, prohibición;
Bosnia y Herzegovina:	Convenio de Basilea, prohibición de la importación; Reglamento (CEE) 259/93, procedimiento rojo;
Brasil:	Convenio de Basilea, no procedimiento de control, procedimiento de CFP y prohibición de importación; Reglamento (CEE) 259/93, no procedimiento de control, procedimiento rojo y prohibición;
Bulgaria:	Convenio de Basilea, no procedimiento de control y procedimiento de CFP; Reglamento (CEE) 259/93, no procedimiento de control;
Camboya:	Convenio de Basilea, prohibición de la importación; Reglamento (CEE) 259/93, sin respuesta;
China:	Convenio de Basilea, prohibición de la importación; Reglamento (CEE) 259/93, no procedimiento de control;
Costa Rica:	Convenio de Basilea, no procedimiento de control; Reglamento (CEE) 259/93, prohibición;
Croacia:	Convenio de Basilea, procedimiento de CFP y prohibición de importación; Reglamento (CEE) 259/93, no procedimiento de control;

Ucrania: Convenio de Basilea, desechos previstos en el art.1, 1) b; Reglamento (CEE) 259/93, procedimiento rojo.

33. Como puede observarse, existe coherencia en las respuestas de un país, la Argentina, al cuestionario del Convenio de Basilea y a las preguntas incluidas en el Reglamento (CEE) 259/93. Se han observado discrepancias en las repuestas de todos los países no miembros de la OCDE.
