## **Cooperación internacional**

### **Nota de la secretaría**

#### **I. Introducción**

1. En su decisión VIII/7, la Conferencia de las Partes pidió a la secretaría que intensificase la cooperación y la coordinación con otras organizaciones internacionales y regionales y acuerdos ambientales multilaterales en esferas de interés para el Convenio de Basilea, en la medida en que lo permitieran los recursos disponibles. En la misma decisión, pidió a la secretaría que solicitase que se le concediese la condición de observadora en el Comité de Comercio y Medio Ambiente de la Organización Mundial del Comercio y que notificase a las Partes en el Convenio de Basilea cuando hubiese presentado esa solicitud a la Organización Mundial del Comercio y ésta le hubiese dado curso.

#### **II. Aplicación**

2. En el bienio 2007-2008 la secretaría emprendió varias actividades de cooperación con organizaciones internacionales y organizaciones no gubernamentales en los niveles tanto internacional como regional, que se describen en el anexo<sup>1</sup> de la presente nota.

3. En cumplimiento de la decisión VIII/7, el 18 de enero de 2007 la secretaría cursó una solicitud al Presidente del Comité de Comercio y Medio Ambiente en la que solicitaba que se otorgara la condición de observadora a la secretaría del Convenio de Basilea. Desde ese entonces la secretaría ha participado en las reuniones del Comité en calidad de observadora como invitada especial, hasta tanto se adopte una decisión final en relación con su solicitud.

### III. Medida propuesta

4. La Conferencia de las Partes tal vez desee considerar la posibilidad de adoptar una decisión del siguiente tenor:

*La Conferencia de las Partes,*

1. *Pide* a la secretaría que intensifique la cooperación y la coordinación con otras organizaciones internacionales y regionales y acuerdos ambientales multilaterales en esferas de interés para el Convenio de Basilea, que incluyan las esferas y las organizaciones que se enumeran en el anexo del documento UNEP/CHW.9/15;
2. *Pide también* a la secretaría que siga las tratativas para que se le conceda la condición de observadora en el Comité de Comercio y Medio Ambiente de la Organización Mundial del Comercio y que notifique a las Partes en el Convenio de Basilea cuando la Organización Mundial del Comercio le haya dado curso a su solicitud;
3. *Pide asimismo* a la secretaría que informe sobre la aplicación de la presente decisión a la Conferencia de las Partes en su décima reunión;
4. *Pide* a las Partes que coordinen sus actividades en los niveles nacional y regional con el fin de respaldar los esfuerzos que realiza la secretaría para intensificar la cooperación internacional.

Specifically, collaboration will focus on: (a) a promotional campaign that engages existing and prospective partners of the Secretariat of the Basel Convention; (b) a strategy to develop and market stories of success through multiple media platforms; (c) a Web strategy for the Basel Convention regional centres and the Secretariat of the Basel Convention (consistent branding while maintaining individuality) to improve reach and impact; (d) a strategy for Web-based technical assistance, and other mechanisms, to foster national implementation of the Basel Convention; and (e) a donor education campaign that includes the use of film and other media.</li> </ul>
