

Appointments to fill vacancies in subsidiary organs and other appointments

Appointment of members of the International Civil Service Commission

Note by the Secretary-General

- 1. As indicated in document A/72/104/Rev.1 of 17 July 2017, the General Assembly will be required, at its current session, to appoint five persons to fill the vacancies that will arise in the membership of the International Civil Service Commission, for a four-year term of office beginning on 1 January 2018.
- 2. The members of the Commission whose terms of office expire on 31 December 2017 are:

Wolfgang Stöckl (Germany) (Vice-Chair); Minoru Endo (Japan);

Luis Mariano Hermosillo Sosa (Mexico);

Aldo Mantovani (Italy);

Curtis Smith (United States of America).

Thus, the members to be appointed should come from the following regions:

One member from the Asia-Pacific States;

One member from the Latin American and Caribbean States:

Three members from the Western European and other States.

- 4. The appointment of the members of the Commission is governed by the provisions of articles 3–5 of its statute. Pursuant to those provisions, and in accordance with paragraphs 3 and 4 of section II of General Assembly resolution 43/226, the Secretary-General has undertaken consultations with Member States, through the Chairs of the various regional groups, with the executive heads of the other organizations, with staff representatives through the Federation of International Civil Servants' Associations and the Coordinating Committee for International Staff Unions and Associations of the United Nations System and with the Advisory Committee on Administrative and Budgetary Questions.
- 5. Following consultations among Member States, Mr. Kumamaru has been endorsed by the Asia-Pacific States and Mr. Mantovani, Mr. Mounts and Mr. Stöckl by the Western European and other States.
- 6. Thus, the Secretary-General hereby submits to the Fifth Committee for its consideration the list of candidates nominated for membership in the International Civil Service Commission for a four-year term of office beginning on 1 January 2018:
 - (a) From the Asia-Pacific States (one vacancy):

Aldo Mantovani (Italy)

Throughout his career, Ambassador Mantovani has accrued expertise in a broad array of fields, including organization and resource management, in addition to his background in international relations. As the head of the Department of Management at the Italian Ministry of Foreign Affairs for one budget cycle, he was responsible for the management of all the properties (owned and rented), including the allocation of resources needed for maintenance, of the approximately 240 Italian embassies and consulates and 80 National Cultural Institutes in the world.

Subsequently, he served for three years at the Human Resources Department, where he was in charge of proposing, managing and supervising the movements of 900 diplomats and 2,500 employees. In addition, he was in charge of negotiating, managing and supervising the contracts of 2,500 locally hired staff, with all the implications related to the potential conflicts arising from the differences between the Italian law and the local legislations. In his capacity, he was also in charge of negotiating with the Trade Unions all the matters concerning the implementation of his responsibilities (from the general framework to the most specific situations).

In his capacity as Deputy Permanent Representative of Italy to the United Nations, Ambassador Mantovani was in charge of organizing and coordinating the Mission's multiple activities for five and a half years, overseeing the work of the diplomatic staff (which grew from an initial 15 to 25 in the period of Italy's term on the Security Council). During this period, he took part, inter alia, in the biennial United Nations budget negotiations and in the process leading up to the adoption of the Millennium Declaration. On the Security Council he was one of the two official Italian representatives, in which role he expressed the positions and promoted the interests of Italy on all the major critical issues unfolding on the international stage.

Details of career

- Born in Florence, December 1945, Ambassador Aldo Mantovani received his degree in Political Science, with honors, from the University of Genoa.
- After his mandatory service in the Army, he won a one-year fellowship from the Italian Ministry of Foreign Affairs to specialize in International Relations at the Johns Hopkins University Center in Bologna.
- After entering the diplomat career, he served in the General Secretariat of the Italian Ministry of Foreign Affairs, the Italian Embassy in Paris, the Consulate General in Jeddah, the Italian Embassy in Washington DC (as Head of the Economic Section), and the Italian Embassy in Bern as Deputy Ambassador.
- At the Ministry in Rome, he was Head of the Department for Management of Assets Worldwide. After his promotion to the rank of Minister Plenipotentiary, he became Head of the Department for Diplomatic and Administrative Staff Mobility.
- In 2003 he was posted to New York as Deputy Permanent Representative of Italy to the United Nations with the title and rank of Ambassador.
- In 2009, he was appointed Ambassador of Italy to Poland, where he served for three years, receiving the Commander's Cross of Merit of the Polish Republic from President Komorowski.
- In December 2011, he returned to the Ministry in Rome and was assigned to the General Secretariat. Ambassador Mantovani has recently retired.

• In November 2013, he was elected by the General Assembly as a member of the International Civil Service Commission for a four-year term of office beginning on the 1st of January 2014.

He is fluent in English and French and has a rudimentary knowledge of German, Spanish and Polish.

Jeffrey Mounts (United States of America)

Jeffrey C. Mounts is the Managing Director for Global Compensation in the Office of the Comptroller/Global Financial Services (CGFS) at the U.S. Department of State. The Department of State Global Compensation Directorate pays over 90,000 employees in the United States and in more than 180 countries worldwide through 250 pay plans and approximately 140 currencies. Additionally, Mr. Mounts administers multiple defined benefit and defined contributions funds for former employees.

Mr. Mounts has 26 years of federal financial management and human capital compensation experience, including executive leadership and subject matter expertise in personnel and pay policy, worldwide payment execution and banking services, after-employment pension and benefit administration, corporate systems development and program management, and global shared services implementation and operation.

Notable projects overseen by Mr. Mounts include the implementation of a PeopleSoft Global platform to process payroll for over 60,000 locally-employed staff, and a new platform to process defined benefit payments for the Foreign Service Retirement and Disability Fund, as well as the development and implementation of a complex multi-currency global disbursing system which makes over \$15 Billion in Electronic Fund Transfer (EFT) and check payments per year. Mr. Mounts also led a new initiative, the Voluntary Leave Bank program, which allows employees to contribute to a shared leave bank for use by members in time of personal and family need.

Mr. Jeffrey Mounts represents the Department of State on the U.S. government Human Resources Line of Business and also on the Provider Council of the Unified Shared Services Management organization. He has previously served on the Executive Steering Board of the Office of Management and Budget and Chief Information Officer Council's Shared Services Subcommittee.

Mr. Mounts holds a Juris Doctorate from the University of Maryland School of Law, a Master of Public Management (Public Finance) from the University of Maryland, and a Bachelor of Science in Political Science/Education from South Dakota State University.
