ADOPTION OF THE AGENDA OF THE THIRTEENTH REGULAR SESSION AND ALLOCATION OF ITEMS TO COMMITTEES, AND ORGANIZATION OF THE SESSION

First report of the General Committee

1. The General Committee, at its 117th, 118th and 119th meetings held on 17 and 19 September 1958, considered the provisional agenda of the thirteenth session of the General Assembly (A/3846), the supplementary list of items (A/3894), and requests by the United States of America (A/3902) and by the Union of Soviet Socialist Republics (A/3915) for the inclusion of additional items, as contained in the memorandum of the Secretary-General relating to the adoption of the agenda and the allocation of items to Committees (A/BUR/148 and Add.1/Rev.1, English only). The Committee also considered two further requests for the inclusion of additional items, by the Ukrainian Soviet Socialist Republic (A/3920 and Add.1) and by the USSR (A/3925).

2. The Committee approved the suggestion of the Secretary-General (A/BUR/148, para. 3) that a new sub-item (c) be recommended for inclusion under item 29 entitled "Establishment of an international administrative service".

3. Attention having been drawn to action taken by the Economic and Social Council under its resolution 683 C (XXVI) in regard to freedom of information (A/BUR/148, para. 4), the Committee agreed to recommend the deletion from the agenda of the thirteenth session of sub-item (c) of item 35 entitled "Reports of the Economic and Social Council and of the Commission on Human Rights".

4. The Committee approved a suggestion by the Secretary-General (A/BUR/148, para. 5) that the annual budget of the International Atomic Energy Agency be considered under item 50: "Administrative and budgetary co-ordination between the United Nations and the specialized agencies".

5. The Committee further approved the wording suggested by the Secretary-General (A/BUR/148, para. 6) for sub-item (d) of item 53.

6. At the suggestion of the representatives of Indonesia and Ceylon, the Committee decided to include the item "The banning of the use of cosmic space for military purposes, the elimination of foreign bases on the territories of other countries and international co-operation in the study of cosmic space", proposed by the USSR, and the item "Programme for international co-operation in the field of outer space" proposed by the United States, as sub-items (a) and (b) respectively under the general heading "Question of the peaceful use of outer space".

7. The Committee approved, by 13 votes to 5, with 1 abstention (see A/BUR/SR.117, p. 8), a suggestion by the representative of the United States that item 61, proposed by Czechoslovakia, be reworded "Measures aimed at implementation and promotion of peaceful and neighbourly relations among States".

8. The representative of India explained that his Government, without prejudice to the merits of the question, did not wish to press for consideration of item 64 (The question of Antarctica) at the present time; the Committee therefore took note of the withdrawal of this item from the agenda of the thirteenth session.
9. After statements had been made by the representative of the Union of South Africa on items 62 (Treatment of people of Indian origin) and 69 (Question of race conflict in South Africa resulting from the policies of <u>apartheid</u> of the Government of the Union of South Africa); by the representatives of France, Australia, and Indonesia on item 65 (The question of Algeria); and by the representatives of Turkey, the United Kingdom of Great Britain and Northern Ireland, Greece and Australia on item 70 (The question of Cyprus), the Committee decided to recommend the inclusion of these items in the agenda.

10. The representative of Hungary made a statement on item 71 (The situation in Hungary); after discussion, the Committee decided, by 15 votes to 3, with 2 abstentions, to recommend the inclusion of the item in the agenda.
11. With regard to item 63 (Question of the representation of China in the United Nations), proposed by India, the representative of India was invited to the table and made a statement.

12. The representative of the United States proposed that the General Committee recommend to the General Assembly the adoption of the following draft resolution:

/ . . .

"The General Assembly

"1. Decides to reject the request of India for the inclusion in the agenda of its thirteenth regular session of the item entitled "Question of the representation of China in the United Nations";

"2. Decides not to consider, at its thirteenth regular session, any proposals to exclude the representatives of the Government of the Republic of China or to seat representatives of the Central People's Government of the People's Republic of China."

.3. After discussion, during which the question of the competence of the Committee to consider the draft resolution was raised, the Chairman ruled that the Committee vas competent to do so, under the rules of procedure. This ruling was challenged by the representative of the USSR. It was upheld by 10 votes to 3, with 7 abstentions.

14. A motion by the representative of the United States that priority in voting be given to the United States draft resolution over the Indian request for inclusion of the item was adopted by 10 votes to 4, with 5 abstentions.

.5. The United States draft resolution was then put to the vote by roll-call, with the following results:

Paragraph 1 was approved by 12 votes to 7, with 2 abstentions. Paragraph 2 was approved by 11 votes to 7, with 3 abstentions. The draft resolution as a whole was approved by 12 votes to 7, with

? abstentions.

16. The Committee's attention was drawn to resolution 683 F (XXVI) adopted by the Iconomic and Social Council at its twenty-sixth session recommending that the Beneral Assembly devote a special meeting, to be held on 10 December 1958, Human Rights Day, to the observance of the tenth anniversary of the signing of the Iniversal Declaration of Human Rights. The Committee agreed to recommend Accordingly to the General Assembly.

II. ALLOCATION OF AGENDA ITEMS TO COMMITTEES

18. The General Committee approved the allocation of items to Committees proposed by the Secretary-General in his memorandum (A/BUR/148) with the following modifications and additions:

(a) On the proposal of the representative of Australia, the Committee decided to recommend that sub-items (b) and (c) of the item on the United Nations Emergency Force be transferred from the plenary meeting to the Special Political Committee.

(b) After rejecting, by 12 votes to 6, with 2 abstentions, a proposal by the representative of the USSR that the item on effects of atomic radiation be transferred to the Special Political Committee, the Committee decided, on the proposal of the representative of the United Kingdom, by 13 votes to 4, with 2 abstentions, to recommend that the item "Measures aimed at implementation and promotion of peaceful and neighbourly relations among States" be transferred from the First Committee to the Special Political Committee.

(c) The Committee decided to recommend that chapter I, section VI, of the report of the Economic and Social Council, containing the Council's recommendation regarding an increase in the membership of the Council, should be referred also to the Second Committee for consideration, if possible prior to the matter being taken up in the Special Political Committee.

(d) The Committee decided to recommend that the two additional items proposed by the USSR (A/3915 and A/3925) be referred to the First Committee.

(e) After discussion, the Committee decided, on the proposal of the representative of Greece, that the item proposed by the Ukrainian SSR, regarding the organization of an international public health and medical research year (A/3920 and Add.1), be referred to the Third Committee, on the understanding that any financial, administrative or co-ordination implications would be referred to the Fifth Committee at the appropriate time.

(f) The Chairman drew attention to a resolution adopted on 27 April 1958 by the United Nations Conference on the Law of the Sea, regarding nuclear tests on the high seas (A/CONF.13/L.56, p. 2), and suggested that the resolution be referred to the First Committee for consideration under the relevant agenda item.

- 1. Report of the International Law Commission on the work of its tenth session.
- 2. Question of arbitral procedure.
- 3. Question of initiating a study of the juridical regime of historical waters, including historic bays.
- 4. Question of convening a second United Nations conference on the law of the sea.

III. ORGANIZATION OF THE THIRTEENTH REGULAR SESSION OF THE GENERAL ASSEMBLY

On the proposal of the Secretary-General (A/BUR/148), the General Committee recommends that the General Assembly approve the following arrangements relating to the schedule of meetings:

- (a) That both plenary and Committee meetings should begin at 10.30 a.m. and 3 p.m.
- (b) That a five-day working week be established, it being understood that extended morning meetings on Saturdays may be scheduled should this prove necessary.

The General Committee recommends that the General Assembly approve, in accordance with rule 2 of the rules of procedure, 12 December 1958 as the closing date of the thirteenth session. \Box
