#### INTRODUCTION

1. Pursuant to Governing Council decision 14/4 ot 18 June 1987 and Gameral Assembly recolution 42/185 of 11 Dwcember 1987, the first special session of the Governing Council of the United Nations Environment Programme (UNEP) was hold at UNEP headquarters, Nairobi, from 14 to 18 March 1988. The Council adopted the present report at the 7th mooting of the session, on 18 March 1988.

#### **CHAPTER I**

#### ORGANIZATION OF THE SESSION

## A. Opening of the session

2. The first special session was opened by Mr. J. Illueca (Panama), President of the Council.

3. In his opening statement, the President reviewed some of the major events related to international ac-operation in the field of the environment that had taken place since the fourteenth session of the Council and outlined the main tasks before the Council at its current session.

### C. Officers

12, According to rule 18 of the ruler of procedure, "at the comm/accoment of the first meeting of its regular session, the Governing Council rhall • leot a President, three Vice-Presidents and a Rnpporteur from among its members". Rule 19 provider that the President, Vice-Preridentr and Rapporteur shall hold office until their successors are elected (i.e., at the lrt meeting of the next regular session). Accordingly, the following officers, elected at the fourteenth regular session, continued to serve in their respective capacities at the first special session:

13, At the opening meeting of the session, the Counail was informed that Mr, Ansari (India), Vice-President of the Council, had apologised for being unable to attend the session and had nominated Mrs. M. Bhalla, head of the Indian delegation at the session, to perform hie functions in the Bureau.

#### D. Credentials

14. In accordance with rule 17, Paragraph 2, of the rules of procedure of the Council, the Bureau examined the credentials of the delegations attending the fourteenth session. The Bureau found the credentials in order and so reported to the Council, which approved the Bureau's report at the 7th meeting of the rerrion, on 18 March.

15. At the opening meeting of the session, the Council adopted the following agenda on the basis of the revised provisional agenda by the Executive Director (UNEP/GCSS.I/1/Re'.1):

- 1. Opening of the session.
- 2. Adoption of the agenda end organization of work.
- 3. Credentials of representatives.
- 4. System-wide medium-term environment programme (1990-1995) and the medium-term plan of the United Nations Environment Programme for the period 1990-1995.
- 5. Proposed revisions to chapter 12 ("Luvironment") of the current United Nations medium-term plan.
- 6. Adoption of the report.
- 7. Closure of the session.

16. The spokesman of the Latin American and Caribbean Group said that his group had no difficulty with the three topics proposed under items 4 and 5 of the agenda, but felt that since the Governing Council at its fourteenth session and the United Nations General Assembly at its forty-second session had approved the items "System-wide medium-term environment programme (1990-1995)" and "Revisions to the global programme on the environment of thm • rionded United Nations medium-term plan for the period 1984-1989" for the current special session, those t w o topics should be discussed first, after which the medium-term plan of the United Nations Environment Programme for the period 1990-1995 could be considered, within the time available at the session.

# F. Organization of the work of the session

17. At thr opening meeting of the session, the Governing Council considered and approved the organisation of the work of the session in the light of thr suggestions made by the secretariat in the annotations to the revised provisional agenda and tha timrtable of meetings suggested by the Executive Director (UNEP/GCSS.1/1/Rev.1/Add.1).

18. The Council also decided to establish an informal, optn-ended drafting group under the chairmanship of Me, D. Protsonk (Ukrainian SSR), with a core membership of two representatives from each regional group, in order to reach agreement on revisions or amendments to the system-wide medium-term environment programme (UNEP/GCSS.I/2 and Corr.1 and 2), the proposed medium-term plan of the United Nations Environment Programme (UNEP/GCSS.I/3 and Cot F. 1), and the proposed revisions to chapter 12 ("Environment") of the extended United Nationa medium term plan for the period 1984 -1989 (UNEP/GCSS.I/4, annex), and in order to seek consensus draft decisions before they were formally considered by the Council. 19. At the 6th meeting of the session, the Council decided that, in view of the heavy work-load before the drafting group, it would establish another open-ended drafting group, under the chairmanship of the President of the Courcil, to perform the second function entrusted to the drafting group that had been established at the opening meeting, i.e. to seek consensue on draft decisions before their submission to plenary for formal consideration. The drafting set up at the 1st meeting would continue to seek agreement on revisions or amendments to the system-wide medium-term environment programme, the proposed medium-term plan of the Uni ted Nations Environment Programme, and the proposed revisions to chapter 12 of the United Nations medium-term plan.

# G. Introductory statement by the Executive Director

20. At the opening meeting of the session, the Executive Director made an introductory statement focusing on the mail tasks before the Council in the light of General Assembly resolutions 42/186 and 42/187, in which the Assembly endorsed the Environmental Perspective to the Year 2000 and Beyond and welcomed the report of the World Commission on Environment and Devel constant entitled <u>Our Common Future</u>. 2/ The full text of the Executive Director's statement is contained in document UNEP/GCSS.I/6/Add.J and Corr.1.

#### **CHAPTER II**

#### MATTERS REQUIRING THE SPECIAL ATTENTION OF THE GENERAL ASSEMBLY AND/OR THE ECONOMIC AND SOCIAL COUNCIL

#### A. Action with respect to resolutions of the General Assembly

21. In paragraph 1 of its decision SS. I/1 of 18 March 1988, the Qoverning Council resolved to exercise fully the role expected of it with respect to environmental activities within the United Nations system, the follow-up of the Environmental Perspective to the Year 2000 and Beyond (see Qeneral Assembly resolution 42/186, annex), the report of the World Commission on Environment and Development, 2/ and the system-wide medium-term environment programme for the period 1990-1995, 2/ in accordance with the relevant resolutions of the Qeneral Assembly.

22. The Council also decided, in paragraph 2 of the same decision, to include in the provisional agenda of its fifteenth session an item entitled "Follow-up of the relevant resolutions of the forty-second and forty-third sessions of the Qeneral Assembly".

23. In paragraph 3 of the same decision, the Council requested the Execut?ve Director, using as appropriate the mechanism of the Designated Official6 for Environmental Matters, to provide the Council at its fifteenth session with the reports called for in paragraphs 10 and 18 of Qeneral Assembly resolution 42/187. In paragraph 4 of the same decision, the Council further requested the Executive Director to submit to it at its fifteenth session, for consideration and transmittal a8 appropriate to the Qeneral Assembly at its forty-fourth session, through the Economic and Social Council, a report containing proposed comments by the Qoverning Council on the reports referred to in paragraph 3 of the decision and on any other matters concerning progress on sustainable development that fell within the Council's mandate.

## B. <u>Environmental considerations in the international development</u> strategy for the fourth United Nations development decade

24. In paragraph 5 of its decision SS.1/1, the Qoverning Council emphasized its view that sustainable and environmentally sound development uhould be one of the main objectives of the new international development strategy, taking into account the Environmental Perspective to the Year 2000 and Beyond, and alco the analysis and recommendations contained in the report of the World Commission on Environment and Development, and invited the Executive Director to contribute fully and actively in the process of devolopment of the strategy.

# C. <u>System-wide medium-term environment programme</u> for the period 1990-1995

25. By paragraph 3 of decision \$.1/3 of 18 March 1988, the Governing Council approved the \$ystom-wide medium-term environment programme for the period 1990-1995, as submitted by the Administrative Committee on Co-ordination (UNEP/GCSS.1/2 and Corr. 1 and 2) and with the amendmen's proposed by the Bureau, subject to the preparation by the Administrative Committee on Co-ordination of a revision of the programme to be presented to the Council at its sixteenth session with a view, inter alia, to reflecting more closely the structure and recommendations of the Environmental Perspective to the Year 2000 and Beyond and the report of the World Commission on Environment and Development in the light of Qeneral Assembly resolutiona 42/186 and 42/187 of 11 December 1987.

26. By paragraph 11 of the same decision, the Council brought the system-wide medium-term environment programme for the period 1990-1995 to the attontion of the Qeneral Assembly. 3/

27. By paragraph 14 of the decision, the Council invited the governing bodies of the organizations and programmes of the United Nations system to take fully into account their objectives, plans and programme budgets the relevant aspects of the system-wide medium-term environment programme for the period 1990-1995, while in paragraph 15 it urged the organisations of the United Nations system to co-operate closely in the implementation of the programme, giving priority to developing countries in eaoh of the programmes areas.

## D. <u>Revisions to the global programme on the environment</u> of the extended United Nations medium-term plan for the period 1984-1989

28. In sccordanae with paragraph 3 of General Assembly resolution 42/185 of 11 December 1987, the Governing Council at its first special session considered appropriate changes to the global programme on the environment of the extended United Nations medium-term plan for the period 1984-1989 and, by paragraph 1 of its decision \$5.1/7 of 18 March 1988, took note of the proposed revisions submitted by the Executive Director (UNEP/GCSS. I/4, annex).

29, In accordanas with paragraph 2 of the same deci, ion, the comments of the Council on the proposed revisions are desmed to be the principles and objectives of the medium-term plan of the United Nations Environment Programme, as approved by the Council in its decision SS.I/6 of 18 March 1988.

30. By paragraph 3 of decision SS.1/7, the Council requested the Executive Director to transmit the above-mentioned comments, as well au the views expressed by delegations during the Council's deliberations on the proposed revisions, through the Committee on Programme and Co-ordination to the Qeneral Assembly at its forty-third session.

# E. <u>Co-ordination between the United Nations medium-term plan</u> and the system-wide medium-term environment programme

31. In paragraph 12 of its decision SS.1/3 on the eyotem-wide medium-term environment programme for the period 1990-1995, the Qoverning Council expressed its concern about the Aced to maintain maximum possible co-ordination between the United Nations Hadium-term plan and the system-wide medium-term environment programme, in the light of General Assembly resolution 2997 (XXVII) of 15 December 1972, which giver the United Nationo Environment Programme a oo-ordinating role on environmental policies and programmes within the United Nations system, and resolution 42/215 of 21 December 1987, by which the Accembly extended the United Nations medium-term plan for the period 1984-1989 to include 1990-1991.

32. In the same vein, by paragraph 4 of decision SS.1/7 on proposed revisions to the global programme on the environment of the extended United Nations medium-term plan for the period 1984-1989, the Governing Council recommended to the General Assembly that the global programme on the environment of the United Nations medium-term plan beginning in 1992 should be ctructured along the lines of the system-wide medium-term environment programme to ensure uniformity of content and to facilitate ao-ordination of the environmental activities being undertaken by the United Nationo system in the light of Aesembly resolutions 42/186 and 42/187 of 11 December 1987.

# F . Support for the Cairo Programme for African Co-operation

33. By oration I of its decision \$\$.1/5 of 18 March 1988, the Qoverning Council urged the governing bodies of the organisations of the United Nations system to give priority to the provision of financial and technical assistance for the effective implementation of each of the programme areas of the Cairo Programme for African Co-operation. \$/

#### **CHAPTER III**

# **ADOPTION** OF **DECISIONS\***

34, At the 7th meeting of the session, on 18 March, the Counail had before it a number of draft decisions submitted by the Bureau (UNEP/GCSS.I/L.29/Rev.1; UNEP/GCSS.I/L.34; UNEP/GCSS.I/L.35/Rev.1; UNEP/GCSS.I/L.36; UNEP/GCSS.I/L.37; UNEP/GCSS.I/L.38; UNEP/GCSS.I/L.39; and UNEP/GCSS.I/L.40). The Council adopted all the draft decisions by consensus, with the comments and amendments indicated below.

#### Programme policy and implementation (decision SS.I/1)

35. A draft decision on this subject was submitted by the Bureau (UNEP/GCSS.I/L.29/Rev.1).

36. On the proposal of the representative of Brazil, supported by the representative of Mexico, the Council decide& to change the wordo "in response to" in paragraph 1 (b) of the draft to "approved by the" and to change the same words in paragraph 1 (a) to "welcomed by".

37. On the proposal of the representative of Chile, *speaking on* behalf of the Group of Latin American and Caribbean States, the Counail also decided to delete Paragraph 6 of the draft decision.

38. The draft decision, as orally amended by the representatives of Chile and Brazil, was adopted by consensus.

39. The Executive Director stated that it was his understanding that, by deleting paragraph 6 of the draft decision, the Governing Council was indiasting that the Environment Fund should be used to finance requirementa, including preparations for sessions of the Council, that should normally be covered by the regular budget of the United Nations.

The 1990 state-of-the-environment report (decision SS.1/2)

40. A draft decision on this subject (UNEP/GCSS.I/L.34) was adopted by consensus and without comment.

System-wide medium-term environment programme for the period 1990-1995 (decision SS.I/3)

41. A draft decision on this subject was submitted by the Bureau (UNEP/GCSS.I/L.39).

42. On the proposal of the representative of France, supported by the representative of Chile, the Council decided to change the words "having considered further" in the third preambular paragraph of the draft to "having noted".

43. On the proposal of the representative of Brazil, supported by the representative of France and Chile, the Council also decided to amend paragraph 13 of the draft by *changing* the words "recommends for the consideration of *Governments*" to "takes note of" and by replacing the words "and welcomes them as usoful guidelines" by the words "as presented by the Administrative Committee an Co-ordination",

44. The draft decision, as orally amended by the representatives of Brazil and of France, was adopted by consensus.

# Regional and subregional programmes in Latin America and the Caribbean (decision SS.1/4)

45. A draft decision in this subject (UNEP/GCSS.I/L.36) was adopted by consensus and without comment,

# Support for the Cairo Programme for African Co-operation (decision SS.1/5)

46, Two draft decisions on this subject (UNEP/GCSS.1/L.37 and L.38) were adopted by consensus.

47. The representative of Japan said that, while he welcomed the consensus achieved on the draft decisions, it should be pointed out that the countries of Asia, as well as those of Africa, ought to be considered in the provision of priority assistance.

# Medium-term plan of the United Nations Environment Programme for the period 1990-1995 (decision SS.I/6)

48. A draft decision on this subject was submitted by the Bureau (UNEP/GCSS.I/L.40).

49. On the proposal of the representative of France, supported by the representative of Brazil, the Council decided to amend the second preambular paragraph of the draft by changing the words "having considered also" ta "having taken note of".

50. On the proposal of the representative of the United States of America, the Council decided to *emend* paragraph 3 of the draft by changing the words "with reference made to" to "in the light of" in the penultimate line of the paragraph.

51. On the proposal of the representative of France, supported by the representative of Brazil, the Council further decided to delete the second clause of paragraph 6 of the draft.

52. The draft decision, as orally amended by the representatives of the United States and France, was adopted by consensus.

Proposed revisions to the global programme on the environment of the extended United Nations medium-term plan for the period 1984-1989 (decision SS.I/7)

53. A draft decision on this subject was submitted by the Bureau (UNEP/GCSS.I/L.35/Rev.1).

54. The President ennounced that the Bureau wished to revise paragraph 2 of the dreft by inserting the words "the principles and objectives of" before the words "the medium-term plan of the United Nations Environment Programme" in the first line of the paragraph.

55. The draft decision, as orally revised, was adopted by consensus.

#### SS.I/1. Programme policy and implementation

The Governing Council,

**Recalling Qeneral** Aseembly resolution 2997 (XXVII) of 15 December 1972,

Recalling also the resolutions adopted by the Council at its session of a special character in 1982, 1/

Having considered Qeneral Assembly resolutions 42/184 of 11 December 1987, on international co-operation in the field of the environment, 42/185 of 11 December 1987, on the biennial cycle of sessions of the governing Council of the United Nations Environment Programme, 42/186 of 11 December 1987, on the Environmental Perspective to the Year 2000 and Beyond, 42/187 of 11 December 1987, on the report of the World Commission on Environment and Development, and 42/193 of 11 December 1987, on preparation of the new international development. strategy for the fourth United Nations development decade,

Having also considered the introductory report of the Executive Director, 2/ his introductory statement 3/ and the annual report of the Administrative Committee on Co-ordination, 4/

Bearing in mind its decision SS.I. 3 of 10 March 1980, on the system wide medium-term environment programme for the period 1990-1995,

1. Resolves to exercise fully the role expected of it:

(a) With respect to environmental activities within the the United Nations system, as set forth by the Qeneral Aceambly in resolution 2997 (XXVII) and by the governing Council in section VI, paragraph 3 of resolution I of 18 May 1982, adopted at its session of a special character)

(b) With respect to the follow-up of the Environmental Perspective to the Year 1000 and Beyond, approved by the General Assembly in its resolution 42/186;

c) With respect to the report of the World Commission on Environment and Development, we laomed by the General Assembly in its resolution 42/187;

(d) With respect to the system-wide medium-term environment programme for the period 1990-1995, in accordance with section I, paragraph 2 (b), of Qeneral Assembly resolution 2997 (XXVII);
